Failure to comply may be sanctioned or punished in accordance with applicable provisions of all these rules. Pro se parties shall be responsible for providing the clerk with the current address and telephone numbers, and shall also be responsible for providing copies of all papers filed to all other parties or attorneys. Such filed papers shall always contain the current address and phone number of the pro-se party. The Clerk of the court shall provide a pro se party a copy of this document at the time a petition or an answer is filed.
