GENERAL RULES

These General Rules will be enforced upon deliveries to the County of El Paso Jail Facilities, Adult Probation & Juvenile Probation that are within the Texas Food Establishment Rules Guidelines. The effective dates are July, 2006 through December 31, 2006.

1. All bidders must fill out pricing on the attached form (legibly) by 2:00 p.m., Tuesday, May 2, 2006. The County reserves the right to cancel a contract, failure to comply with these rules or specifications.
2. Deliveries must be made as early as possible on the date specified on the Purchase Order, and may not be altered without proper notification. Deliveries will be made between 5:00 a.m. – 11:00 a.m. (No Noon Deliveries) and 1:00 p.m. – 5:00 p.m. for both Jail Downtown and Annex Facilities.
3. The County of El Paso is not obligated to purchase estimated amounts, and can make changes at any time.
4. Refrigerated trucks are to be used for delivery in order to keep all fresh and frozen foods within their proper temperature. Beef and chicken patties will not be accepted iced down only.
5. For security purposes only the following items **will** be accepted for deliveries:
 - a. Cardboard boxes not wooden crates
 - b. Plastic ties not metal ties, straps, and glass
 - c. It is the vendor's responsibility to pick-up all wooden pallets left behind on delivery.
6. No damaged bags or cases will be accepted (i.e. flour, sugar, or salt).
7. No crushed eggs will be accepted; items must be properly sealed to assure freshness.
8. Disruption of the department's menu will not be tolerated; therefore vendor must give proper notice on any shortages of items to allow the department enough time to make other arrangements.
9. Pursuant to Texas Government Code Section 2252.002, a bidder who's principle place of business is outside the State of Texas may not be awarded any contract unless the nonresident bidder underbids the lowest bid submitted by a

responsible resident bidder by an amount that is not less than the amount by which a resident bidder would be required to underbid the nonresident bidder to obtain a comparable contract in the state in which the nonresident's principal place of business is located. Any bidder whose principal place of business is in the State of New Mexico must underbid Texas bidders by 5%. For information regarding other states, contact the El Paso County Purchasing Department. This preference for Texas resident bidders does not apply to any contract involving the expenditure of federal funds, including federal pass through funds.

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

Tex. Local Gov't Code § 176.001 (2005)

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality.
