The County of El Paso (EPC) is seeking competitive proposals for a scalable web content filter/traffic management system per the specification located in this RFP.

1.4 – Vendor Qualifications

EPC will evaluate proposals only from vendors that meet the following qualifications:

- The Vendor must sell a complete solution that will block and filter certain types of web traffic and must meet the requirements listed in the specifications
- Vendor must be able to support proposed solution 24/7/365
- Vendor must have a proven track record in the Web Filter/Traffic Management space
- Vendor must have been in operation more that (5) years.

1.5 – Non Responsive Proposals

Any proposal that does not directly address the needs of El Paso County as described in the RFP will be considered non-responsive and will not be considered. A proposal that

does not prove the vendor's ability to furnish a suitable solution, based on experience and references, as well as response to the design and planning requirements in the RFP, will not be considered.

1.6 – Contract / Agreement

The vendor is required to submit two originals of the vendor's proposed solution, design, terms and conditions for this project. These agreements must be included in the RFP response package. It is anticipated, and the County reserves the right to do so, that the final contract will be negotiated with the Vendor.

1.7 – Submittal Information

Vendors must submit one (1) original and eight (8) copies of their proposals; all materials submitted in response to this RFP would become the property of El Paso County. Vendors will be aware that El Paso County is a public entity and as such, must abide by the public record laws. Proposals will be kept confidential until the selection process has been completed. At that time, the contents of the proposals become public record and open to inspection by all parties.

The vendor is responsible for all costs incurred in preparing and submitting the vendor's response to the RFP. All costs incurred for the presentation and demonstration of the vendor's recommendation is the responsibility of the vendor.

1.8 – Cost / Price Certification

All costs and prices proposed in the response to this RFP must be valid for a minimum of 120 days. El Paso County is not responsible for any vendor errors, omissions or miscalculations

1.9 – Acceptance and Use of Proposal

El Paso County reserves the right to accept or reject any or all proposals. The County reserves the right to use any or all nonproprietary ideas, concepts, or configurations presented in vendors' responses.

1.10 – Response Format

Vendor responses to the RFP must follow the forms and format provided in the RFP. Additional information can certainly be provided but not in lieu of the prescribed format. It is intended that the technical and application data be presented separate from the cost data and that the cost data contain no technical data. 1.11 – Vendor Conference

Vendors are encouraged to attend but attendance is not mandatory. All questions and requests for clarifications that have been submitted in writing will be addressed at that conference. Additional questions and requests for clarification may be addressed at the vendor conference. The questions and answers will be forwarded to all vendors that have indicated their plan to respond to the RFP. The County is not responsible for any oral instructions given by any County employees, agents, board members or elected officials concerning this RFP. All questions, responses and changes will be handled through the El Paso County Purchasing Department.

1.12 – Vendor References

Proposals must include references of other counties, cities and entities that have used the services provided by the vendor.

- The references are mandatory.

Section 2 - Specifications for Services

2.1 – Description of Requested Solution:

EPC requests proposals to provide a solution for a scalable Web Content Filter/Traffic Management system, preferably appliance-based, that can be integrated with the county's current data network infrastructure.

- a. The solution must be able to support a minimum of 2,100 +/- separate IP addresses accessing the Internet daily.
- b. It must provide the capability to transparently monitor, manage and report on traffic from the county's internal networks to the Internet.
- c. Using pass-through technology, it may be an inline, standalone appliance or tightly integrated with the Cisco Secure PIX Firewall or Ironport C series Email security appliance.
- d. Vendors are encouraged to provide a range of optional features; however, URL blocking, HTTP and SSL blocking, web proxy blocking, streaming video and Internet radio and peer-to-peer blocking are requirements for all proposed solutions.
- e. A solution compatible and interoperable with Cisco PIX and any and all Cisco switch products.
- f. The successful vendor will be responsible for providing instructions and assistance to the EPC Server/Network staff and provide adequate knowledge transfer and training.

2.2 - Current EPC Operational Environment

The EPC network uses 20 MB of Internet bandwidth and has developed a network architecture that depends on the use of the Cisco PIX firewall and a Cisco network infrastructure.

EPC has deployed over 2100 personal computers (PC) and laptop computers at several locations within the county that require filtered Internet access. Any solution proposed under this bid must be transparent to these computers. No configuration changes or software installations to the computers is allowed. Login Scripts will be allowed. This includes having to configure each to access a proxy. Every PC is networked with Internet Explorer browser already in place.

2.3 - Technical Specifications

Specifications are intended to define the level of quality and performance of the requested equipment/service. All variations from the specified items shall be fully explained and included with the bid.

- a. The installation of this Web filtering Traffic Monitoring software must reside at the central site where the core Internet appliances reside with no other configurations required at any of the remote locations
- b. The Solution require should be a appliance for URL filtering with the option of a second unit for redundancy and fault tolerance
- c. Appliance should support at least two Gigabit Ethernet Cards
- d. Appliance should be rack mounted
- e. Appliance should have redundant power supply
- f. Web base administration via HTTP or HTTPS
- g. The solution should scan outbound traffic and have the capability to scan inbound traffic
- h. Appliance should support L4 traffic monitoring / Network Layer Malware Detection
- i. Appliance should have an built-in URL filtering Functionality with Categories
- j. Appliance should support pre-defined categories and custom categories
- k. Appliance should have the capability to catch malware that attempts to bypass port 80
- l. Appliance should be able to process more that 1200 HTTP requests per second.
- m. Appliance should be able to handle 2100 simultaneous TCP connections and should be able to handle burst traffic
- n. Appliance should provide easy auto-updating of any system patches and URL categories
- o. Appliance should integrate with Windows Active Directory
- p. Appliance should have methods to create white lists or blacklists and unrestricted groups with full access to internet or restricted groups based on Active Directory Membership
- q. Filter must provide dynamic reporting by category, workstation, username, group membership or other criteria
- r. Filter must provide general reports such as past activity and top users
- s. Filter must provide reports on overall bandwidth consumed vs. bandwidth saved or other like reports
- t. Appliance must provide secure shell SSH login for maintenance
- u. Warranty must cover at least (3) three years of hardware and software upgrades, maintenance and support from date of installation

2.4 – Training and Operations

Maintenance and Support: The solution proposed shall include a comprehensive description of tools and processes available with the solution to diagnose and resolve issues, backup and recover lost archived objects and management console requirements. The solution’s automatic notification capabilities as well as its self-diagnostic and error reporting capabilities should be outlined.

Administration Training and Knowledge Transfer: The vendor shall train EPC support personnel in the use of their product.

Section 3 – Costs

3.1 – Total Costs

The vendor must provide total and detailed costs of the proposed project. All software, documentation, equipment, network, travel, training, labor, installation, conversion, maintenance and shipping must be priced separately. These costs will be summarized and presented on one page.

Instructions for the certifications:

General Requirements

The County of El Paso, Texas is required to obtain from all applicants of federal funds or pass-through certifications regarding federal debt status, debarment and suspension, and a drug free workplace. Institutional applicants are required to certify that they will comply with the nondiscrimination statutes and implementing regulations.

Applicants should refer to the regulations cited below to determine the certifications to which they are required to attest. (c) The undersigned shall require that the language of this certification be included in the award document for all sub-awards at all tiers (including sub-grants, contracts under grants and cooperative agreements, and subcontracts) and that all sub-recipients shall certify and disclose accordingly.

1. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

As required by Executive Order 12549, Debarment and Suspension and implemented at 21 CFR Part 1404, for prospective participants in primary covered transactions

A. The applicant certifies that it and its principals:

(a) Are not presently debarred, suspended, proposed for debarment, declared ineligible, sentenced to a denial of Federal benefits by a State or Federal court, or voluntarily excluded from covered transactions by any Federal department or agency;

(b) Have not within a three-year period preceding this application been convicted of or and a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain or performing a public (Federal, State, or local) transaction or contract under a public transaction violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

(c) Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State, or local) terminated for cause or default; and

B. Where the applicant is unable to certify to any of the statements in this certification, he or she shall attach an explanation to the application.

2. DRUG-FREE WORKPLACE

As required by the Drug Free Workplace Act of 1988, and implemented at 21 CFR Part 1404 Subpart F.

A. The applicant certifies that it will or will continue to provide a drug free workplace by:

(a). Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the applicant's workplace and specifying the actions that will be taken against employees for violations of such prohibition;

(f) Taking one of the following actions within 30 calendar days of receiving notice under subparagraph (d)(2), with respect to any employee who is so convicted:

- (1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or
- (2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal State, or local health, law enforcement, or other appropriate agency

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

3. CERTIFICATION REGARDING FEDERAL DEBT STATUS (OMB Circular A-129)

The Applicant certifies to the best of its knowledge and belief, that it is not delinquent in the repayment of any federal debt.

for the normal operation or achievement of any statutory objective of the project or activity shall not violate this statute.

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

Tex. Local Gov't Code § 176.001 (2005)

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
