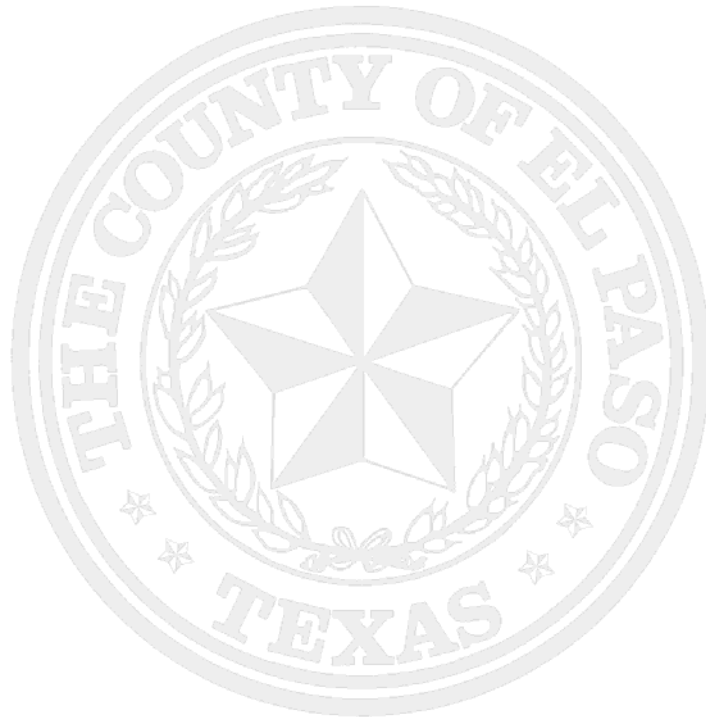

Request for Qualifications

Architectural Services to design plans to remodel the Ascarate Park Pavilion and design a replacement facility for the AGCA Building at the Ascarate Golf Course. The County of El Paso is seeking Qualifications for architectural services from a firm licensed to practice engineering work in the State of Texas. The County defines the desired services in following scope of work.

I. Scope of Work:

The contract will encompass preliminary and final design plans and specifications for a new air distribution system, including dampers and grills, for the Ascarate Golf Course Clubhouse. The air distribution or duct system conveys air from central heaters and air conditioners throughout the Clubhouse. The Clubhouse includes the restaurant dining area, the restaurant kitchen, the Clubhouse restrooms, the Pro Shop and the locker rooms, both men's and women's facilities.

- The air distribution system replaces an existing outdated system.
- The new air distribution system should achieve good air distribution responsive to the needs of the various areas of the Clubhouse.
- The system should minimize convective and conductive losses and minimize pressure drops.
- It should include a design for insulated ducts that meet International Energy Conservation code.
- The duct design must have proper seals with mastic and/or Underwriters Laboratory (UL) 181 approved tape at joints and seams.
- The air distribution system should consider the use of the occupied space and our specific weather conditions.
- The air distribution system design should consider poor existing building features such as insulation and inefficient fenestration through multiple windows.
- The air conditioner units are new rooftop Carrier refrigeration units; one 4 ton unit over the kitchen and two 5 ton units over the dining room and one 4 ton over the Pro Shop
- The heating units are existing units.
- The current project consists of the preparation of plans and specifications for a new air distribution system.
- The design should meet the County's interest in maximizing heating and cooling efficiencies. The services include performing ACCA Manual J and Manual D calculation to ensure the ducts accommodate the air flow requirements of the heating and cooling system for efficient distribution of heated or cooled air.

Other specific tasks include:

- Preparation of construction bid packages for contractor installation.
- Analysis of bids and recommendation as to acceptance/rejection of bids.
- Periodic on-site field-inspections required by the project to monitor compliance with plans and specifications.
- Periodically review contractor's performance and timely work progress.
- Verify contractor billing using Application and Certification for Payment Form (AIA Document G702) and as-built information.
- Recommend acceptance/rejection of the completed project.
- Preparation of final as built construction plans.

II. **Statement of Qualifications:**

The County of El Paso seeks to contract with an engineering firm, registered to practice in the State of Texas, which has experience in the following areas:

- Designing heating and cooling air distribution systems for public occupancy buildings
- Has experience with energy efficiency projects
- Has the capacity to develop plans and specifications for a retrofit project

Provide within the proposal a list of past clients, local governments, as well as resumes of all engineers assigned to this project.

Please limit Statement of Qualifications to ten (10) pages with any attachments.

III. Qualification Submission:

Please submit qualifications in a sealed envelope(s) on or before the deadline. **One original signature copy and six (6) duplicate copies** of the qualifications must be submitted to the County of El Paso Purchasing Agent office, 800 E. Overland 300, El Paso, Texas 79901 or mailed to its registered address above and received by the deadline.

Responsive submittals must, at a minimum, contain the following:

- Technical: Detail the proposed approach to address the scope of work. Review the specific tasks to be undertaken and identify any potential problems with proposed solutions to those problems.
- Design Team and Staff: As appropriate, list the senior designers and staff assigned to the project and the percentage of time each will devote to the project. Percentage should equal 100%. As an Appendix to the submittal, provide resumes or vita of all personnel assigned to the project.
- Prior Related Experience: Provide a listing of all similar work performed by the team proposed for this project within the past **three** years. In addition, provide contact information for at least three references for projects included in this listing.
- Qualifications: Provide evidence of the following: registration of the Engineer/firm with the State of Texas; current professional liability insurance; statement evidencing the Engineer/firm is eligible to work on projects funded by the State of Texas.

The County may invite Individuals or firms to make presentations in person to a Review Committee appointed by Commissioners Court at a time and place designated by the Committee. Individuals or firms responding to this proposal may not communicate with persons assigned to the Review Committee other than as requested by the committee as a whole.

IV. Project Schedule:

The County of El Paso requires that the responder selected for this project adhere to the following schedule:

- A maximum of 30 calendar days for preparation of preliminary plans and draft specifications from receipt of Notice to Proceed by the County of El Paso

- Upon return of preliminary plans and draft specifications by the County of El Paso, a maximum of 60 calendar days for completion of final plans and specifications, and bid documents for this project.

Commissioners Court will select an engineering firm and authorize the County Purchasing Agent to negotiate a fee for the project. The County of El Paso reserves the right to require the individual or firm providing engineering services to redesign the project for re-bidding, at no additional compensation, to stay within the project budget. Should the individual or firm fail to adhere to the design schedule delineated above, the County reserves the right to find the individual or firm to be in breach of contract. The County determines the total amount of funds for the project, including engineering, administrative, and construction services.

Instructions for the certifications:

General Requirements

The County of El Paso, Texas is required to obtain from all applicants of federal funds or pass-through certifications regarding federal debt status, debarment and suspension, and a drug free workplace. 1. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

As required by Executive Order 12549, Debarment and Suspension and implemented at 21 CFR Part 1404, for prospective participants in primary covered transactions

A. The applicant certifies that it and its principals:

(a) Are not presently debarred, suspended, proposed for debarment, declared ineligible, sentenced to a denial of Federal benefits by a State or Federal court, or voluntarily excluded from covered transactions by any Federal department or agency;

- (1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or
- (2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal State, or local health, law enforcement, or other appropriate agency

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

The Applicant certifies to the best of its knowledge and belief, that it is not delinquent in the repayment of any federal debt.

Tex. Local Gov't Code § 176.006 (2005)

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

Tex. Local Gov't Code § 176.001 (2005)

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
