1. 24.- Cleaner Bippy, we need more detail for product and where it will be used?  
Bippy is basically Ajax. It comes 48 cans to a case. Each can is 16 oz – it is used to clean toilets, sinks, and dayroom tables  
Bippy # 485-29-10410-0
2. 26.- Cleaner Foam Aerosol 190z., we need more detail for product and where it will be used?  
Used in the Jail Facility and requested per demand.
3. 30.- Cleaner Non-Acid, where will it be used and what packaging would be preferred, qts, gal, etc.?  
Used in the Jail Facility and requested per demand.
4. 32.- Cleaner Toilet Bowl neutral (orange), is there a desired brand? What packaging would be preferred, qts, ga, etc.?  
Stearns Product Item # ST791 2 buckets of 90 - .5 ounce powder drop in bucket system per case (2x90x.5)
5. 52.- Gloves (plastic), what sizes?

8. 79.- Plates-3 Compartment, Styrofoam with lid, can you provide more detail for this product?  
**They need to be hinged and size is 9" x 9" x 3" D and about 1/8" thickness.**
9. 80.- Platters-Oval, 11", 500/CS, can you provide more detail and color for product and where it will be used?  
**Used in the Jail Facility and requested per demand.**
10. 98.- Super Shine-All, can you provide more detail for product and where it will be used?  
**Hillyard Super Shine All # 140G – to clean the blue vinyl floor we have at the Downtown Detention Facility.**
11. Is the product specified to be delivered Countywide or to a centralized location such as a County Warehouse for stock?  
**Countywide**
