Since the site for this project is within an active federal LPOE construction site, and south of the existing "Border Fence", site visits will only be available with prior notification and on specified dates, as indicated below:

- **Dates for site visits are:** Wednesday, November 9th, Thursday November 10th and Monday November 14th.
- **Times for site visits are:** All dates indicated above, 2:00 P.M. to 3:00 P.M. for project site within federal LPOE construction site, and 3:00 P.M. to 4:00 P.M. for project site between border fence and Rio Grande River.
- **Mandatory Pre-Notification for site visits:** Prior to attending a site visit on any of the above noted dates, mandatory pre-notification for attendance is required. Site visit date, Company Name and number of site visit attendees will be requested from prospective attendees.

- **Location for Commencement of Site Visits:** Persons attending site visits shall assemble prior to 2:00 P.M. at the field office trailer of Coast & Harbor Associates (U.S. Government representative). This trailer is physically located within the field office compound of the federal general contractor Turner Construction, near the northeast side of the intersection of former FM1109 and Island Guadalupe Road. Due to safety and other requirements, all site visit attendees will be escorted within the federal LPOE construction site, and as such late arrivals may not be allowed to participate.
- **Mandatory Personal Protective Equipment:** Each person attending the site visits will be required to provide their own personal protective equipment, which includes hard hat, safety vest, safety glasses and appropriate work boots/shoes. Attendees without proper personal protective equipment may not be allowed to participate.

All site visit attendees are hereby notified that all questions regarding the bids or site conditions for this project shall be submitted to the El Paso County Purchasing Department, as indicated in the Notice to Bidders. Representatives from Turner Construction (and their subcontractors), U.S. General Services Administration and their consultant Coast & Harbor Associates, and the U.S. Border Patrol cannot provide any official information or details regarding this project.
