

INVITATION FOR BIDS {PRIVATE}

The County of El Paso will receive Bids for Ascarate Park Entrance Renovations, Bid #11-049, until 2:00 P.M., on Wednesday, December 07, 2011, at the County Purchasing Department, 800 E. Overland Ave., Suite 300, El Paso, Texas 79901 at which time and place all bids will be publicly opened and read aloud.

Bids are invited upon the several items and quantities of work as follows:

NOTE: The items and quantities shown in the unit price schedule are ESTIMATES ONLY. They are shown here only for the purpose of comparing bids as an expected total expenditure. The County, at its sole discretion, will direct exactly how many actual units will be placed, and will pay for only those units that are ordered and accepted. No payments will be made regarding the estimated quantities, they are estimates only.

Estimates are minimums, but not guaranteed minimums, and the contract cost can increase so long as the unit costs remain the same and the increased funds are appropriated in the budget.

Line item entries shall prevail over sum total entries. When discrepancies exist between unit prices and corresponding extended prices, unit prices shall prevail.

Any additional information required by interested vendors must be submitted in writing to the attention of the County Purchasing Agent before Tuesday, November 29, 2011, at 12:00 p.m.

Copies of the Contract Documents may be obtained for a non-refundable sum of \$50.00 per each set of the documents at the office of the County Purchasing Agent, 800 E. Overland, Rm 300, El Paso, TX, 79901, telephone number (915) 546-2048. Payment for the Contract Documents may be by check or money order payable to the order of El Paso County.

A certified cashiers check, payable to the order of El Paso County or a satisfactory Bid Bond in the amount equal to five percent (5%) of the total contract price, executed with a surety company authorized to do business in the State of Texas and must be included in the bid package.

The Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

The County of El Paso reserves the right to reject any or all Bids or to waive any technicalities in the bidding.

Bids may be held by the County of El Paso for a period not to exceed ninety (90) days, or such longer time as may be required by the funding agencies, from the date of the bid opening for the purpose of reviewing the Bids and investigating the qualifications of Bidders, prior to awarding of the Contract.

BASE BID – Renovations to the existing entrance landscape at Ascarate Park from Delta Dr. to the toll booth facility, addition of a new roundabout and renovations to the Golf Course entrance fence and the County Parks office entrance landscape.

The entrance renovations include planting, irrigation, new light standards, new signs, new fence, a prefabricated toll booth and a new roundabout which includes asphalt, concrete, and landscape. Demolition will include concrete, asphalt, signs and electrical poles to accommodate the new additions. The golf course entrance fence includes demolition of the existing wrought iron and repointing of the existing rockwall and addition of a new decorative wrought iron and gate. The park offices entrance landscape renovations will include new concrete, landscape and irrigation.

Having examined the plans and specifications with related documents and the site of the proposed work, and being familiar with all of the conditions surrounding the construction of the proposed project including the availability of materials and labor Bidder hereby proposes to furnish all labor, materials, and supplies: and to construct the project in accordance with the Contract Documents within the time set forth herein, and at the prices stated below. These prices are to cover all expenses incurred in performing the work required under the Contract Documents, of which this proposal is a part.

Bidder hereby agrees to commence work under this contract on or before a date to be specified in a written "Notice to Proceed" by the Owner, **substantial completion of the project within 160 consecutive calendar days thereafter, and final completion of the project within 180 consecutive calendar days as stipulated in the specifications.**

Bidder further agrees to pay as liquidated damages, the sum of \$250.00 for each consecutive calendar day thereafter as hereinafter provided in the GENERAL CONDITIONS.
