Award will be made based on a review of qualifications, scope of services and price. **COMMISSIONER’S COURT RESERVES THE RIGHT TO REJECT ANY AND ALL PROPOSALS AND WAIVE TECHNICALITIES.** Only proposals that conform to specifications will be considered. Successful Proposer shall not order items or services until a Purchasing Order is received from the County Purchasing Office. Payment will not be made on items delivered without an Agreement.

If the proposal totals more than \$100,000.00, the bidder shall furnish a certified cashiers check made payable to the County of El Paso or a good and sufficient bid bond in the amount of 5% of the total contract price, executed with a surety company authorized to do business in the State of Texas. The certified cashiers check must be included with the proposal at the time of the opening.

In order to remain active on the El Paso County Vendor list, each Vendor receiving this proposal must respond in some form. Vendors submitting a proposal must meet or exceed all specifications herein. Vendors submitting a no proposal must submit their reason in writing to the El Paso County Purchasing Department.

IMPORTANT NOTICE FOR VENDORS

EL PASO COUNTY CODE OF ETHICS TRAINING REQUIREMENT FOR VENDORS

Vendors. Any vendor involved in a single procurement exceeding \$50,000 must complete training on the El Paso County Code of Ethics. **This training must be completed prior to submitting a bid or proposal, responding to a request for qualifications or proposals, or otherwise contracting with the county.** The training must be completed by an officer, principal, or other person with the authority to bind the vendor. The certification of completed training on the Ethics Code issued by the County Human Resources Department is valid for one (1) calendar year from the date of completion. A list of those Vendors with a current certification of completion and the corresponding date of expiration shall be maintained on the El Paso County website under the Purchasing Department's Current List of Training Certified Bidders. This training requirement does not apply to emergency purchases.

Training

In compliance with Section 161 of the Texas Local Government Code, training on the El Paso County Code of Ethics will be accessible in an online format to Vendors and Lobbyists on an ongoing basis, subject only to limitations due to technical resources. No person or entity required to complete training will have to do so more than once per year.

The contractor shall submit a proposal for the annual inspection of the Notifier Fire Alarm System for the Detention Facility.

The proposal shall include the following:

- Performance of operations necessary to conduct the inspection
- All charges for parts and equipment listed within these specifications
- All freight, shipping and handling charges for required test equipment
- All labor charges, including compensation for required overtime
- Travel expense, lodging and meals
- Charges for rental equipment and cars

1. Background Information

The El Paso County Detention Facility is located at 601 East Overland Street, in El Paso, Texas, 79901. The Notifier Fire Alarm System networks 3 Notifier NFS 3030, 5 Notifier INA, 12 LCD-80, 1 local area server, 1 workstation, and monitors and printers. Since the installation of the system in 1995 and a system upgrade in 2006, the system has always been serviced by authorized service provider companies. All inspections and required tests of the system are current. The inspection reports may be reviewed at the office of the maintenance section supervisor.

2. Description of the Notifier System

The listed devices are connected and monitored by the fire alarm network:

- Smoke Detectors 1,400
- Heat Detectors 144
- Duct Detectors 45
- Water Flow switches 22
- Supervisory switches 30
- Horns and Strobes 13
- Ansul Fire Suppression Monitors 3

3. Walkthrough, Optional

The contractor may contact the Maintenance Foreman, at (915) 546-2238, for an appointment to evaluate the project.

The contractor shall provide a minimum of 24 hours notice. The walk-through shall be scheduled during normal business hours; Monday through Friday, 07:00 to 15:00 hours. Access to the facility will not be provided without an appointment. The contractor may not ask questions at the time of the walk-through; all questions must be submitted to the County Purchasing Department before the deadline.

4. Minimum Service Requirements

- 4.1** The contractor shall conduct a thorough inspection of the entire fire alarm system. Every device shall be tested; all horn/strobes, pull stations, smoke detectors, duct detectors, flow switches, tamper switches, hood fire suppression systems monitoring devices, door release units, elevator shunt trip and elevator recall circuits and air handler shut down circuits.
- 4.2** The fire alarm system shall be tagged in accordance with the inspection results.

5. General Requirements

5.1 Regulations

All work shall conform to all applicable, building, mechanical, plumbing, fire and electrical codes and regulations.

5.2 Service Provider

The contractor company shall be a NOTIFIER Factory Authorized Service provider company. The provider shall comply with NOTIFIER issued guidelines for inspection, training and repair procedures.

5.3 Inspectors / Engineers

The technicians conducting the inspection must be well experienced with NOTIFIER fire alarm systems. If requested by the County representative, the contractor shall submit written training and work experience documentation for the technician(s) conducting the service work.

5.4 Test Equipment

Only suitable test equipment may be used.

5.5 Manuals

The contractor shall utilize maintenance, maintenance supplement, installation and operation manuals and other equipment related publications, issued by the equipment manufacturer that may be required to conduct the work.

5.6 Reports

Provide written inspection reports.

Provide written recommendations listing required upgrades.

Provide a list of all deficiencies found during the inspection.

Provide a list of all required repairs and submit repair estimates.

5.7 Schedules

The contractor shall submit an accurate time schedule for the inspection; including the following information:

-Date of inspections

-Time required for the completion of the required inspections

5.8 Facility Operation

a. Interruptions of the operation of the Detention Facility shall be held to an absolute minimum.

b. Possible interruptions to the following listed functions must be held to a minimum: Feeding of inmates, movement of officers and inmates, booking and releasing of inmates, use of computer and fiber optic equipment.

c. The contractor shall provide 24 hours written notice for the testing and of elevator recall and shunt-trip circuits.

5.9 Code Requirements

All work shall conform to all applicable, building, mechanical, plumbing, fire and electrical codes and regulations.

Obtain all necessary permits and licenses.

5.10 Background Investigation

The contractor shall submit a list of employees, who will execute the work inside the Detention Facility, for a background investigation, with the following information to the El Paso County Sheriff's Department Identification and Records Section.

Name of employee: first, middle and last name

Employee's home address

Employee's date of birth

Employee's drivers license number

The Sheriff may deny access to security areas to any employee who failed the background investigation.

5.11 Tools and Test Equipment

All tools brought into the Detention Facility must be checked in and out.

Therefore, employees of the contractor must supply a complete inventory list of their tools, power tools, and test equipment.

5.12 Searches

All persons and their belongings may be subjected to inspections and/or searches.

5.13 Parking

All contractor vehicles, required to conduct the work inside the Detention Facility, shall be parked off site at the contractor's expense.

5.14 Cleaning

Keep work areas clean. Remove and properly dispose of all packing material and debris at the end of each workday.

5.15 Tobacco Products

The El Paso County Detention Facility is a smoke free facility. Contractor employees shall not enter the facility carrying tobacco products.

6. Contract Requirements

6.1 Contract Period

a. The contractor shall submit a proposal for a maintenance and inspection service.

b. The work shall be conducted as follows:

- **March and September of 2012 (For 2 semi-annual inspections)**

6.2 Working Hours

The work required may be conducted within the following time periods:

- Monday through Friday, during and after regular business hours

- Some nighttime work may be required to conduct the inspection

6.3 Compensation and Invoices

- a. Unless otherwise agreed upon in writing by the parties, the County's maximum liability for all services performed during the term of this Agreement shall not exceed the amount awarded with the purchase order.
- b. The Contractor shall be compensated for actual services provided.
- c. The compensation paid to the Contractor under this Agreement includes all fees and expenses incurred while performing services under this Agreement.
- d. The Contractor shall submit **one invoice** for services rendered. (Annual inspection)
- e. The Contractor shall submit **two invoices** for services rendered. (Semi-annual inspections)
- f. The County shall pay the Contractor within 30 days following receipt of each invoice.

6.4 Independent Contractor

The Contractor is an independent contractor, and neither the Contractor nor Contractor's staff is, or shall be deemed, county employees.

6.5 Termination of Agreement

If at any time after commencement of the services required by this Agreement, the County shall, in its sole reasonable judgment, determine that such services are inadequate, unsatisfactory, no longer needed or substantially not conforming to the descriptions, warranties or representations contained in this Agreement, the County may terminate this Agreement upon 30 days written notice to Contractor.

6.6 Indemnification

The Contractor agrees to indemnify and hold the County, its officers, agents, and employees harmless against, any claims, demands, damages, costs, and expenses (including reasonable attorney's fees for defending the claims and demands) for injury or damage to the person or property of any other party arising out of any act or failure to act by the Contractor, its officers, agents, contractors, or employees, or the condition of any equipment owned by the Contractor.

6.7 General Provisions

- a. Sole agreement: This is the entire Agreement between the Contractor and the County. No contract or proposal submitted by the contractor shall supersede the requirements outlined in these specifications.
- b. Severability: If any part of this Agreement is held unenforceable, the rest of the Agreement will continue in full force and effect.

- c. Applicable law: The laws of the State of Texas shall govern this Agreement, and venue shall be El Paso County.
- d. Notices: All notices and other communications given in connection with this Agreement shall be in writing and shall be deemed given as follows:

Notices shall be deemed given when delivered personally to the recipient's address, or three days after being deposited in the United States mails, postage prepaid to the recipient's address.

- e. No partnership: This Agreement does not create a partnership relationship; the Contractor does not have authority to enter into contracts on behalf of the County.
- f. Assignment: The Contractor Company may not assign its rights or obligations under this Agreement without the County's prior written consent. The County may freely assign its rights and obligations under this Agreement.
- g. Amendment: This agreement may not be amended or modified, except by a writing executed by both parties hereto.

6.8 General Liability Insurance

The contractor shall provide and maintain General Liability Insurance coverage during the contract time period.

6.10 Automobile Liability Insurance

Instructions for the certifications:

General Requirements

The County of El Paso, Texas is required to obtain from all applicants of federal funds or pass-through certifications regarding federal debt status, debarment and suspension, and a drug free workplace. Institutional applicants are required to certify that they will comply with the nondiscrimination statutes and implementing regulations.

Applicants should refer to the regulations cited below to determine the certifications to which they are required to attest. (c) The undersigned shall require that the language of this certification be included in the award document for all sub-awards at all tiers (including sub-grants, contracts under grants and cooperative agreements, and subcontracts) and that all sub-recipients shall certify and disclose accordingly.

1. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

As required by Executive Order 12549, Debarment and Suspension and implemented at 21 CFR Part 1404, for prospective participants in primary covered transactions

A. The applicant certifies that it and its principals:

(a) Are not presently debarred, suspended, proposed for debarment, declared ineligible, sentenced to a denial of Federal benefits by a State or Federal court, or voluntarily excluded from covered transactions by any Federal department or agency;

(b) Have not within a three-year period preceding this application been convicted of or and a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain or performing a public (Federal, State, or local) transaction or contract under a public transaction violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

2. DRUG-FREE WORKPLACE

As required by the Drug Free Workplace Act of 1988, and implemented at 21 CFR Part 1404 Subpart F.

A. The applicant certifies that it will or will continue to provide a drug free workplace by:

(2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal State, or local health, law enforcement, or other appropriate agency

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

Tex. Local Gov't Code § 176.001 (2005)

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
