2. Cisco3845-MB has a qty. of two (2) on the new list. However, our previous coverage has been for only one (1), and it's for S/N FTX1240A5MX. ASA550 on list indicates a qty. three (3), however, previous coverage has only been for two (2), which are S/N's JMX1312L0Q7 & JMX1319L0TJ. Please clarify.

Response: Bid for One (1) Cisco3845-MB. Please use revised Bid Spec 13-007.

3. WS-C3560G-24PS-S. The new list indicates a qty. of 40, however, I show a qty. of 36. WS-C3560-48PS on the list has a qty. 2, and WSC3560G-48-PS has a qty. 18. However, I show a qty. 8 of WS-C3560G-48PS-S, and a qty. 12 of WS-C3560G-48TS, which is not listed on the new list. Lastly the new list indicates a qty, 7 of AIR-BR1410A-A-K9, however, I show a qty. 9 that received coverage.
