- The following is an approved alternate to the TXDOT emulsified asphalt HFRS-2P:

The County will accept the AASHTO M316-16 HFMS-2P as an approved equal product for the bid as base bid item #2 cost/gallon for the same volume of emulsion.

1. Is bid 17-043 going to be opened on Sept 21st or 28th?

**Response:** Bid opening date is **September 28, 2017 at 2:00 p.m.** and deadline for questions is **September 21, 2017 at 12:00 noon.**

2. What is the brand and company of asphalt emulsion the County is using right now?

**Response: The current provider is Holly Frontier Refining & Marketing, LLC.**

3. Is it an anionic or cationic emulsion?

**Response: The emulsified asphalt is referenced on TXDOT Manual table 9 and is anionic.**

4. In what type of containers will the emulsion be delivered?

**Response: Emulsion shall be delivered to the construction site via acceptable DPS approved tankers, at which time the contents will be transferred into the County's emulsion tanker (8,000 gallon) and to be used by the distributor. Vendor must have the capability of delivering multiple tankers per day within a few hours of delivery.**

5. Is there any advantage for local vendors in regards to price percentage?

**Response: No advantage is acknowledge in the bid package.**
