# The Purchasing Department has received the following questions:

1. Can the County provide the specifications for the "Recycled Concrete Base Course Material" as specified in the bid?

# **RESPONSE:** Recycled concrete base course material shall comply with TXDOT 247 Type D material with a gradation to comply with Base course specification (grade 3).

2. Will El Paso County Purchasing revise bid form to include a line item for each group (Location) Recycled Base Course Material (complete): , Delivery Charge Base Course (To Each Location): , Delivery Charge Recycled Concrete Base (To Each Location) in each group location in lieu of the category Recycled Concrete Base Course Material line item 1 the bottom of the form? This will give the vendor an opportunity to bid the Recycled Concrete Base Course item based on availability for that particular group area for this type of material and if this line item is not available in this group area vendor may apply N/A.

# **RESPONSE:** Refer to new price sheet.

3. Alternate Recycled Concrete Base Course Material is indicating material shall comply with the gradation and physical properties as stated above. The Liquid limit is asking for 40% Max and 24% Min. Plasticity Index is 12% Max and 7% Min. Recycled Concrete Base is non-plastic which is allowed per TXDOT and other governmental entities. Will El Paso County Purchasing allow this requirement of non-plasticity?

# **RESPONSE:** Yes. This is acceptable in accordance to TXDOT specifications.

- 4. Solicitation Check List page 36 is asking for: Did you provide the bid bond documents. The only item that I found regarding this is page 16 is Construction projects additional requirements
  - Builders Risk Policy for total amount of completed project
  - Bid Bond
  - Performance & Payment bond
  - Since this is a supply material bid will a bid bond be required if yes please provide the requirements for this?

#### **RESPONSE:** No. A bid bond is not required for supplied materials.

5. Will you please provide a physical address for each location?

#### **RESPONSE:**

- Montana Warehouse will accept deliveries at 14698 Van Lane and material yard located at the intersection of Bradley road and Desert Willow Drive.
- Fabens Warehouse will accept deliveries at Fabens transfer station at end of Citizen transfer road in Fabens.
- Horizon Warehouse will accept deliveries at 15311 El Rosio.
- Canutillo Warehouse will accept deliveries at Canutillo transfer station on gateway north between Westway and Transmountain. (An acceptable alternative site within vicinity maybe provided after bid has been approved)
- 6. Request for El Paso County Purchasing provide physical address for each delivery point where materials are to be delivered.

#### **RESPONSE:** See response to item 5.

7. Will El Paso County Purchasing provide a line item for Vendor to specify plant location for regular base course and recycled base course so purchasing can make an evaluation on best value for El Paso County?
