Attempts to circumvent this requirement may result in rejection of the proposal as non-compliant.

Any changes in the specifications will be posted on the County website as an addendum. It shall be the proposer's responsibility to check the website prior to the bid opening date to verify whether any addendums have been posted. Website: <u>www.epcounty.com</u> ; click button labeled "**Directory**", search for and select "**Purchasing**", click on button labeled "**List of Bids**".

Award will be made based on a review of qualifications, scope of services and price. **COMMISSIONER'S COURT RESERVES THE RIGHT TO REJECT ANY AND ALL PROPOSALS AND WAIVE TECHNICALITIES.** Only proposals that conform to specifications will be considered. Successful Proposer shall not order items or services until a Purchasing Order is received from the County Purchasing Office. Payment will not be made on items delivered without an Agreement. Payment shall be made through County funds after completion of goods or services. Purchase Orders will be issued as required. Successful proposer must comply with all bonding requirements as stated in the Texas Local Government Code §262.032.

In order to remain active on the El Paso County Vendor list, each Vendor receiving this proposal must respond in some form. Vendors submitting a proposal must meet or exceed all specifications herein.

## El Paso County Code of Ethics Training Affidavit

(This form must be signed by an officer, principal, or individual authorized to bind the company under a contract with the County.)

IN COMPLIANCE WITH CHAPTER 161 OF THE TEXAS LOCAL GOVERNMENT CODE, ANY VENDOR INVOLVED IN A SINGLE PROCUREMENT EXCEEDING \$50,000 MUST COMPLETE THE ENCLOSED ETHICS TRAINING BEFORE SUBMITTING A BID OR PROPOSAL WITH THE COUNTY OF EL PASO.

Purpose: The stability of democracy depends upon the continuing consent of the governed, which in turn depends upon the trust the electorate holds for its government. The Ethics Commission of the County of El Paso, Texas, in concert with elected county officials, as well as leaders of the various county departments, recognizes the need to maintain the public trust and confidence in the workings of county government and thus adopts this Code of Ethics.

#### What is a vendor:

Any person or their representative or employee whose goods and services are purchased under the terms of a purchase order or contractual agreement with the county; and any other persons doing business with the County.

Procurement: In advising upon, discussing, recommending, and/or granting any County purchases, bids or contracts, County public servants shall inform themselves about their financial interests, and shall make a reasonable effort to inform themselves about the financial interest of their family members.

County public servants shall excuse themselves from exercising influence, participating in, discussing, recommending, and/or granting of any County purchases, bids, or contracts if they or a family member have a substantial financial interest.

Private Communication: No member of the El Paso County Commissioners Court, County Elected Officials/Department Heads or the El Paso County Hospital District Board of Managers shall permit any vendor, its lobbyists, representative, or employee to communicate with him privately regarding any procurement of items by the County or the Hospital District from the date that the bid, RFP, or RFQ is authorized or released, whichever is first. No private communication regarding the purchase shall be permitted by a member of the Commissioners Court, a county elected official/department head, or

the hospital district board of managers until the procurement process is complete and a purchase order is granted or a contract is entered into.

Members of the Commissioners Court, county elected officials/department heads and the board of managers shall make a reasonable effort to inform themselves regarding procurements and shall have a duty to inquire of vendors, their lobbyists, representatives, or employees, the nature of the private communication being sought prior to engaging in any communication.

This prohibition against private communication with vendors, their lobbyists, representatives, or employees shall apply to commissioners court approval of hospital district purchases.

# Indigent Burial Services for the County of El Paso

**RFP 19-025** 



Opening Date Thursday, July 11, 2019

#### BACKGROUND

The County of El Paso is responsible for the disposition of human remains for individuals identified as indigent whose death occurs in El Paso County. The Community Services Department screens requests for this County service. Department staff validates a decedent's indigent status and/or that of a legal next of kin and authorizes the disposition of remains.

Cremation is the County's disposition method for adult non-veteran human remains and infants whose parent has authorized cremation. Unidentified paupers, and unidentified human remains are to be interred and do not qualify for cremation services. All honorably discharged veterans or eligible spouses will be interred at Ft. Bliss National Cemetery. This solicitation for services provides the County the ability to authorize an entity to take charge of a decedent and have the body prepared for disposition by cremation and/or burial.

#### PURPOSE

The County seeks a Contractor that will discharge this duty in a respectful manner and in strict conformity with all applicable laws of Texas and the rules and regulations of the State as provided by Chapter 651 of the Texas Occupations Code and the Health and Safety Code, and the Texas Funeral Commission Standards and Regulations. The successful contractor shall comply with all specification listed in this Request for Proposal. This invitation for a RFP is open to business actively engaged in burial services. Proof of capability may be required prior to the award of a contract. The County will reimburse for services in accordance with the proposal as awarded. It bars any Contractor from assessing additional fees to a pauper's next of kin in connection with this service.

The County has historically used a County -owned cemetery for pauper burial services. The County has been responsible for upkeep and maintenance of the cemetery, burial of cremated remains and human remains. Attachment A - Frequently Asked Questions of this packet contains an overview of the program.

The County is now looking to privatize burial and cremation services and to have the cremains and remains buried in a private local cemetery in El Paso County. The successful Contractor will be responsible for taking possession of the decedent, prepare the body for cremation, cremate the body and bury or inter in a local private cemetery with whom the Contractor will work with for the burial of the remains and cremains.

#### MINIMUM REQUIREMENTS OF CONTRACTOR

The County Community Services Department through its General Assistance Division is responsible for determining the eligibility of the deceased, as an indigent burial.

The contractor is responsible for all aspects of the burial or cremation process, including transportation, preparation, containment, securing, opening and closing a plot, niche or crypt.

At the time of submitting this proposal, the contractor must disclose and submit for approval, to the El Paso County General Assistance Division (Department), any and all subcontractors that will be performing functions for the contractor prior to any involvement in the burial process described in these specifications. The contractor may <u>not</u> subcontract for any part of the services or items required by this contract except as disclosed in this proposal.

The Department will give written authorization to the contractor when a decedent is to be retrieved and prepared for burial or cremation. The contractor shall take possession of the body at the morgue, the medical examiner's office, or any other location within El Paso County and transport the body to the contractor's facility or a subcontractor's facility.

The decedent shall be cared for and interred or cremated in strict conformity with the laws of the State of Texas and rules and regulations of the Texas Funeral Service Commission. An entity responding to this solicitation must be a licensed funeral establishment under the auspices of the Texas Funeral Service Commission.

The decedent shall be buried in an individual casket or if cremated interred in a grave, crypt, or niche. Cremated remains may be returned to family members at the family members' request.

#### A. Cremation Services

The County of El Paso's indigent burial policy prescribes that all identified pauper persons be cremated. In no case will a Veteran of the U.S. Armed Forces, identified or unidentified, be cremated. Other exceptions and special instructions for Veteran burials are noted in the Burial Services section of this RFP.

- 1. Contractor(s) shall respond to a first call from Department staff to take possession of a decedent, eligible for indigent services and have the body prepared for disposition by cremation.
- 2. First call availability is 24 hours per day seven days per week.
- 3. Contractor shall provide reliable phone number to the County for after-hours calls that is answered 24/7, to avoid usage of answering service or voice mail.
- 4. Contractor's personnel responding to a first call from the Department must hold a funeral director license or be authorized by the funeral director. Proof of funeral director license must accompany RFP submittal.

- 5. In the event of a natural disaster or inclement weather, Contractor must stay operational to assist the Department.
- 6. Contractor shall not release any information about or discuss a death, death scene or decedent to the media or any persons. All information regarding decedents, investigations, or other matters shall be held in strictest confidence at all times.
- 7. The Contractor(s), shall take possession of the decedent at the Medical Examiner Office, health care facility or any other location within El Paso County and transport the decedent to the Contractor's facility within twenty-four (24) hours of notification. The Contractor(s) must comply with all applicable laws and specific procedures required in handling and transporting of decedents.
- 8. Contractor must own and have available a minimum of two (2) transport vehicles in their inventory at all times. In addition, in the event where two transport vehicles are not sufficient, Contractor must have access to additional vehicles. Vehicles shall be reliable, clean, mechanically sound, secure, dignified, private and in good appearance. Vehicle must be kept in good repair and have regularly scheduled and documented maintenance records. These records must be available for review by El Paso County authorities on request. The interior of the vehicles must be regularly cleaned and disinfected. Vehicles must allow for bodies to be tightly secured to prevent any damage during transport.
- 9. All transports require the use of a body bag if there are any bodily fluids present. Transport stretchers shall be padded and secured in a manner that immobilizes the body from moving during normal transport. Padding shall be installed on all head-bars to prevent injury during a sudden stop. A pillow shall also be used between the head and the head-bar for additional support.
- 10. Contractor is required to have on-site storage cooler and may be inspected by an El Paso County authorized representative at any time during this contract.
- 11. The Contractor(s) shall provide storage and refrigeration of the decedent until the conclusion of the statutory waiting period for cremation or for a time period authorized by Department staff. The decedent's body will be prepared according to the minimum requirements of State law.
- 12. The Contractor(s) shall make arrangements for cremation services with a licensed crematory establishment if services are not provided directly by the Contractor(s).
- 13. The Contractor(s) shall provide removal of decedent and transportation of the decedent for cremation.
- 14. The cremains shall be attended by and interred in the presence of a funeral director licensed by the State of Texas according to the minimum requirements of State law.

- 15. The Contractor(s) shall provide transportation and interment of the cremains at a private local cemetery and follow all rules and regulations of said local private cemetery. Cremation must occur as prescribed by Chapter 205 of the Texas Administrative Code.
- 16. Interment of cremains must take place within 30 calendar days or less from having received the referral from the Department. Contractor must store cremains properly and as prescribed by State law and ensure that at least once per month interment of cremains takes place.
- 17. The Contractor shall reserve/dedicate a grave (s), crypt(s) or niche(s) in a private cemetery or their own facility exclusively for El Paso County cremains. There must be a capacity to support a minimum of 60-80 cremains per annum. This amount is the average number of indigent burials performed by the County each year.
- 18. The Contractor shall provide a container for the cremains to be interred in said crypt(s), grave (s) or niche (s) and shall be at a minimum of metal or Ziegler type case to be interred and will meet the minimum requirements of said local private cemetery if applicable and State law.
- 19. The Contractor shall provide and install an economy bronze niche plate minimum size 2" x 4" or equivalent that meets minimum crypt/niche and/or cemetery requirements and state law for each cremain interred in the crypt(s) at the time of interment. The niche plates will be engraved with the decedent's full name, date of birth (if known) and date of death (if known).
- 20. Shipping of cremains at the request of next of kin shall be at the expense of next of kin as authorized by Department staff.
- 21. Establish and maintain a system for tracking cremation services and location of interred cremains accessible to County staff and/or next of kin in the event of a disinterment request. (See Disinterment)
- 22. Timely billing, at a minimum monthly, to the County for cremation and burial services authorized by Department staff. (See Invoicing)
- 23. Contractor shall obtain death certificates and reports of death and burial permits or cremation permits for each body from the proper authorities as prescribed under Chapter 193 of the Texas Health and Safety Code. These instruments, properly approved, must be available at the time of the interment. Death certificates must be filed with Bureau of Vital Statistics.
- 24. Contractor's clothing shall represent "best commercial practice" and shall be clearly marked with Contractor's name on the clothing or with badge identification. Fully enclosed shoes or boots and full length pants must be worn at all times. Casual clothing is prohibited without the Contractor's name on the clothing or without badge identification.

#### **B. Burials Services**

The Department's indigent burial policy prescribes that veterans, infants and unidentified persons (Jane or John Does) be buried in a grave. Infants may be cremated and interred as prescribed in this RFP at the request of next of kin and as authorized by Department staff.

Contractor must meet conditions 1-10 as listed in Section A. Cremation Services including conditions as prescribed below.

- 1. The Contractor(s) shall provide storage and refrigeration of the decedent until the burial has been coordinated and taken place with said local private cemetery.
- The decedent's body will be prepared according to the minimum requirements of State law. The Contractor(s) shall make arrangements for preparation of the decedent for burial with a licensed mortuary establishment if services are not provided directly by the Contractor(s).
- 3. Contractor shall be responsible for transporting the body of the decedent to the grave site and shall follow all rules of said local private cemetery.
- 4. The decedent's burial shall be attended by and interred in the presence of a funeral director licensed by the State of Texas according to the minimum requirements of State Law.
- 5. The Contractor shall ensure that the interment occur in a cemetery that is maintained in a respectful and presentable manner. Cemetery must be licensed to conduct business as a private cemetery in accordance with State law. The grounds will be reasonably leveled after each burial and mowed at least once per month during the spring and summer months (April-September).
- 6. The Contractor shall provide an outer burial container for the grave that meets the minimum requirements of said cemetery and State law.
- 7. Interment of decedents under this section must take place within 30 calendar days or less of written authorization or referral from the Department. Contractor must store the body (ies) properly and as prescribed by State law and must notify the Department 48 hours prior to each scheduled burial.
- The Contractor shall provide an economy grass marker measuring 20x10 inches and adhering to minimum standards as prescribed by cemetery regulations and State Law. Special care should be taken to ensure temporary grave markers remain visible and intact.
- 9. The Contractor shall maintain an accurate and current layout of the cemetery, hereby knowns as the "Map". The Map will serve as an identification and location tool for family members looking to place a permanent marker and for easy identification of each plot as necessary. An updated Map should be furnished to the County on a monthly basis with the Invoice for payment.

- 10. The Contractor shall establish and maintain a system for tracking burials and location of interred remains accessible to Department staff and/or next of kin in the event of a disinterment request. (See Disinterment)
- 11. The Contractor shall ensure timely billing, at a minimum monthly, to the County for burial services authorized by Department staff. (See Invoicing)
- 12. Contractor shall obtain death certificates or reports of death and burial permits for each body from the proper authorities as prescribed under Chapter 193 of the Texas Health and Safety Code. These instruments, properly approved, must be available at the time of the interment. Death certificates must be filed with Bureau of Vital Statistics.
- 13. Contractor's clothing shall represent "best commercial practice" and shall be clearly marked with Contractor's name on the clothing or with badge identification. Fully enclosed shoes or boots and full length pants must be worn at all times. Casual clothing is prohibited without the Contractor's name on the clothing or without badge identification.
- 14. Contractor shall provide burial services to include the following services and items.
  - a. Embalming or necessary body preparation as required by the Texas Funeral Service Commission.
  - b. Casket will be of doeskin, pinewood or metal type, cloth covered, non-protective or equivalent to meet minimum standards and requirements as prescribed by State law.
  - c. Temporary grave marker must be provided. The temporary marker will have all the known identifying information for the decedent to include full name, date of birth, and date of death.
  - d. Burial must be in a single local private cemetery located in El Paso County and follow all rules and regulations of private, local said cemetery and State law. Contractors must provide, at the time of proposal submittal, a written agreement or legal binding arrangement with a single local cemetery where remains and cremains will be interred under this contract if the services are not provided directly by the Contractor.
  - e. Provisions for opening and closing of grave, crypt or niche space.
  - f. Filing and documentation of all required paperwork.
- 15. Contractor shall coordinate all Veteran burials with the U.S. Department of Veterans Affairs, National Cemetery Administration for burials at Ft. Bliss National Cemetery. Contractor will notify the Department of impending Veteran burial within 48 hours of scheduled burial.
- 16. El Paso County reserves the right to inspect any burial service to ensure specifications are satisfied.

## C. Invoicing

Before payment will be made by El Paso County, the contractor shall furnish, with his invoice for services, an affidavit properly made and sworn to that the specifications contained herein have been strictly adhered to, and that the contractor has not received and will not accept or receive any other compensations, money or otherwise, from any person for services for which the County is being charged.

Contractor may not receive any supplemental payments from any family member or other source including insurance until such time as the County is reimbursed in full.

Invoicing must include the following:

- a. Correct full name (if known), date of birth and date of death of the deceased individual.
- b. For deceased individuals whose identity is unknown, invoice must include Medical Examiner's Office case number, gender and date or approximate date of death.
- c. The identifying case number if the case is a case from the Medical Examiner's Office.
- d. Location of final disposition to include cemetery name, crypt or mausoleum name, plot and space number.
- e. Date of service.
- f. Itemized cost of services.
- g. Map of location if interred in a grave.

Where twin children are to be buried in the same casket, the County shall pay as though only one body were involved.

#### D. Disinterment/Re-interment

El Paso County does not pay for family-requested exhumations. The following specifications are required to be followed for exhumation services requested by any other authority as required by court order.

- 1. The Contractor(s) shall arrange and direct all exhumations and re-interments for El Paso County which are authorized by the Department.
- 2. The Contractor(s) shall provide a licensed funeral director to oversee the exhumation and re-interment as required by the laws of the State of Texas.
- 3. If family-requested disinterment, the Contractor shall deliver the exhumed remains to the family at the cost of the family. El Paso County will not be held liable for any cost of said disinterment and/or re-interment or any associated costs.

- 4. The Contractor shall update records to reflect the disinterment and provide updated records and Map to Department staff immediately.
- 5. Court Ordered disinterment: The Contractor shall deliver the exhumed remains to the morgue, the El Paso County Medical Examiner's Office or any other authority as prescribed by Court Order. The Contractor shall take possession of the remains and re-inter if necessary upon release by the El Paso County Medical Examiner's Office or any other authority.
- 6. For re-interment: The Contractor shall prepare the remains at the Contractor's facility in accordance with the laws of the State of Texas. The Contractor shall provide a disaster pouch if necessary and any other required supplies.
- 7. The Contractor shall reuse the original casket if original casket is in reasonable condition. If original casket is unusable, a new casket shall be replaced.
- 8. The Contractor shall make every effort to keep the outer container in the grave and reusable during the exhumation. The outer container shall be reused if it continues to meet minimum requirements of the cemetery. If the original outer container is unusable, the outer container shall be replaced.

### E. Experience

The Contractor shall provide a summary of its current and recent history of past performances relating to providing burial services/indigent burial services and/or charitable-type of burial services. Contractor is cautioned that it is the Contractor's sole responsibility to submit information requested in this RFP and that the County of El Paso is under no obligation to solicit such information if it is not included with the proposal. Failure of Contractor to submit such information may cause an adverse impact on the evaluation of this RFP. The County reserves the right to consider historic information and facts gained from this RFP, references, or other objective data in the evaluation process.

- 1. Company Profile
  - a. Specify the date organized and type of organization (partnership, corporation, etc.). Include a brief history of the organization, management structure, current services provided, and any other relevant information pertinent to demonstrating the Contractor's capability. Include location of corporate headquarters, parent company identification, and subsidiary or affiliate identification (if applicable).
  - b. List and describe any similar or larger communities with whom the Contractor presently has or has provided indigent burial services or similar burial services. All Contractors are to notate if indigent burial services have not previously been provided by the company/organization. All Contractors are to include the following information:

- Client name, address, and telephone number;
- Date of original contract and expiration date;
- Number of renewals, if applicable
- c. Discuss any corporate reorganization or restructuring that has occurred within the last three years and discuss how the restructuring will impact upon the Contractor's ability to provide services proposed. Discuss any announced pending mergers or acquisitions which affect the information on corporate organization listed above.
- d. List and describe other current or anticipated contractual obligations that have been awarded that will coincide with the terms of this contract.
- e. Provide an organization chart delineating organizational structure. Include a project organizational chart showing the proposed local service team for this contract.
- 2. Financial Statements

If requested, Contractor shall provide audited financial statements that have been audited by an independent Certified Public Accountant (CPA) or CPA firm for the preceding two-year period.

If Contractor is a wholly owned subsidiary of another company or corporation, and Contractor does not possess audited financial statements, then unaudited financial statements for subsidiary for the preceding two-year period must be submitted as supplemental information to the company's financial statements to meet this requirement.

3. Qualifications

By submitting and signing this proposal, Contractor expressly affirms and certifies that it

- a. Is a duly qualified, capable, and otherwise bondable business entity;
- b. Has a minimum of five (5) year in business providing similar services;
- c. Is not in receivership;
- d. Does not owe any back taxes within El Paso County, Texas
- e. Is able and capable of performing its duties as described in this RFP through its own resources and/or assignment or subcontracting to others;
- f. Is normally engaged in this type of business; and
- g. Is familiar with and will abide by all laws, regulations, and customs applicable to this type of service.

#### 4. Licenses/Permits

All licenses or permits required by any State, County, or other governmental authority shall be secured by Contractor at its sole cost and expense.

#### F. Inventory

Contractor shall provide a list of current inventory of transport vehicles, to include make, model and year.

#### G. Term of Contract

The contract shall be for an initial term of one (1) year effective when contract is fully executed by both parties.

The contract may be renewed on an annual basis for a maximum of two (2) additional oneyear periods. Each option to renew shall be exercised in writing solely at the discretion of the County, for the same terms and conditions, unless mutually agreed in advance to any changes to the original terms and conditions. The initial contract and any renewal contract may be terminated by either party for any reason by giving thirty (30) calendar days written notice of the intent to terminate.

The combined maximum period, including the initial term and renewals, shall not exceed three (3) years.

#### H. Evaluation Criteria

Proposals shall be evaluated based on the requirements set forth in the RFP. Selection of the firm(s) will be at the discretion of the County and will be based on the proposal that the County deems to be the most responsive and responsible and serves the best interests of the County.

## **ATTACHMENT A - FREQUENTLY ASKED QUESTIONS**

### PAUPER BURIAL SERVICES

#### CREMATIONS

- Who is eligible for indigent pauper burial services in El Paso County? Individuals who die in El Paso County and meet residential and income eligibility guidelines qualify for indigent cremation services. Veterans, unidentified remains and infants will receive a casket burial. In the case of an infant decedent, a cremation can be performed if requested by the parent(s). See Burials
- 2. What happens to the cremains? Cremains are either buried in the County Cemetery or given to the next of kin at their request.
- **3.** Is there a graveside service? No, there is no graveside service or viewing prior to cremation.
- 4. What is the average amount of cremations completed in a year? During FY18 (Oct 2017 to Sept 2018) there were fifty-seven (57) adult cremations and eight (8) infant cremations
- 5. Do cremains have to be buried in a plot? No, cremains can be interred in a niche or mausoleum.

#### BURIALS

1. Who is eligible for a regular burial?

Unidentified remains and Veterans are eligible for a regular casket burial. Veterans are buried at Ft. Bliss with a military service and unidentified remains are currently buried in a casket at the County Cemetery.

- Is there a graveside service? No, there is no viewing or graveside service prior to burial. There is a military service for Veterans buried at Ft. Bliss National Cemetery. The service is coordinated through the (type in the organization that arranges the service).
- 3. What is the average amount of burials conducted yearly? During FY18 (Oct 2017 to Sept 2018) there were six (6) Veteran Burials and (1) infant unidentified remain burial.

#### **EXHUMATIONS**

1. Who pays for exhumation costs should exhumation be requested?

The cost of exhumation is the responsibility of the individual requesting exhumation.

#### MISCELLANEOUS

1. Is there a timeframe for burials?

There is no statutorily required timeframe for burials although the County will require that all burials whether cremains, unidentified remains, Veteran or infants must take place within 30 calendar days or less of having received the referral.

- 2. Who will determine eligibility for pauper burial services? General assistance staff will make the determination as to eligibility for services
- 3. Who is responsible for providing a grave marker? The entity responsible for burial/cremain interment will provide a grave marker/name plate for the deceased.

#### General Provisions County of El Paso, Texas

These General Provisions are considered standard language for all County of El Paso BIDS and Request for Proposal documents. If any "specific bid requirements" differ from the General Provisions listed here, the "specific bid requirements" shall prevail.

#### 1. BID/PROPOSAL PACKAGE

- **a.** The request for bid/proposal, general and special provisions, drawings, specifications/line item details, contract documents and the bid/proposal sheet are all considered part of the bid/proposal package. Bids/Proposals must be submitted on the forms provided by the County, including the bid/proposal sheet completed in its entirety and signed by an authorized representative by original signature. Failure to complete and sign the bid/proposal sheet/contract page (s) may disqualify the bid/proposal from being considered by Commissioners' Court. Any individual signing on behalf of the proposer expressly affirms that he or she is duly authorized to tender this bid/proposal and to sign the bid/proposal sheet/contract under the terms and conditions in this bid/proposal. Proposer further understands that the signing of the contract shall be of no effect unless subsequently awarded and the contract properly executed by Commissioners' Court. All figures must be written in ink or typed. Figures written in pencil or with erasures are not acceptable. However, mistakes may be crossed out, corrections inserted, and initialed in ink by the individual signing the bid/proposal. Changes must also be made to any electronic copies submitted. If there are discrepancies between unit prices quoted and extensions, the unit price will prevail. Each bidder/proposer is required to thoroughly review this entire bid/proposal packet to familiarize themselves with the bid/proposal procedures, the plans and specifications for the requested work as well as the terms, and conditions of the contract the successful proposer will execute with the County.
- b. Bid/Proposal must be in the Purchasing Department BEFORE the hour and date specified. Faxed or e-mailed bids/proposals will not be accepted. Late bids/proposals will not be considered under any circumstances.
- **c.** Any bid/proposal sent via express mail or overnight delivery must have the BID/RFP number and title clearly marked on the outside of the envelope or package. Failure to clearly identify your bid/proposal may be cause for disqualification.

#### 2. COMPETITIVENESS AND INTEGRITY

To prevent biased evaluations and to preserve the competitiveness and integrity of such acquisition efforts, proposers are to direct all communications regarding this bid/proposal to the El Paso County Purchasing Agent or assigned designee, unless otherwise specifically noted.

An authorized person from the submitting firm must sign all bids/proposals. The signature acknowledges that the proposer has read the bid/proposal documents thoroughly before submitting a bid/proposal and will fulfill the obligations in accordance to the terms, conditions, and specifications.

Please carefully review this Request for Bid/Proposal. It provides specific information necessary to aid participating firms in formulating a thorough response.

3. BIDDERS'S/PROPOSER'S RESPONSIBILITY

The Bidder/Proposer must affirmatively demonstrate its responsibility. The Bidder/Proposer must also meet the following minimum requirements:

- Have been in business of providing services for a minimum of one (1) years;
- Have adequate financial resources or the ability to obtain such resources as required;
- Be able to comply with all federal, state, and local laws, rules, regulations, ordinances and orders regarding this Request for Bid/Proposal;
- Have satisfactory record of performance;
- Have a satisfactory record of integrity and ethics; and
- Be otherwise qualified and eligible to receive an award.

#### 4. **REJECTION OF BIDS/PROPOSALS**

The County, acting through its Commissioners' Court reserves the right to: (1) reject any and all bids/proposals and waive any informality in the bids/proposals received; (2) disregard the bid/proposal of any proposer determined to be not responsible. The County further reserves the right to reject any bid/proposal due to failure of performance on deliveries as determined in writing by the County Purchasing Agent.

#### 5. RESTRICTIVE OR AMBIGUOUS SPECIFICATIONS

It is the responsibility of the prospective proposer to review the entire invitation to bid/proposal packet and to notify the Purchasing Department if the specifications are formulated in a manner that would restrict competition or appear ambiguous. Any such protest or question(s) regarding the specifications or bid/proposal procedures must be received in the Purchasing Department no less than seventy-two hours prior to the time set for bid/proposal opening. Vendors are to propose as specified herein or propose an approved equal. The mention of any brand name in the specifications is not intended to be restrictive, but is intended to describe the general features and requirements (or equivalent) that the County of El Paso is seeking.

Under Local Gov't Code Section 262.005 and Health & Safety Code Section 361.426, the County is required to give preference to products made of recycled materials if they meet specs. The County is also required to encourage the use of recycled products in developing new procedures and specs. They are also required to eliminate procedures and specifications that explicitly discriminate against products made of recycled materials.

#### 6. SUBSTITUTES

It is not the County's intent to discriminate against any material of equal merit to those specified however, should the proposer desire to use any substitutions, prior written approval shall be obtained from the County Purchasing Agent sufficiently in advance in order that an addendum might be issued.

#### 7. EXCEPTIONS TO BID/PROPOSAL

The proposer will list on a separate sheet of paper any exceptions to the conditions of the bid/proposal. This sheet will be labeled, "Exceptions to Bid/Proposal Conditions", and will be attached to the bid/proposal. If no exceptions are stated, it will be

understood that all general and specific conditions will be complied with, without exception.

The Bidder/Proposer must specify in its bid/proposal any alternatives it wishes to propose for consideration by the County. Each alternative should be sufficiently described and labeled within the bid/proposal and should indicate its possible or actual advantage to the program being offered.

The County reserved the right to offer these alternatives to other proposers.

#### 8. PRICING

Bid/Proposals for equipment shall offer new (unused) equipment or merchandise unless otherwise specified. Quotes F.O.B. destination. If otherwise, show exact cost to deliver (merchandise only). Bid/Proposal will be either lump sum or unit prices as shown on the bid/proposal sheet. The net price will be delivered to the El Paso County, including all freight or shipping charges. In case of error in extension, unit prices shall govern. BID/RFP subject to unlimited price increases will not be accepted. The County is tax exempt and no taxes should be included in your bid/proposal.

Unless prices and all information requested are complete, bid/proposal may be disregarded and given no consideration.

In case of default by the contractor, the County may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the contractor, the difference between the price named in the contract of purchase order and the actual cost thereof to the County. Prices paid by the County shall be considered the prevailing market price at the time such purchase is made. Periods or performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the Purchasing Agent and the Commissioners' Court.

#### 9. TAX EXEMPTION

Pursuant to Section 151.309 of the Texas Tax Code, El Paso County qualifies for exemption from sales, excise and use taxes imposed under the Limited Sales, Excise, and Use Tax Act, which is codified at Chapter 151 of the Texas Tax Code. In accordance with Section 151.309, a taxable item sold, leased, or rented to, or stored, used, or consumed by the County is exempt from the taxes imposed under Chapter 151.

#### 10. MODIFICATION OF BIDS/PROPOSALS

A bidder/proposer may modify a bid/proposal by letter at any time prior to the submission deadline for receipt of bids/proposals. Modification requests must be received prior to the submission deadline. Modifications made before opening time must be initialed by bidder/proposer guaranteeing authenticity. Bids/Proposals may not be amended or altered after the official opening with the single exception that any product literature and/or supporting data required by the actual specifications, if any, will be accepted at any time prior to the Commissioners' Court consideration of same. No substitutions or cancellations for merchandise will be permitted without written approval of the County Purchasing Agent.

#### 11. SIGNATURE OF BIDS/PROPOSALS

Each bid/proposal shall give the complete mailing address of the Bidder/Proposer and be signed by an authorized representative by original signature with the authorized representative's name and legal title typed below the signature line. Each bid/proposal shall include the Bidder's/Proposer's Federal Employer Identification Number (FEIN), failure to sign the Contract page(s) and bid/proposal response sheet will disqualify the bid/proposal from being considered by the County. The person signing on behalf of the Bidder/Proposer expressly affirms that the person is duly authorized to render the bid/proposal and to sign the bid/proposal sheets and contract under the terms and conditions of this BID/RFP and to bind the Bidder/Proposer thereto and further understands that the signing of the contract shall be of no effect until it is properly placed on the County Judge, and fully executed by both parties.

#### 12. AWARD OF BID/PROPOSALS-EVALUTATION CRITERIA AND FACTORS

#### Pursuant to the Texas Local Government Code

Bids shall be awarded to the responsible bidder that submits the lowest and best bid.

**Bid/Proposals** will be made to the responsible proposer whose bid/proposal is determined to be the best evaluated offer demonstrating the best ability to fulfill the requirements set forth in this Request for Bid/Proposal. The prices proposed will be considered firm and cannot be altered after the submission deadline. The proposed cost to the County will be considered firm, unless the County invokes its right to request a best and final offer and cannot be altered after the submission deadline.

The County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this BID/RFP and may discontinue its efforts under this BID/RFP for any reason or no reason or solely for the County's convenience at any time prior to actual execution of the contract by the County. County reserves the right to accept or reject all or any part of the bid/proposal, waive minor technicalities, or to award by item or by total bid/proposal. Price should be itemized.

## A Bidder/Proposer whose bid/proposal does not meet the mandatory requirements set forth in this BID/RFP will be considered noncompliant.

Each Bidder/Proposer, by submitting a bid/proposal, agrees that if its bid/proposal is accepted by the Commissioners' Court, such Bidder/Proposer will furnish all items and services upon the terms and conditions in this BID/RFP and contract.

Contractor shall submit to the County, for approval, within ten (10) days from notice of contract award, all Certificates of Insurance evidencing the required coverage as described under Insurance in the schedule of the Requests for Bids/Proposals.

#### 13. PUBLIC INFORMATION ACT

The parties agree that the County is a governmental body for purposes of the Public Information Act, codified as Chapter 552 of the Texas Government Code and as such is required to release information in accordance with the Public Information Act. Bidder/Proposer agrees that it has marked any information that it considers to be confidential, proprietary, and/or trade secret in its bid/proposal. County agrees to provide notice to Bidder/Proposer in accordance with the Public Information Act in the event the County receives a request for information under the Public Information Act for information that the Proposer has marked as confidential, proprietary, and/or trade secret.

#### 14. RESULTANT CONTRACT

The resultant contract shall become effective upon the Commissioners' Court execution of the same. The contract documents shall consist of the contract, the general and special provisions, the drawings, bid/proposal package, any addenda issued, and any change orders issued during the work.

The criteria utilized for determining responsibility of bidder/proposer(s) includes, but is not limited to, the proposer's experience, skill, ability, business judgment, financial capacity, integrity, honesty, possession of the necessary facilities or equipment, previous performance, reputation, promptness, and any other factor deemed relevant by the County to determine whether a bidder/proposer is responsible. The term of the resultant contract will begin as stated in the contract executed by the Commissioners' Court and will terminate on the date specified in the contract unless terminated earlier as herein set forth.

#### 15. ESTIMATED QUANTITIES

Any reference to quantities shown in the Request for Bids/Proposals are an estimate only. Since the exact quantities cannot be predetermined, the County reserves the right to adjust quantities as deemed necessary to meet its requirements.

#### 16. CONTRACTOR INVESTIGATION

Before submitting a bid/proposal, each contractor shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and to verify any representations made by the County upon which the contractor will rely. If the contractor receives an award as a result of its bid/proposal submission, failure to have made such investigations and examinations will in no way relieve the contractor from its obligation to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the contractor for additional compensation.

#### 17. NO COMMITMENT BY COUNTY

This Request for Bid/Proposal does not commit the County to award any costs or pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a bid/proposal to this request, or to procure or contract for services or supplies.

#### 18. BEST AND FINAL OFFERS

In acceptance proposals, the County reserves the right to negotiate further with one or more of the contractors as to any features of their proposals and to accept modifications of the work and price when such action will be in the best interest of the County. This includes solicitations of a Best and Final Offer from one or more of the proposers. If invoked, it allows acceptable proposers the opportunity to amend, change or supplement

their original proposal. Proposers may be contacted in writing requesting that they submit their best and final offer. Any such best and final offer must include discussed and negotiated changes.

#### 19. SINGLE BID/PROPOSAL RESPONSE

If only one (1) bid/proposal is received in response to the Request for Bids/Proposals, a detailed cost bid/proposal may be requested of the single contractor. A cost/price analysis and evaluation and/or audit may be performed of the cost bid/proposal in order to determine if the price is fair and reasonable.

#### 20. REJECTION/DISQUALIFICATION OF BIDS/PROPOSALS

El Paso County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this bid/proposal package and may discontinue its efforts for any reason under this bid/proposal package at any time prior to actual execution of the Contract by the County. Bidders/Proposers may be disqualified and rejection of bid/proposals may be recommended to the Commissioners' Court for any of (but not limited to) the following causes:

- A. Failure to use the bid/proposal form(s) furnished by the County, if applicable.
- B. Lack of signature by an authorized representative that can legally bind the company on the bid/proposal form.
- C. Failure to properly complete the bid/proposal.
- D. Bids/proposals that do not meet the mandatory requirements.
- E. Evidence of collusion among bidders/proposers.

#### 21. CHANGES IN SPECIFICATIONS

If it becomes necessary to revise any part of this bid/proposal, a written notice of such revision will be posted on the County Purchasing website. The County is not bound by any oral representations, clarifications, or changes made in the written specifications by the County's employees, unless such clarification or change is posted on the County Purchasing website. It shall be Bidder's/Proposer's responsibility to check the website prior to the bid/proposal opening date to verify whether any addendums have been posted.

#### 22. BID/PROPOSAL IDEAS AND CONCEPTS

The County reserves the right to adopt or use for its benefits, any concept, plan, or idea contained in any bid/proposal.

#### 23. BID/PROPOSAL DISCLOSURES

Results of bids/proposals for the purchase of goods, materials, general services and construction are considered public information at the time of the bid/proposal opening. All information contained in the bid/proposal response is available for public review.

The Proposal for Services: Only the names of those who submitted proposals will be made public information until an award is made by Commissioners' Court and contract executed by the parties. No price, staffing or other proposal information will be released. Proposers are requested to withhold all inquiries regarding their proposal or other submissions until after an award is made. No communication is to be had with any

County employee, other than the Purchasing Agent, regarding whether a proposal was received. Violations of this provision may result in the rejection of a proposal.

#### 24. WITHDRAWAL OF BID/PROPOSAL

Bidders/Proposers may request withdrawal of a sealed bid/proposal prior to the scheduled bid/proposal opening time provided the request for withdrawal is submitted to the Purchasing Agent in writing. No bids/proposals may be withdrawn for a period of sixty (60) calendar days after opening of the bids/proposals.

#### 25. INDEMNIFICATION

A. The contractor shall agree to assume all risks and responsibility for, and agrees to indemnify, defend, and save harmless, the County, its elected and appointed officials and department heads, and its agents and employees from and against all claims, demands, suits, actions, recoveries, judgments, and costs and expenses including reasonable attorney's fees for the defense thereof in connection therewith on account of the loss of life property or injury or damage to the person which shall arise from contractor's operations under this contract, its use of County facilities and/or equipment or from any other breach on the part of the contractor, its employees, agents or any person(s) in or about the County's facilities with the expressed or implied consent of the County. Contractor shall pay any judgment with cost which may be obtained against El Paso County resulting from contractor's operations under this contract.

Contractor agrees to indemnify and hold the County harmless from all claims of subcontractors, laborers incurred in the performance of this contract. Contractor shall furnish satisfactory evidence that all obligations of this nature herein above designated have been paid, discharged or waived. If Contractor fails to do so, then the County reserves the right to pay unpaid bills of which County has written notice direct and withhold from Contractor's unpaid compensations a sum of money reasonably sufficient to liquidate any and all such lawful claims.

**B.** Pursuant to Texas Local Government Code Section 262.032(b), any successful bidder who is awarded any contract in excess of \$50,000 may be required to execute a performance bond to the County. Said bond shall be in the full amount of the contract and must be furnished within 30 days after the date a purchase order is issued or the contract is signed and prior to commencement of the actual work.
