**FIRST AMENDMENT TO SERVICE AGREEMENT FOR DRUG TESTING CUPS  
AND LABORATORY CONFIRMATION SERVICES**

This Amendment is made to the Service Agreement for drug testing cups and laboratory confirmation services entered into in March 2014 made by and between the El Paso County, hereinafter referred to as "the County," on behalf of the El Paso County Juvenile Probation Department, hereinafter referred to as "JPD," and Redwood Toxicology Laboratory, hereinafter referred to as "Contractor," for the provision of drug testing services.

WHEREAS, Section XII 12.5 provides that the agreement may be amended in writing to include any amended provisions that may be agreed to by the parties.

NOW THEREFORE it is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed Agreement effective March 3, 2014 as follows:




- 6.1 Price shall be for cost per specimen for GC/LC/MS
  - \$6.00 per standard screen one Drug Standard Lab Panel LC/GS/MS
  - \$9.50 per GC/MS confirmation on site-devices
  - \$50.00 per UA-Multi Drug comprehensive panel
- 6.3 Cost per on-site screening cups and specimen for GC/LC/MS (Amendment Attachment A)







**Section II: Laboratory Panels with Built-In Confirmation Pricing**  
For screening specimens via the laboratory and confirming automatically.

**Methodology**

Initial screening of RTL's standard laboratory tests is performed by enzyme immunoassay (EIA). Confirmation is performed by a secondary method, including: gas chromatography (GC), gas chromatography/mass spectrometry (GC/MS), and/or liquid chromatography/tandem mass spectrometry (LC/MS/MS), depending on drug class. GC/MS confirmation on all positives is available upon request for an additional fee.

**SERVICE AGREEMENT FOR DRUG TESTING CUPS  
AND LABORATORY CONFIRMATION SERVICES**

This Service Agreement for the Provision of drug testing services (this "Agreement") is made by and between the El Paso County, hereinafter referred to as "the County," on behalf of the El Paso County Juvenile Probation Department, hereinafter referred to as "JPD," and Redwood Toxicology Laboratory, hereinafter referred to as "Contractor," for the provision of drug testing services.

**I. PURPOSE:** The purpose of this Agreement is to provide for the provision of drug testing services, laboratory and on-site drug screening supplies for the El Paso County Juvenile Probation Department and the 65<sup>th</sup> District Family Drug Court Program.

**II. SCOPE OF WORK:**

- 2.1 Contractor shall furnish drug testing laboratory confirmation services and/or on-site drug screening kits for the El Paso County Juvenile Probation Department and the 65<sup>th</sup> District Family Drug Court Program.
- 2.2 Contractor shall provide LOD confirmatory testing utilizing GC/MS technology at a minimum on all submitted urine specimens that screen positive using the point-of-collection devices and that creatinine levels be provided on all specimens.
- 2.3 Contractor shall furnish all required chain of custody forms, bags, shipping labels and containers.

**III. LABORATORY SERVICES**

- 3.1 Laboratory must be certified by the Clinical Laboratory Improvement Amendments (CLIA) or the Substance Abuse and Mental Health Administration (SAMHSA) for drug of abuse testing in human urine.
