Dear Honorable Judges and Commissioners Court Members:
The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2013 is submitted herewith. This report is required by the Texas Local Government Code, $\oint 114.025$. We believe that the information contained within this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2013. The following pages detail total collections by department and assessments by court.

Overall there was an average increase of $9.68 \%$ in collections throughout the various County departments compared to previous year collections. A majority of the increase in collections came from the Justice of the Peace and Constable departments. This was due, in the most part, to a better functionality of the new judicial computer system (Odyssey) in which warrant executions and collections are now operating at a smoother pace. Furthermore, the Scofflaw program was reinstated, which further increased the collection process. Several other departments also experienced a considerable increase in collections, including County Clerk, Domestic Relations and the County Tax Office. The County Clerk experienced an overall in crease by 12.9 percent, Domestic Relations a 15.7 percent increase, District Clerk 16.9 percent increase and County Tax Office a 12.2 percent increase.

My sincere thanks go to the County officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.
