The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 1996 is submitted herewith. This report is required by the *Texas Local Government Code*, § 114.025. We believe that the information contained in this report presents all of the financial activities on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year just ended. As a means of comparison, the 1996 fiscal year funds and fees exceeded the 1995 fiscal year funds and fees by 5.2%. The most significant increases were posted by the County Sheriff's Department and the West Texas Community Supervision and Corrections Department of 11.5% and 9.4% respectively.

We thank the county officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.





Computation of Food Cost Per Prisoner Day


The cost of food was \$1,507,618.07 and the total prisoner days were 465,319. The cost per prisoner day was \$3.24.
