

**EL PASO COUNTY COMMISSIONERS COURT ORDER  
ADOPTION OF 2023 TAX RATE FOR  
THE EL PASO COUNTY HOSPITAL DISTRICT**

**THAT ON THIS, THE** 28th day of August, 2023, the Commissioners Court of El Paso County, Texas met in a duly called session at the Commissioners Court Chamber, El Paso County Courthouse, 500 East San Antonio, Room 303, El Paso, Texas with the following members present:

and at said meeting, the Court did consider the following:

**ORDER ADOPTING THE 2023 TAX RATE FOR THE  
EL PASO COUNTY HOSPITAL DISTRICT**

**WHEREAS**, pursuant Texas Health and Safety Code section 281.065(a), the Court has the authority to impose an ad valorem tax for the benefit of a hospital district; and

**WHEREAS**, the El Paso County Commissioners Court, for the benefit of the El Paso County Hospital District, introduced and approved the following motions:

**Motion 1**

*“On behalf of the El Paso County Hospital District, that the property tax rate be increased by the adoption of a tax rate of \$0.235650 per \$100 of valuation, which is effectively a 6.12% increase in the tax rate which consists of a rate of \$0. 197663 per \$100 assessed value for the purpose of maintenance and operations of the El Paso County Hospital District for Fiscal Year 2024.”*

**Motion 2**

*“On behalf of the El Paso County Hospital District, that the property tax rate be increased by the adoption of a tax rate of \$0.235650 per \$100 of valuation, which is effectively a 6.12% increase in the tax rate which consists of a rate*

*of \$0.037987 per \$100 assessed value for the payment of principal and interest of the debts of the El Paso County Hospital District.”*

**NOW THEREFORE, BE IT ORDERED** that the El Paso County Commissioners Court, for the benefit of the El Paso County Hospital District, adopt the tax rate for said District, as stated above, and the Tax Assessor Collector is authorized to assess and collect these property taxes for the El Paso County Hospital District on October 1, 2023.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.997 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$14.64.**
