



Measure 3: Time to Disposition

Definition: The percentage of cases disposed or otherwise resolved within established time frames. This is a comparison of data from age of disposed cases and only considers cases that are disposed, not the full docket.

The Criminal District Courts have implemented a Felony Case Plan (CASE) that sets the time standards for El Paso County. The applied time frame for this measure will use the Standard Track time frame, in which a case can be disposed of between 275 days and 285 days. The most similar range in the reported data is between 181 and 365 days, which will be used for this measure.

Analysis and Interpretation: For each case, the report calculates the time, in days, from filing of the case in the Court until the date the case was disposed. The case processing time standards published by the American Bar Association (ABA), those published by the Conference of State Court Administrators (COSCA) and the National Center for State Courts (NCSC) provide a starting point for determining guidelines. The following charts display for each court the time periods required to dispose of their cases. Note: Although the time to disposition is measured only using active cases that have been disposed, the case time that elapsed when the defendant was a fugitive is included in this measure. (NCSC only counts the time the case was active)

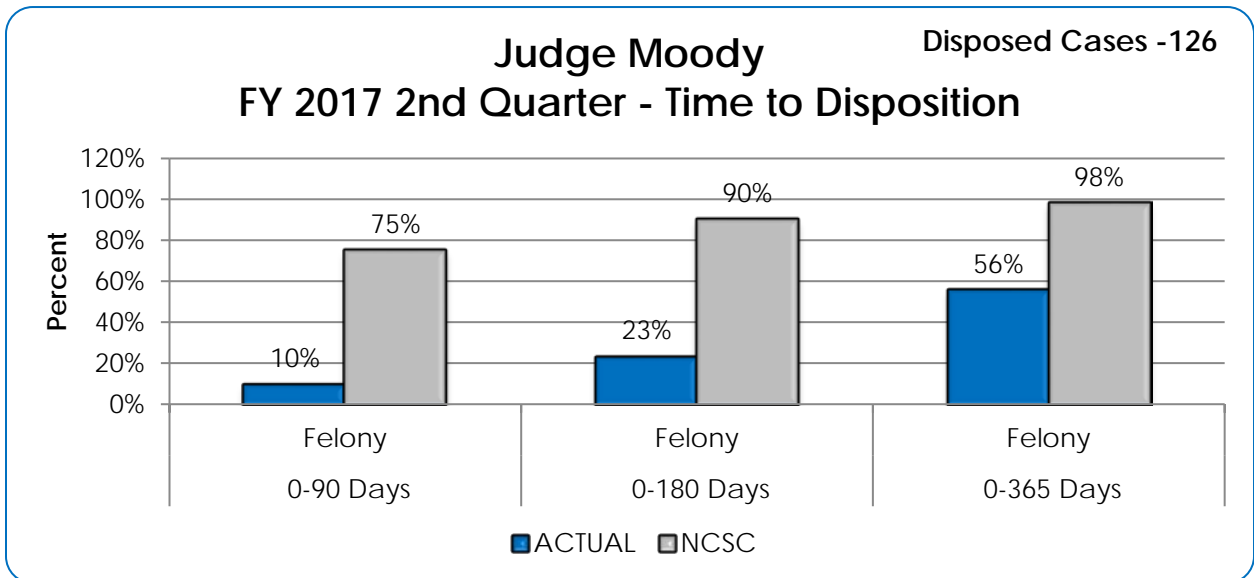
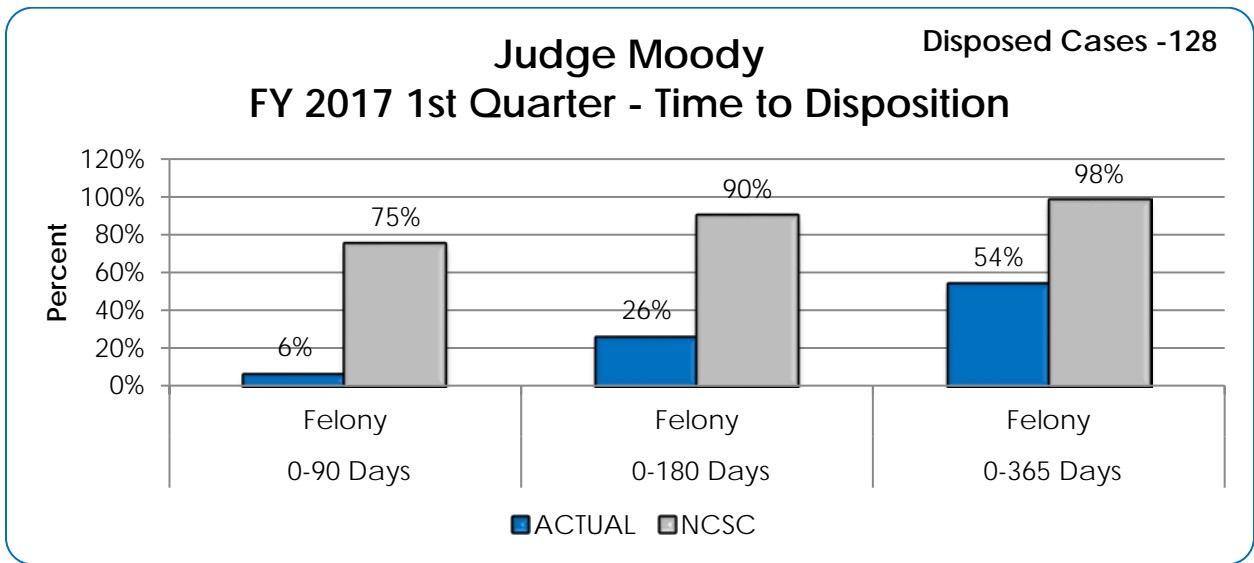
ABA Case Processing Standards – Criminal District Court and Misdemeanor Courts
