

**JOINT TERMINATION OF
CONSULTANT SERVICES CONTRACT**

This Joint Termination of Consultant Services Contract is entered into this 1st day of June, 2009, by and between the County of El Paso, Texas (COUNTY) and Dolores Messick (CONTRACTOR).

WHEREAS the parties have previously entered into a Consultant Services Contract (KK-08-448: hereinafter CONTRACT) wherein Contractor agreed to be available to provide professional consulting services to the Sheriff's Office from January 1, 2009 until June 30, 2009; and

WHEREAS the County agreed to compensate Contractor in the sum therein agreed; and

WHEREAS the parties have formed a consensus the services being provided by Contractor heretofore are no longer necessary; and

WHEREAS the parties mutually hereby declare that they, and each of them, have fully performed their respective duties and obligations under the provisions of said Contract;

NOW, THEREFORE, THE COUNTY AND CONTRACTOR ENTER INTO THIS JOINT TERMINATION OF CONSULTANT SERVICES CONTRACT AS HEREINAFTER SET FORTH:

- 1.1 The parties hereby terminate the Contract, effective June 1, 2009.
- 1.2 The parties fully and finally release each other from further performance of their respective duties and obligations under the Contract.
- 1.3 The parties fully and finally release each other from any claim(s) of non-performance of any of their respective duties and obligations under the Contract that may now exist or hereinafter be asserted.
