REQUESTING FOR THE COUNTY JUDGE AND COUNTY COMMISSIONERS TO APPROVE AND AUTHORIZE THE ACCEPTANCE OF THE GRANT AWARDED TO THE DWI DRUG COURT INTERVENTION AND TREATMENT PROGRAM.

BACKGROUND/DISCUSSION OF TOPIC: To include statutory requirement, operational impact, or performance goal.

THE GOVERNORS CRIMINAL DIVISION GRANT WILL SUPPORT THE DWI DRUG COURT INTERVENTION AND TREATMENT PROGRAM IN SEVERAL ASPECTS. THE FUNDING WILL COVER THE SALARY OF TWO PROBATION OFFICERS THAT WILL BE ASSIGNED TO THE DWI DRUG COURT PROGRAM ON A FULL TIME BASIS. TO INCLUDE OTHER EXPENSES SUCH AS DRUG TESTING SERVICES FROM LOCAL LABS, ANTABUSE ASSESSMENTS FROM LOCAL CLINICS, CELL PHONE MONTHLY SERVICES, DAILY SCRAM BRACELET MONITORING FEES, TRAVEL EXPENSES FOR TEAM MEMBERS TO ATTEND NATIONAL/STATE DRUG COURT CONFERENCES.

FISCAL IMPACT:

AWARDED AMOUNT \$129,720 FOR THE USE OF THE DWI DRUG COURT PROGRAM. NO COUNTY MTACH REQUIRED. THE DWI DRUG COURT PROGRAM HAS BEEN A RECEPIENT OF THE GOVERNORS CRIMINAL JUSTICE DIVISION GRANT SINCE 2005.
