THIS CONTRACT, made this 15 day of _______, 1986, by and between MIGUE, NAVAR, First Party, and the CITY OF EL PASO, Second Party, witness:th:

Application has been π : ie to the City of El Paso for rezoning a portion of Tract 16, Section 8, Block 79, Tsp. 3, T&PRR Co. Surveys, City and County of El Paso. Texas, which are more particularly described by metes and bourts in the attached Exhibit "A" which is made a part hereof for reference.

To remove certain objections to such rezoning, First Party covenants that if the property is rezoned from R-3 (Residential) to C-4 (Commercial) District w. hin the meaning of the zoning ordinance of the City of El Paso, i: shall be subject to the following restrictions, conditions and covenants:

1. The property can () ly be used for a baseball field(s), soccer field(s), 'olleyball court(s), racquetball court(s), basketb:ll court(s), tennis court(s), swimming pool(s), and other similar types of recreational uses.

 In conjunction wi:1 the above permitted uses, the following accessor; uses shall be allowed: pro-shop, restaurant, and foll and beverage concessions.

This agreement is a restriction, condition and covenant running with the land and a charge and servitude thereon, and shall bind First Party and his successors in title. Any future conveyance of the land shall contain this restriction, condition and covenant and shall embyly this agreement by express reference.

The City may enforce this agreement by injunction or any other legal or equitable remery. The City Council of the City of El Paso may amend or release the above restrictions, conditions and covenants in its discretion without the consent of any third person who may be benefited thereby, and without affecting the validity, or necessitating the amendment of, the ordinance passed


