The Purchasing Department received questions relating to the above referenced Proposal.

1. We would like to inquire on whether vendor/offeror needs to provide the facility in which the services will take place or if a space will be provided by the county.

The vendor will have to provide a space/location to conduct the requested treatment.

2. We also would like to ask the projected annual hours for the staff to be provided and projected number of personnel that is needed under each bid.

The hours and staff are dependent on the provider's ability to provide service. We have approximately 500 juveniles on probation. Approximately half are court ordered to attend some form of treatment/therapy. Depending, on the counseling format, curriculum and number of referrals the provider can accept will impact the annual hours of service and necessary personnel necessary.

3. Lastly, we would like clarification on whether these services are open to bid for agencies or whether they are for individual response only.

The bids are open to individuals and agencies, however, the services must be Provide by a Licensed Professional Counselor, Licensed Master Social Worker, Licensed Marriage and Family Therapist.

4. Which specific pre and post test instrument or measurement is being requested on page 6?

There is not a specific pre/post test required. The vendor is responsible for developing an instrument that will gauge the progress of the juvenile and/or family members. An example may be juvenile referred for substance abuse services. Initial assessments indicates the juvenile was testing positive every months, at time of discharge the juvenile tested positive only once for a three month period; or juvenile is reoffered for anger management. Juvenile upon being referred is verbally aggressive in the home everyday; upon completing counseling services the juvenile has only one documented outburst every two weeks.
