#### **REQUEST FOR PROPOSAL**

#### I. SEX OFFENDER TREATMENT

**Purpose:** To provide evaluation, assessment and treatment of youth adjudicated for reportable sex offenses, which require sex offender registration. The primary goals of treatment shall be to assist juveniles in gaining control over their sexual behavior problems, enhancing the juveniles overall functioning, increasing their pro-social interactions, preventing further victimization, halting development of additional psychosexual problems, and developing age-appropriate relationships.

Sex Offender Treatment services for the Juvenile Probation Department to include, but not limited to, juvenile probationers, significant others, and family members through individual, group or family sessions.

It is the intention of the Juvenile Probation Department to receive Request for Proposal that reveal actual costs for the sex offender treatment services as follows:

#### Vendor must adhere to Texas Administrative Code, Title 22, Chapter 810 "Council on Sex Offender Treatment"

Treatment shall incorporate both cognitive/behavioral and re-offense prevention plans to reduce recidivism. A multifaceted program shall be age and developmentally appropriate and may include but is not limited to the following:

Group and individual cognitive behavioral treatment shall be gender specific Sexual offense sequence Re-offense prevention plans Family therapy Victim empathy

- A. Individual sessions- Must be performed directly by a Licensed Sex Offender Treatment Provider (LSOTP), Affiliate Sex Offender Treatment Provider (ASOTP) or Provisional Sex Offender Treatment Provider (PSOTP) Cost per counseling 1 hour per person.
- **B. Juvenile Group sessions-** Must be performed directly by a Licensed Sex Offender Treatment Provider (LSOTP), Affiliate Sex Offender Treatment Provider (ASOTP) or Provisional Sex Offender Treatment Provider (PSOTP). Services must be available as needed.

#### 1. Developmentally delayed juveniles group-

Maximum of eight- (8) person's in-group that consists of developmentally delayed juveniles based on psychological evaluation provided and/or evaluation conducted by provider. Sessions must not exceed sixty- (60) minutes and must be sensitive to an individual's culture, language of literacy and understanding, ethnic, developmental, sexual orientation, gender, medical, and/or educational issues that may be identified during the assessment. **Cost per counseling 1 hour per person.** 

#### 2. Non-Developmentally delayed juveniles group-

Maximum of eight- (8) person's in-group that consists of non-developmentally delayed juveniles based on psychological evaluation provided and/or evaluation conducted by provider. Sessions must not exceed 1½ hours and must be sensitive to an individual's culture, language of literacy and understanding, ethnic, developmental, sexual orientation, gender, medical, and/or educational issues that may be identified during the assessment. **Cost per counseling 1-1**/<sub>2</sub> hours per person.

- C. Parent Group sessions- Must be performed directly by a Licensed Sex Offender Treatment Provider (LSOTP), Affiliate Sex Offender Treatment Provider (ASOTP) or Provisional Sex Offender Treatment Provider (PSOTP). Services must be available as needed. (Maximum of eight- (8) pairs (1 or 2 parents/caregivers) in-group and sessions must be 1-1/2 hours. Cost per counseling 1-1/2 hours per pair.
- **D. Family sessions-** Must be performed directly by a Licensed Sex Offender Treatment Provider (LSOTP), Affiliate Sex Offender Treatment Provider (ASOTP) or Provisional Sex Offender Treatment Provider (PSOTP). Sessions must not exceed 1hour and must be sensitive to family's culture, language of literacy and understanding, ethnic, developmental, sexual orientation, gender, medical, and/or level of education that may be identified during the session. Services must be available as needed. **Cost per counseling 1 hour per family.**
- E. Juvenile Sex Offender Evaluation and Assessment-The evaluation shall focus on strengths, the risks, and deficits of the juvenile with sexual behavior problems, as well as identifying factors from social and sexual history, which may contribute to sexual deviance. Evaluations provide the basis for the development of comprehensive treatment plans and should provide recommendations regarding the intensity of intervention specific treatment protocol needed amenability to treatment, as well as the identified risk the juvenile with sexual behavior problems presents to the community. Psychological profiles cannot be used to prove or disprove an individual's propensity to act in a sexually deviant manner. Cost per evaluation and assessment.
  - 1. The assessment shall be age appropriate.
  - 2. The assessment shall be sensitive to any cultural, language, ethnic, developmental, sexual orientation, gender, medical and/or level of education that may be identified during the evaluation.
  - 3. The assessment shall be developmentally appropriate which includes social, cognitive, and educational levels.
  - 4. The assessment shall determine the client's level of functioning, appropriate treatment interventions, and facilitate the development of an individualized treatment plan. Assessments shall be individualized and reasonable efforts shall be made to acquire collateral information as well as the following information:

- a. Criminal investigation records (only when child is adjudicated for the referred offense(s) and information may be redacted from the criminal investigation records to reflect the adjudicated offense(s)).
- b. Intellectual and cognitive functioning
- c. Mental status psychiatric history/hospitalization
- d. Medical history and an exam by a medical professional to determine sexual development
- e. Self destructive behaviors including self-mutilation and suicide attempts
- f. Family origin and history/relationship including exposure to domestic violence
- g. Criminal history
- h. Sex offender registration status
- i. History of violence and aggression
- j. History of school truancy, fire-setting, abuse of animals, and running away
- k. Cognitive distortions
- I. Impulse control
- m. Trauma assessment (emotional, physical, sexual abuse)
- n. Social and educational competence
- o. Substance abuse
- p. Sexual history including sexual development, sexuality and experimentation, gender identity issues, masturbatory practices, and fantasy consent
- q. Sexual deviant behavior-including a description of the offense behaviors, number of victims, gender and age of victims, frequency and duration of sexual contact, victim selection, access, grooming behaviors, use of threats, coercion or bribes to maintain victim silence, degree of force used before, during and/or after the sexual behavior, and deviant arousal patterns
- r. Collateral Information. The treatment provider shall thoroughly review written documentation and collateral interviews. This involves gathering and reviewing information from all available and relevant sources concerning the juvenile and the victim, including:
  - 1. Parent or guardian

- 2. Sibling
- 3. Statements from the victims
- 4. School records
- 5. Child protective services
- 6. Previous treatment provider
- 7. Mental health professional
- 8. The following may be provided from the supervising officer:
  - a. Petition
  - b. Court orders
  - c. Pre-disposition reports
  - d. Psychological/psychiatric evaluation when available
- 9. Optional administration of Psychological Tests for purposes of assessment. Psychological tests have been described as a "critical dimension" to a comprehensive evaluation of juveniles. The primary components required but not limited to the assessment of the juvenile are as follows:
  - a. Intellectual and neurological functioning
  - b. Personality (for example: Jesness Inventory, MACI, Minnesota Multiphasic Personality Inventory-MMPI-A for adolescents)
  - c. Psychopathology (for example: Piers Harris Children's Self Concept Scale, Hare's Psychopathy Scale Youth Version)
  - d. Behavioral
  - e. Sexual deviance
  - f. Co-morbidity

#### **OTHER REQUIREMENTS**

Juvenile sex offender evaluation and assessment must be returned typed within 3 working days of assessment.

The Vendor must be available to communicate and staff cases with supervising Juvenile Probation Officer on a regular basis. Vendor will provide a progress report monthly along with the billing. A progress report may also be requested at anytime by the Probation Officer and/or the Court. The progress report shall identify progress or lack of progress based on clearly specified objective criteria, refusal or failure to attend or participate in treatment, failing to abide by the client's treatment plans and/or contracts, or any disclosures regarding violations of supervision shall be clearly documented in treatment records. An action plan shall be provided for any areas in which the juvenile is not progressing. This information shall be provided and communicated to the appropriate supervising Juvenile Probation Officer in the justice system according to the referring agency policy or pursuant to the court order.

Individualized treatment plans should be designed and periodically reassessed and revised. Treatment Plans should have specific treatment needs, treatment objectives, and required interventions.

# Must provide services in the language of literacy and understanding of the juvenile.

A typed progress report, to include the elements within the Juvenile Justice Evaluation Center Logic Model, must be signed and submitted to the Juvenile Probation Department within the 5<sup>th</sup> -calendar day of the month. Failure to submit progress reports in a timely manner will result in non-payment for services. **(See attached)** 

Typed progress reports should be issued to the agency that has mandated treatment and should be discussed with the juvenile and parents. Progress "must be based on specific measurable objectives, observable changes and demonstrated ability to apply changes in current situation".

A Vendor may be called to testify in a Court of Law.

The Vendor will also provide a one- (1) hour class a minimum of four- (4) times a year in coordination with the El Paso County Juvenile Probation Department. The Vendor will explain the services delivered to participants and families as part of their contractual agreement.

Vendor will also provide a recommendation for sex offender registration.

Services shall only be provided to juveniles referred by the Juvenile Probation Department. Groups shall not be co-mingled with non Juvenile Probation Department referred youth.

### COST

Case staffing with family and Juvenile Probation Department personnel will be at no cost.

# Costs to include all typed and signed documentation/reports to the Juvenile Probation Department.

All representations made by the Juvenile Probation Department are contingent upon availability of funds from which payments for the contract services can be

#### made and do not represent an obligation on the part of the Juvenile Probation Department, the County of El Paso, or the Texas Juvenile Probation Commission.

Administrative expenses and communications with family, school, referral source, or other agencies considered part of the cost per counseling hour and may not be billed as a separate cost. Services must be available as needed. The department will not be financially responsible for missed appointments.

#### Individual Session: Cost per counseling 1 hour per person.

Juvenile Group sessions: Developmentally delayed juveniles group Cost per counseling 1hr/person.

Juvenile Group sessions: Non-Developmentally delayed juveniles group Cost per counseling 1½ hrs/person.

Parent Group sessions: Maximum of eight- (8) pairs (1 or 2 parents/caregivers) in-group and sessions must be 1-1/2 hours. Cost per counseling 1-1/2 hours per pair.

#### Family sessions: Cost per counseling 1 hour per family.

Juvenile Sex Offender Evaluation and Assessment: Cost per evaluation and assessment. A typed and signed copy of the sex offender evaluation will be provided to the Juvenile Probation Department whether they were paid through private insurance, CHIP or Medicaid, the Juvenile Probation Department, or any other source of funding.

#### **MEASUREMENT OF PROGRAM OUTCOME**

Proposed goals, objectives, activities, and outcome measures need to be presented in the logic model format. (See attachment and/or refer to <u>http://www.jrsa.org/jjec</u>). Additionally, present the criteria utilized to define a successful and unsuccessful closure must be submitted as part of this bid.

- 1. The rate of successful closures
- 2. The rate of unsuccessful closures
- 3. Recidivism Rate (new adjudications)
- 4. Out of home placement avoidance

### PROPOSAL SUBMISSION

The original plus four- (4) copies of an applicant's proposal must be received by the El Paso County Purchasing Department at the address indicated on the cover page of the Request for Proposal. A representative at the Purchasing Department will date-stamp and time-stamp every proposal received immediately upon receipt. All proposals received before the proposal submission deadline will be kept in a secure location until the due date and time.

The applicant's original proposal must be unbound with no staples or heavy paper stock within the document itself. It may be necessary to reproduce the original application to provide sufficient copies for review purposes. Therefore, the applicant should not include anything that cannot be photocopied using automatic processors. Such items include anything stapled, folded, pasted, or in a size other than 8 ½" x 11" on white paper and heavy or lightweight paper which could disable the photocopy machine and/or become destroyed. Odd sized attachments of any kind will not be copied or sent to reviewers. Excessive or over-sized material, i.e., posters, videotapes, audiotape, or CDs should not be included. Documents may be photo-reduced or have type closer than fifteen- (15) characters per inch. Furthermore, only one side of each page should have printing.

#### **Proposal Format**

Each applicant may submit one proposal. The proposal must be submitted as an original plus four- (4) copies as stated in the PROPOSAL SUBMISSION section.

Application materials could accidentally get out of order when being processed, thus every sheet of the proposal must have a page number. It is also requested that pages be numbered consecutively from beginning to end (i.e., page 1 for the Cover Page, page 2 for Letter of Transmittal, page 3 for the Table of Contents, etc). Any appendices should be labeled and separated from the narrative and financial information section, and the page numbers should be continued in the sequence.

The proposal must be organized and indexed in the following format and must contain, at a minimum, all listed items in the sequence indicated:

Cover Page Letter of transmittal Table of Contents Proposal Narrative Financial Information Application Forms & Certifications

Within each section of the proposal, applicants should address the items in the order in which they appear in the Request for Proposal.

Any proposal that does not adhere to this format, and which does not address each specification and requirement within the Request for Proposal may be deemed non-

responsive and rejected on that basis. All material submitted in response to this Request for Proposal becomes the property of El Paso County.

### COVER PAGE

Each proposal must have the Proposal Schedule form as the cover page.

The cover page must:

- Identify the Request for Proposal (i.e., Proposal for the Sex Offender Treatment Program)
- Identify the applicant organization
- Identify the applicant organization's contact person
- Identify the applicant organization's address, phone and FAX
- Indicate the date of the proposal.

## LETTER OF TRANSMITTAL

A Letter of Transmittal must accompany each proposal containing the following:

- Must be on official business letterhead
- Identify the applicant organization and contact person
- Identify the name and title of the person authorized by the organization to contractually obligate the organization
- Identify the legal status of the submitting organization (proprietorship, corporation, non/for-profit, etc). Include federal tax number
- Identify the name, title, telephone and FAX number of the person to be contacted for clarification
- Explicitly indicate acceptance of all requirements of the Request for Proposal
- Be signed by the person authorized to contractually obligate the organization
- Acknowledge receipt of any and all amendments to this Request for Proposal.

### TABLE OF CONTENTS

Immediately following the letter of transmittal, the applicant is required to provide a Table of Contents identifying all subsequent sections and pages.

 Describe your organization's qualifications and experience in providing treatment to juvenile sex offenders and/or juvenile offenders who have been adjudicated for a reportable offense as outlined in Article 62.001 Sec. 1.01(5) (A)-(I) and Sec 2 (A)-N) under this REQUEST FOR PROPOSAL'S PURPOSE OF SERVICE.

- 2. In addition, explain your knowledge and understanding of and experience with:
  - a. Familiarity with the Texas Family Code and procedures pertaining to juvenile probation
  - b. Working with juvenile's diagnoses with mental illness and/or mental retardation
  - c. Working with juvenile offenders who have been victimized; experienced sexual, physical, emotional abuse
  - d. Related judicial entities working with the juvenile delinquent population (i.e., public defenders, district attorney's juvenile court judges, drug court administrators and judges)
  - e. Familiarity and application of various clinical assessment instruments
  - f. Understanding and experience using cognitive behavioral therapy for group and individual services
  - g. Must adopt an evidence based cognitive behavioral curriculum specifically for juvenile offenders
  - h. Provider must be specific in outlining the modality to be used as part of this proposal and the level of training and experience of the individual(s) who will facilitate the group
- 3. In detail, explain how your organization will address, incorporate, and coordinate all components of this Request for Proposal's Program Requirements.
- 4. Identify the lead professional and their qualifications and experience in conducting this type of assessment. If applicable, identify any other professional staff and their qualifications and experience.

#### FINANCIAL INFORMATION

The services requested shall be provided for a period of one- (1) year, and may be renewed for up to two- (2) years upon mutual agreement from vendor and department evidenced in writing prior to the expiration date of the initial term. Provide information as requested in the COST section in the Request for Proposal.

#### **Proposal Evaluation**

A representative from the El Paso County Purchasing Department will open the proposals immediately after the deadline and will record them. A representative from the El Paso County Juvenile Probation Department will perform a preliminary review of the proposals to determine compliance with the mandatory requirements of this Request for Proposal. A team of individuals from the El Paso County Juvenile Probation Department will review and score all proposals.

The contents of any proposal shall be kept confidential during the evaluation process.

All proposals received by the El Paso County Purchasing Department on or before the submission deadline shall become the property of the El Paso County Juvenile Probation Department and shall not be returned to the applicant. The El Paso County

Juvenile Probation Department shall have the right to use any or all ideas contained in the proposal. Acceptance or rejection of a proposal shall not affect this right.

### THE FOLLOWING IS FOR ALL SERVICES MENTIONED ABOVE:

#### GENERAL:

The services requested shall be provided for a period of one- (1) year, and may be renewed for up to two- (2) years upon mutual agreement from vendor and department evidenced in writing prior to the expiration date of the initial term.

#### LEGAL:

Vendor shall purchase at its own expense, commercial public liability insurance in a general aggregate limit of not less than \$300,000 for each single occurrence for bodily injury or death and \$100,000 for each single occurrence for injury to or destruction of property. Policies shall be (1) with an insurance company licensed to do business in Texas and (2) shall be satisfactory to the County. All of said insurance policies shall name the County, its officers, employees and the El Paso County Juvenile Board as additional insured. El Paso County shall be given at least thirty days advanced written notice of any lapse, amendment or cancellation. A copy of the insurance certificate should be included in the bid package.

Vendor shall defend, indemnify and hold harmless El Paso County, its officers, agents and employees from all claims or causes of action of any kind for injury or damage of any kind to any person or property brought by or on behalf of any person due to or related to the negligence or intentional act or omission of Vendor, its agents, employees, or sub Vendors. Vendor shall pay any and all damages assessed against El Paso County, its officers, agents or employees, arising out of such negligence or intentional acts.

Vendor shall maintain at Vendor's own expense, Professional Malpractice Insurance with a policy limit of not less than \$1,000,000. Such policy shall be with an insurance company licensed to do business in Texas and shall be satisfactory to the County. All of said insurance policies shall name the County, its officers, employees and the El Paso County Juvenile Board as an additional insured and shall provide that the County shall be given at least thirty- (30) days advance written notice of any lapse, amendment or cancellation. A copy of the insurance certificate should be included in the bid package.

Vendor shall ensure that all of its paid and unpaid personnel who are required or allowed to provide services pursuant to this agreement will execute a Texas Law Enforcement Telecommunications System (TLETS)/National Crime Information Center (NCIC) records check, in order to allow the Juvenile Probation Department to perform the criminal records check and Sex offender background check, as well as Sex Offender Background search through the Texas Department of Public Safety.

This agreement is conditional upon, subject to and contingent upon receipt of adequate Federal and/or State funding to meet the liabilities of this agreement. Vendor shall have no cause of action against Juvenile Probation Department in the event Juvenile Probation Department is unable to perform its obligations pursuant to this agreement as a result of suspension, termination withdrawal or failure of Federal and/or State funding to Juvenile Probation Department.

Nothing contained herein shall be construed as creating the relationship of employer and employee between the Juvenile Probation Department and the Vendor. The Vendor shall be deemed at all times to be an independent Vendor.

Vendor shall not sell, assign, transfer or convey this agreement, in whole or in part, without the prior written consent of the Juvenile Probation Department.

This agreement will be governed and construed according to the laws of the State of Texas. This agreement is performable in El Paso County, Texas. Venue for any legal proceedings shall be in El Paso County, Texas.

This document expresses the entire agreement between the parties and shall not be amended or modified except by written instrument signed by the parties.

In the event that any portion of this agreement shall be found to be invalid or unenforceable, the remaining terms and conditions shall be severed and shall remain in full force and effect.

Vendor must be familiar with the Texas Family Code §261.101 *Persons Require to Report; Time to Report.* This code deals with reporting child physical or mental health abuse or neglect.

Vendor certifies that they will comply fully with the non-discrimination and equal opportunity provisions of Title VII of the Civil Rights Act of 1964, as amended; section 504 of the Rehabilitation Act of 1973, as amended; the Age Discrimination Act of 1975, as amended; the Americans with Disabilities Act of 1990, as amended; and with all applicable requirements imposed by or pursuant to regulations that implement those laws.

Vendor warrants that it is certified, approved or licensed by all Federal, State or local regulatory agencies or departments in compliance with all applicable regulatory agency or department policies, procedures and administrative rules to regulate any activity performed by the Vendor. Current proof of such certification, approval, license, registration or any other required regulatory permits shall be provided to the El Paso

County Juvenile Probation Department within thirty- (30) days of execution of this agreement.

Vendor shall disclose to El Paso County any pending or initiated criminal or governmental investigations within the last twelve- (12) months preceding the execution of this agreement, as well as during the term of this agreement along with any results and/or finding related to the vendor conducted by but not limited to the following agencies: Department of Justice, Texas Juvenile Probation Commission, Texas Department of Family and Protective Services or any other agency which may license or regulate the Vendor in the provision of these services.

Vendor shall ensure that all files and records generated or created, pursuant to this contract containing individually, identifiable health information in electronic, paper and oral form also known as protected health information (PHI) is maintained and/or disseminated in accordance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA).

The signer of the proposal must declare that all persons, companies or parties interested in the contract as principals are named therein; that the proposal is made without collusion with any other person, persons, company or parties submitting a proposal; that it is in all respects fair and in good faith without collusion or fraud; and that the singer of the proposal has authority to contractually bind the vendor.

### ACCOUNTING:

Invoice for services timely billed to but denied by other funding sources may be submitted to the County in accordance with the requirements of this contract except that such invoices shall be submitted within ninety-(90) days from the date of service along with documentation of submission to and denial by the other funding source. Service provider shall not supplement the contracted rate with Medicaid reimbursement or any other reimbursement. Invoices not timely submitted shall not be paid.

Vendors shall request prior approval through electronic notification to the supervising juvenile probation officer to include the identified service, dates of service which are needed on a monthly basis. Such requests must be requested prior to any services being rendered. Failure to do so will result in the vendor absorbing the cost for services not approved.

Vendor must maintain and make available for inspection, audit or reproduction, by an authorized representative of El Paso County or the State of Texas, Federal Government, books, documents and other evidence pertaining to the cost and expenses for this agreement, hereinafter called records.

JPD will notify the Vendor in writing of any deficiencies noted during such monitoring and may initiate the withholding, suspension, or reduction of payments as appropriate, based upon such monitoring.

As determined in the reasonable judgment of the Juvenile Probation Department, failure of Vendor to comply with any provisions of this agreement or a failure to achieve set goals and/or outcomes of failure of the Vendor to properly administer contracts and take appropriate corrective action in the event of violations by vendor may be considered a material breach of this contract and may result in withholding, suspension, or reduction in payments or in immediate termination of this agreement as well as refund of payments. #### Tex. Local Gov't Code § 176.006 (2005)

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

#### Tex. Local Gov't Code § 176.001 (2005)

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
