# Request for Qualifications Remodel a Pavilion in Ascarate Park and Design a New AGCA Building for the Ascarate Golf Course

The County of El Paso is seeking Qualifications for architectural services from an individual or firm licensed in the State of Texas to provide services as defined in the scope of work. The following outlines the proposed scope of work.

# I. Scope of Work:

The Scope of Work encompasses both preliminary and final design of plans and specifications for two distinct projects. The first is the remodeling the Pavilion at Ascarate Park. The second is a new building at the Ascarate Golf Course. It includes but is not limited to the following elements:

# Remodeling the Ascarate Park Pavilion

- This effort includes upgrading the building for year round usage.
- Replacing the cooling system with refrigerated air.
- Adding a heating system
- Remodeling existing restrooms to meet current ADA specifications.
- Adding a staging kitchen (non-preparation kitchen) with the capacity to maintain catered food for serving.
- Adding shade structures contiguous to the building to extend the building's usable space.
- Providing recommendations for closing existing archways.
- Cleaning and sealing the existing floor
- Retaining the building's rustic look and feel while upgrading it for use as a rental facility or as the headquarters for fiestas, festivals or other large events.
- Developing a master plan that considers the Pavilion as part of a larger festival area for the County's use in developing that capacity.
- Creating a parking area for the Pavilion.

# **Building a New AGCA Facility at the Golf Course**

- Verifying the need to demolish the existing structure.
- Demolition of the existing structure if the analysis indicates the cost of repairing outweighs the cost of new construction.
- Developing a rehabilitation plan if repairs are less costly than new construction.
- Designing a new facility on a smaller footprint if the recommendation is for new construction.
- Building design must mimic the architectural look and feel of the existing surrounding buildings.
- A prefabricated building is an acceptable alternative if the façade mimics surrounding buildings.

For both projects:

- The architectural professional will develop drawings that provide a biddable document for interested contractors
- The architectural professional will supervise the Request for Proposal (RFP) process for the remodeling and/or construction projects.
- The professional will assist in developing a scoring matrix to help select the best value contractor(s) for the project elements.
- The professional will supervise the work to ensure fidelity to the design work.
- The professional will verify contractor billing using Application and Certification for Payment Form (AIA Document G702).
- Professional will recommend acceptance/rejection of the completed projects.
- Professional will oversee preparation and submission of final as-built construction plans for the County's archives.

# II. Statement of Qualifications:

The County of El Paso is seeking to contract with an architectural professional or firm registered to practice in the State of Texas that has experience in the following areas:

- Plan and design work
- Project oversight
- Work with public entities
- Multiple and integrated projects of similar size

Provide within the proposal a representative list of clients served within the past two years, including local governments, as well as resumes of all professionals assigned to this project.

Please, limit Statement of Qualifications to ten (10) pages with any attachments and provide a copy of the current certificate of insurance for professional liability.

- Qualifications: Provide evidence of professional/firm registration with the State of Texas, professional liability insurance in force, and evidence the individual/firm is not barred from working on projects funded by the State of Texas.

Individuals or firms maybe invited to make presentations in person to the review committee assigned by the County of El Paso Commissioners Court at a time and place designated by the committee. No communication with persons assigned to the review committee by individuals or firms responding to this solicitation other than that requested by the committee as a whole.

## V. Project Schedule:

The County of El Paso requires that the professional selected for this project adhere to the following schedule:

- A maximum of 30 calendar days for preparation of preliminary plans and draft specifications from receipt of Notice to Proceed by the County of El Paso
- Upon return of preliminary plans and draft specifications by the County of El Paso, a maximum of 60 calendar days for completion of final plans and specifications, cost estimates and bid documents for this project.

The County Commissioners Court will select an architectural professional or firm and authorize the Purchasing Agent to negotiate a fee for the projects. The County of El Paso reserves the right to require the individual or firm providing professional services to redesign the project for re-bidding at no additional compensation to that individual or firm in order to stay with the budget for the project. The County reserved the right to declare a breach of contract should the individual or firm fail to adhere to the design

schedule as delineated above. The County sets the total amount of funds for the project, including engineering, administrative, and construction services.

### 1. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

As required by Executive Order 12549, Debarment and Suspension and implemented at 21 CFR Part 1404, for prospective participants in primary covered transactions

- A. The applicant certifies that it and its principals:

  - (2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal State, or local health, law enforcement, or other appropriate agency
- (g) Making a good faith effort to continue to maintain a drug free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

### Tex. Local Gov't Code § 176.006 (2005)

- § 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire
- (a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:
  - (1) begins contract discussions or negotiations with the local governmental entity; or
- (2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.
- (b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.
- (c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:
- (1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;
- (2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;
- (3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:
- (A) is received from, or at the direction of, a local government officer of the local governmental entity; and
  - (B) is not received from the local governmental entity;
- (4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:
  - (A) serves as an officer or director; or
  - (B) holds an ownership interest of 10 percent or more;
- (5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;
  - (6) describe each affiliation or business relationship with a person who:
    - (A) is a local government officer; and
- (B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

- (7) describe any other affiliation or business relationship that might cause a conflict of interest.
- (d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:
- (1) September 1 of each year in which an activity described by Subsection (a) is pending; and
- (2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.
- (e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.
- (f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.
- (g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

# Tex. Local Gov't Code § 176.001 (2005)

### § 176.001. Definitions

In this chapter:

- (1) "Commission" means the Texas Ethics Commission.
- (2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.
- (3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.
  - (4) "Local government officer" means:
    - (A) a member of the governing body of a local governmental entity; or
- (B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.
- (5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
