The addendum has been issued to notify vendors of the following questions submitted to the Purchasing Department.

1. In reviewing the RFP documents, I found two different LTD Certificates and would like to find out which one we should use for the RFP?

Response:

One document is the certificate of coverage and the other is the policy. The terms and conditions of the coverage is the same in both documents.

2. Regarding the on-line enrollment system, we can provide this service if we offer and the County accepts a voluntary worksite benefit (accident, critical illness, etc.) to offer to the County employees. Would this be something the County would be interested in and that we could include in our response?

Response:

The voluntary worksite benefit could be included in the response and will be considered during the evaluation process. Our intent is to solicit two lines of coverage, STD and LTD, and implement an online enrollment system

3. Can you please provide the rates of STD and LTD?

Currently the County only offers LTD and wants to add STD. The rates are attached.

4. Is the effective date 10-1-2012?

The County's Open Enrollment Period is October 2012. Our intent is to have the terms of the STD/LTD and on-line enrollment system in place by Open Enrollment. The STD/LTD coverage will need to begin no later than Jan 1, 2013.
