1. Can El Paso County please explain why the last RFP earlier this year was cancelled or not awarded?

Response: On August 27, 2012 the El Paso County Commissioners rejected the proposals for RFP 12-055 due to the limited response from vendors.

2. Will there be a bidder's Conference?

Response: There will not be a bidder's conference.

3. In regards to software licensing please can you notify me how many users per application area e.g. Accounting System, treasurer Cash Management please specify the application and how many users?

## **Response:**

Budget: 8 functional division users; between 250 to 600 departmental users Accounts Payable: 14 functional division users; between 250 to 600 departmental

users

**Internal Audit: 15 functional division users** 

Cash Management: 6 functional division users; up to 60 departmental users

Payroll: 7 functional division users; up to 3,000 county employee users

Treasury: 7 functional division users; up to 60 departmental users

Grants: 11 functional division users; up to 60 departmental users

Purchasing/Fixed Assets: 28 functional division users; between 250 to 600

departmental users

Human Resource: 23 functional division users; up to 3,000 county employee users

ITD: 11 functional division users

Administration: 8 functional division users

The numbers listed above are functional users per application. There are also 250 to 600 users who will have access to enter requisitions, verify or input budget information, review/complete personal action forms etc. In addition, there will be approximately 3,000 users who will have access to the payroll time and attendance, employee self service, open enrollment, etc.,

4. Are view only license required if so, for which application?

Response: View only licenses are not required.

5. What main arrears of focus is important to your county?

## **Response:**

- b.
