### **EL PASO COUNTY BOND UPDATE**

On Monday, August 12, 2024, County Commissioners Court voted to adopt an Order calling for a Bond Election to be held in El Paso County on November 5, 2024. In September, a series of informational meetings will take place throughout the County outlining each proposition and related projects.

The proposed GO Bond package totals \$323.8 million and consists of five propositions:

A: Parks & Recreation

B: New Office of Medical Examiner

C: County Subcourthouses (Annexes)

D: County Coliseum Renovation & Modernization

E: New Animal Shelter

The County estimates that a \$323.8 million bond would cause a projected 3-cent tax rate increase, which would cost approximately \$5.02 per month or \$60 per year to a taxpayer with a home value of \$200,956, the average home value for El Paso County in 2024.

### **Community Input Received**

Beginning in February 2024, the County held public meetings to gather input on project priorities. The Commissioners Court then tasked the Bond Advisory Committee, a citizen-led committee, to develop and recommend a project list and financing structure. ### El Paso County Tax Rate

El Paso County Commissioners proposed the No New Revenue and Voter Approved Tax Rates for FY2025:

No New Revenue Rate \$0.426323/\$100 of assessed property value Voter Approved Tax Rate \$0.478306/\$100 of assessed property value

The Court has asked county staff to work on maintaining the No New Revenue rate for FY2025 despite the increased mandates by the State of Texas and the reduction in revenue these mandates have caused.

Commissioners are set to finalize the tax rate on August 26th, 2024.

- **FEBRUARY 23rd** Commissioner Stout sends public letter to General Service Administration (GSA) to remove commercial traffic from Bridge of the Americas (BOTA) and not take the County Coliseum
- JUNE 14th GSA announces they will not take the Coliseum as part of the modernization project
- JUNE 26th GSA presents final options which includes removal of commercial traffic from BOTA
- **JULY 22nd -** Commissioner Stout submits public letter urging GSA to choose Action Alternative 4 which removes commercial traffic from BOTA
- MID-SEPTEMBER Draft Environmental Impact Statement, which will identify a preferred design, scheduled for publication in Federal Register; publication in Federal Register kicks off a 45-day public comment period
- DECEMBER 31st Final decision on design expected



## BRIDGE OF THE AMERICAS PORT MODERNIZATION PROJECT

On June 26th, the General Services Administration, responsible for managing the ports of entry into the United States, released its final two proposed plans for the modernization of the Bridge of the Americas. The Bridge of the America, aka Puente Cordova Americas, is the only toll-free international bridge in Texas. In December of last year, the General Services Administration announced the allocation of \$650M-\$700M in funds to modernize the outdated bridge.

The first proposal, known as Viable Alternative #1A, according to GSA:

 Viable Action Alternative 1A- multi-level modernization (high/low booths) primarily within existing port boundaries with minor land acquisition immediately adjacent to the port and additional land acquisition to the east (13 acres). No El Paso County land to be acquired.


This proposal includes commercial traffic through the bridge. The second alternative, Viable Action Alternative 4, removes all commercial traffic from the bridge:

 Viable Action Alternative 4- multi-level modernization within the existing port boundaries with minor land acquisition immediately adjacent to the port and elimination of commercial cargo operations. No El Paso County or TxDOT DPS land to be acquired.

Commissioner Stout remains committed to public health and removing trucks from the Bridge of the Americas. Once the Environmental Impact Statement is published in mid-September, the GSA's preferred design will be revealed to the public, opening up a 45-day comment period.

## OPERATION LONE STAR AND STATE UNFUNDED MANDATES

For the past three years, the state of Texas has arrested people on immigration related offenses under Operation Lone Star. This has led to a dramatic increase in state inmates in El Paso County jails, along with a dramatic increase in costs. These costs are known as "State Unfunded Mandates" because the county is mandated to pay for them without reimbursement from the state.

On July 22nd, El Paso County made a Declaration of Disaster to apply for state grants to help mitigate the budget disaster caused by Operation Lone Star.

Commissioner Stout said in an article by the <u>Texas Tribune</u>, "There's no crisis, there's no emergency, there's no disaster" on the border. "It's more of political rhetoric than anything else."

We have seen what works on the border when it comes to meeting and processing new arrivals, and what works for interior destination communities - coordination among various levels of government, and with civil society. This is the type of support we need for effective border management and for receiving cities and towns. This approach presents a practical solution to the reality of migration and benefits both new arrivals and American communities with values of welcome and optimism.

Commissioner Stout celebrates the binational culture of El Paso County and hopes to maintain El Paso's status as a welcoming beacon to all travelers, rather than one that intimidates and punishes people.

### <u>Operation Lone Star by the Numbers</u>

Latest data published by the Texas Tribune as of Newsletter publication date

- Since March 2021, approximately 2,000 people have been booked into El Paso County Jail because of Operation Lone Star.
- El Paso County has lost \$11.7 Million in revenue from the federal government.
- State Unfunded Mandates make up roughly 70% of El Paso County's budget.
- Since 2021, El Paso County has spent over \$10 million for processing and holding state inmates.



## EL PASO COUNTY BUDGET HEARINGS

El Paso County held public hearings on its proposed FY2025 budget, totaling \$600,205,703, on Tuesday, August 13th, 2024.

The proposed budget emphasized community-based initiatives and sustainable funding sources. The tax rate adoption for the budget is set to be finalized on August 26, 2024. It is important to note the impact of unfunded mandates from the Texas Legislature, which make up roughly 70% of the county's budget, increase costs for the County and local taxpayers.

### **Texas Chapter 59**

The property where the Corbin Sambrano Wellness Center will be built was seized by the District Attorney's office in 2014 after 10 years of litigation. El Paso County District Attorney Jaime Esparza donated the property to the County under Chapter 59 in the Texas Code of Criminal Procedure, which requires the following uses for the site:

- 1. Mental health, drug, or rehabilitation service, or
- 2. Services for victims or witnesses of criminal offenses or instances of abuse, or
- 3. The provision of training or education related to the first two.







## CORBIN SAMBRANO WELLNESS CENTER

Commissioner Stout has led work with the community for the past several years to transform the former Valley Theater, which most recently was an adult oriented business, into a place of healing and service. The building was seized by the El Paso District Attorney and given to the County in 2020. Several designs for the Corbin Sambrano Wellness Center have been proposed.

Because the property was seized by the D.A. and conveyed to the county, there are certain requirements for how the building may be used under Chapter 59 (see explainer above).

After several years and many meetings with community stakeholders, including the Corbin Sambrano and San Juan neighborhood associations, El Paso County representatives proposed three new designs for the wellness center to the neighborhood associations and other stakeholders.

The three proposals incorporate sustainably designed construction and airconditioning, plants native to the Chihuahuan Desert, and a mixed-use format that will be able to host a variety of programs and events, that is inviting to all members of the community.

Commissioner Stout is committed to transparency and including the community in the design process, and will look to open the Wellness Center by August 2026.





## AGRILIFE EXTENSION & COMMUNITY GARDEN

Commissioner Stout visited the Texas A&M AgriLife Extension- El Paso at Ascarate Park in July to learn more about the horticulture and community education programs like the El Paso Master Gardeners. The community garden is one of the great resources in our county and is open to tours, classes, and field trips and they are always looking for volunteers.


