Said contract shall be let to the lowest responsible bidder, and the **COMMISSIONER'S COURT RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS AND WAIVE TECHNICALITIES.** Only bids that conform to specifications will be considered. Faxed bids will not be accepted. Successful bidder shall not order items or services until a Purchase Order is received from the County Purchasing Office. Payment will not be made on items delivered without a Purchase Order. Contract will be awarded by lump sum or line item, whichever is in the best interest of the County.

In order to remain active on the El Paso County Vendor list, each vendor receiving this bid must respond in some form. Vendors submitting a bid must meet or exceed all specifications herein. Vendors submitting a no bid must submit their reason in writing to the El Paso County Purchasing Department.

IN COMPLIANCE WITH CHAPTER 161 OF THE TEXAS LOCAL GOVERNMENT CODE, ANY VENDOR INVOLVED IN A SINGLE PROCUREMENT EXCEEDING \$50,000 MUST COMPLETE THE ENCLOSED ETHICS TRAINING BEFORE SUBMITTING A BID OR BID WITH THE COUNTY OF EL PASO.

Purpose: The stability of democracy depends upon the continuing consent of the governed, which in turn depends upon the trust the electorate holds for its government. The Ethics Commission of the County of El Paso, Texas, in concert with elected county officials, as well as leaders of the various county departments, recognizes the need to maintain the public trust and confidence in the workings of county government and thus adopts this Code of Ethics.

What is a vendor:

Any person or their representative or employee whose goods and services are purchased under the terms of a purchase order or contractual agreement with the county; and any other persons doing business with the County.

Procurement: In advising upon, discussing, recommending, and/or granting any County purchases, bids or contracts, County public servants shall inform themselves about their financial interests, and shall make a reasonable effort to inform themselves about the financial interest of their family members.

County public servants shall excuse themselves from exercising influence, participating in, discussing, recommending, and/or granting of any County purchases, bids, or contracts if they or a family member have a substantial financial interest.

Private Communication: No member of the El Paso County Commissioners Court, County Elected Officials/Department Heads or the El Paso County Hospital District Board of Managers shall permit any vendor, its lobbyists, representative, or employee to communicate with him privately regarding any procurement of items by the County or the Hospital District from the date that the bid, RFP, or RFQ is authorized or released, whichever is first. No private communication regarding the purchase shall be permitted by a member of the Commissioners Court, a county elected official/department head, or

the hospital district board of managers until the procurement process is complete and a purchase order is granted or a contract is entered into.

Members of the Commissioners Court, county elected officials/department heads and the board of managers shall make a reasonable effort to inform themselves regarding procurements and shall have a duty to inquire of vendors, their lobbyists, representatives, or employees, the nature of the private communication being sought prior to engaging in any communication.

This prohibition against private communication with vendors, their lobbyists, representatives, or employees shall apply to commissioners court approval of hospital district purchases.

# PROJECT OVERVIEW

The County of El Paso ("County") Parks and Special Event Division ("Division") is seeking a "Partner/Bidder" to enter into a contract for catering and concessions services for the County Sportspark, Ascarate Golf Course, and County Aquatic's facilities. The County Courthouse is not included in this Bid. The Pavilion at Ascarate Regional Park is not exclusive to the Partner, but the Division will direct 100% of private rentals to Partner for catering and concessions services opportunities.

The current concessions Partner has been with the County for 16 years at the Ascarate Golf Course, County Sportspark, and County Courthouse. By design, the Division is looking to expand programming and revenue opportunities by including the Aquatics facilities and capability to support special events developed and/or hosted by the County.

Concessions revenues to the County in fiscal years 2015 and 2016 were \$99,000 and \$129,000, respectively. County officials attribute this to a change in Parks and Special Events leadership and a renewed focus on increasing and expanding recreational programming. The Division believes this trend to hold true for FY17, FY18, and FY19.

#### About Parks and Special Events

The Division oversees all recreational programming and special event bookings, management, and operations for County parks. The overall responsibility includes ten (10) parks with seven hundred and sixty-five (765) acres; a 27-hole golf course; a 10-field, 45-acre baseball and softball sports complex; three swimming pools; and a 400-acre regional park with a 50-acre surface lake, and a 20-acre Festival Area used to host 5k runs, car shows, concerts, fishing events, and various community events.

#### County Sportspark

The Sportspark, located at 1780 N. Zaragoza, El Paso, TX 79936, is a forty-five (45) acre, ten (10) field complex with batting cages, pro shop, quick service concessions, and an upstairs restaurant. Serving as a state-of-the-art tournament facility, the Sportspark also hosts local youth and adult baseball, softball, and kickball leagues throughout the year. The Sportspark is closed Christmas Day and New Year's Day. Fiscal year 2016 figures:

#### Ascarate Golf Course

Ascarate Municipal Golf Course, located within Ascarate Regional Park, is a 27-hole course. #### Aquatics Facilities

The Aquatics Program operates three (3) pools located in Fabens, Canutillo, and Ascarate Regional Park. Aquatics programming consists of open swim, team practices, private facility rentals, swim meets, and special events. The Program looks to expand into teaching swim lessons and additional recreational opportunities. Fiscal year 2016 figures:

The Parks and Special Events Division's Aquatics Facilities do not currently have concessions services and allows patrons to bring food and non-alcoholic beverage to the facilities. It is the desire of the County to continue this practice, but look at mobile solutions (food cart/golf cart) and vending machines as a way to supplement any perceived lack of service. All service options will be considered. Office space at the Aquatics Facilities is not available at this time. Alcohol will not be a service solution due to the nature of these venues. There is no minimum commission percentage or service required. If a plan is offered, it will be evaluated as part of the bid.

#### FOOD SERVICE OPERATIONAL REQUIREMENTS

- 1. The successful Partner shall provide all labor, supplies, materials, food, alcohol, and catering services to the locations in this Bid as needed by the County for the term of the contract, including extensions.
- 2. The Partner shall offer beverages (soft drinks, juice, water, etc) of their choice for the first year of the contract, and on a year-to-year basis thereafter. It is anticipated in Year 2 of this contract, the County will create an exclusive beverage pouring rights contract with a Beverage Partner. After the pouring rights contract is signed, the successful Partner shall work with the Beverage Partner to sell only their beverage products at County facilities.
- 3. The Partner will be responsible for the hiring and training of its personnel. All personnel responsible for serving alcoholic beverages are required to hold a current Texas Alcoholic Beverage Commission (TABC) certification.
- 4. The Partner shall provide uniforms and hygiene guidelines to all staff. Use of County and Division/venue-specific logo are encouraged, but subject to approval by the Associate Deputy Director of Parks and Special Events.
- 5. The Partner shall provide a trash management plan, to include dumpsters at both the Sportspark and Ascarate Regional Park/Ascarate Golf Course. The location for these dumpsters shall be mutually agreed upon by Partner and County, and all associated expenses are the sole responsibility of the Partner.
- 6. The Partner shall provide their own administrative supplies and Point of Sale (POS) cashiering system. A monthly report shall be submitted to the El Paso County Auditor's Office and the Associate Deputy Director of Parks and Special Events regarding monthly gross sales, and the percentage to be paid to the County. The Partner may also use the County's existing cashiering system if they so choose.
- 7. If the Partner is not able to provide a food product requested by the County, the County reserves the right to purchase the product from an alternative source.
- 8. In the event a special event promoter wants control of food and beverage options, the Partner shall include all applicable buy-out options.
- 9. In the event that the County seeks to bring a major, national, or international event to a listed location, and the event sponsor wants a profit sharing model for catering or food services, the Partner will work with the County to provide options to support a profit sharing model for the designated event.
- 10. The Partner shall offer a proposed catering and concessions menu, to include alcohol and tournament options, for each location. Prices for each food and beverage item to be sold should be listed. Menu template for this Bid can be found in Exhibit D.
- 11. Healthy Food Option The County of El Paso is seeking healthy food options as part of the proposed catering and concessions services proposed menu. A full list of healthy food requirements can be found in Exhibit C.

#### **REVENUE TO THE COUNTY**

It is anticipated that the Partner shall pay to the County a minimum commission percentage of revenue received from all catering and concessions services sales, special event catering, and buy-out options, in addition to the monthly rent payment for use of County facilities. However, the County is open to increase or multiple percentage options. Include all percentage options separately and submit a draft contract for each option contained in your response. All options will be reviewed during the evaluation process.

#### CONTRACT TERMS

The term of the agreement is for a period of three (3) years with two (2) annual extension options, not to exceed five (5) total years; however, the selected Partner shall offer beverages (soft drinks, juice, water, etc) of their choice for the first year of the contract, and on a year-to-year basis thereafter, as the County may enter into an exclusive beverage pouring rights contract with a beverage company to work with the successful Partner.

The County reserves the right to award a contract to one or more Partner(s) that represent the best economic and qualitative returns.

Partner(s) may elect to bid on one or both catering and concessions services locations in their bid.

The Partner will have exclusive first-right-of-refusal for all contracted special events. Should the Partner not exercise these rights, the County may permit the contracted event to manage their own concessions operations or contract with another organization. Revenues generated between the contracted special event and the County are the exclusive right of the County.

#### SITE VISIT AND CONFERENCE

A mandatory site visit will be held on **Wednesday**, **March 1**, **2017 at 9:00 a.m.** All potential Partners will meet at the Sportspark and proceeding to Ascarate Golf Course. A conference will follow immediately after the site visit and will last four (4) to six (6) hours in duration.

#### PARTNER MINIMUM REQUIREMENTS

The Partner must have been in business providing catering and concessions services for events and facilities, and selling alcoholic beverages, for the period of two (2) years.

The Partner must be licensed to do business in Texas.

The Partner must be licensed and able to serve alcoholic beverages at designated events.

The Partner's three (3) most recent years of audited/reviewed financial statements that demonstrate the Partner's ability to perform.

# **BID FORMAT**

The Partners bid shall include all of the following topics in the order listed below. Partners must clearly state in the response if the Partner cannot agree with certain provisions and must clearly identify the specific provisions to which it is not agreeable. A checklist for all required items listed in this Bid can be found in Exhibit D.

Reference to handbooks or other technical documentation may be used to augment the response to an item but may not constitute the entire response. References to handbooks and technical documentation must include the paragraph and/or page number of the reference document. It is requested that brochures and bulky publications be separated from the written response.

# A. COVER PAGE

Each bid must have the County's Signature Page Form as the cover page.

# **B. LETTER OF TRANSMITTAL**

A Letter of Transmittal must accompany each bid. The Letter of Transmittal must be on official business letterhead, signed by the person authorized to bind the company in any contract with the County, and contain:

- identify the applicant organization and contact person;
- identify the name and title of the person authorized by the organization to contractually obligate the organization;
- identify the legal status of the submitting organization (proprietorship, corporation, non/for-profit, etc.).
- identify the name, title, telephone, email and fax number of the person to be contacted for clarification;
- a statement that the cost bid is valid for 120 days; and
- acknowledge receipt of any and all amendments to this Bid.

# C. TABLE OF CONTENTS

Immediately following the letter of transmittal, the Partner is required to provide a Table of Contents that identifies all subsequent sections and pages.

#### **D. MINIMUM QUALIFICATIONS**

Describe how your organization meets the minimum qualifications as described.

#### E. FOOD PRODUCT SPECIFICATIONS

The Partner shall identify all foods and beverage menus, tournament menus, alcoholic beverages, and other items sold or distributed by the Partner, including all specifications that fully describe the portion size and packaging. Menu item cost to consumer will be included in the template for this Bid (Exhibit D).

# F. EQUIPMENT

The Partner will be required to supply, install, service, and maintain all vending, cooking, display, and other equipment used to sell or display food services, at no cost to the County. A full list of County-owned fixtures and equipment for use by Provider at Ascarate Golf Course and the Sportspark can be found in Exhibit A. A listing of additional equipment to be used/provided by Partner must be included in the proposal must be included using the template in Exhibit B.

The Partner is responsible for any servers, computers, internet services, Wi-Fi, or other electronic infrastructure to do their business. The County will provide televisions at the Sportspark and Ascarate Golf Course for use by the Partner. It is the responsibility of the Partner to provide cable packages, to include sports channels for guest enjoyment.

The County leases a beverage and food cart which is available for use by the Partner.

The County assumes no liability for damage to the equipment from fire, theft, vandalism, or other cause. The County, however, will use reasonable precautions to protect the Partner's equipment.

If any type of equipment provided by the successful Partner will not fit into existing areas, any modifications (i.e., new counters, etc.) will be made at the Partner's expense.

Renovations must be approved in writing by the County.

Appearance of all equipment provided will be aesthetically appealing, as determined by the County.

The Partner may suggest additional locations the Partner feels would benefit from an added catering and concessions services presence.

# G. EQUIPMENT MAINTENANCE REQUIREMENTS

Equipment owned by the County and to be used by Partner will be inspected and signed for in good working order. All code inspections are the responsibility of the Partner.

The Partner will include in the bid a plan for regular maintenance of all equipment owned by the County and the Partner. The Partner is responsible for reimbursing the County for loss of sales and/or additional costs incurred due to equipment breakdown, failed inspections, or inability to meet delivery requirements as referenced in this bid.

# H. TRANSITION PLAN AT BEGINNING AND END OF CONTRACT

The Partner shall describe a transition plan from the date of award, with target and event timeframes for an assumed transition plan takeover of the catering and concessions services operation. The County has a reasonable expectation that no loss in service will occur during this transition.

#### I. CUSTOMER SERVICE

The County is committed to customer service across all recreational opportunities and venues. The Partner shall describe the customer service trainings required for employment with Partner and will work with the Division on expectations metrics.

Customer feedback opportunities (surveys) are requested of the Partner at all venues with answers provided to the Associate Deputy Director of Parks and Special Events on a monthly basis.

It is requested the Partner set baselines customer service metrics in the first 120 days of operation and strive to reach 80% overall annual customer service satisfaction score.

As the Division operates venues that provide recreational experience to diverse age ranges, the Division is sensitive to ensuring the safety and enjoyable experience of all guests and requests employees of Partner pass appropriate background checks.

#### J. CATERING AND CONCESSIONS SERVICES MARKETING SUPPORT

The County recognizes the importance of timely and effective marketing to promote the catering and concessions services at County facilities. These efforts are intended to support the sale of food and beverage at facilities through various marketing outlets (print, digital, online) and the Partner's bid may include any proposed strategies for the development and implementation of marketing initiatives.

#### K. ACCOUNT REFERENCES

- 1. Provide a minimum of three (3) references in which the Partner worked with similar catering and concessions services as described in this bid. Especially list any governmental agencies and/or accounts within the City and County of El Paso. Provide name, address, telephone number, email address of the primary contact, and the number of years of service for each account.
- 2. Provide a complete listing of all current catering and concessions services accounts operated by the Partner within the City and County of El Paso.

#### L. ACCOUNTS LOST

The Partner must include a list of all City and County accounts which were canceled or not renewed during the immediate past three (3) years. Provide the name, telephone number, and email address of the primary contact for the contract. Please include the years of service of the account(s) and reason for non-renewal.

#### **M. VIABILITY**

- The Partner shall provide evidence of its financial ability to carry out the catering and concessions services operation. All evidence under this requirement shall be sufficient to allow an adequate evaluation by the committee. The Partner shall provide a copy of its last three (3) years of audited financial statements and also a brief narrative supporting its financial viability.
- 2. Provide a disclosure of any judgments, including but not limited to pending or expected litigation or other real or potential financial reversals that might affect the viability or stability of the Partner; or warrant that no such condition is known to exist.

# N. DRAFT CONTRACT

The Partner will submit a draft copy of their standard service contract with their bid; the contract will be subject to review by the County Attorney's office and Parks and Special Events office.

#### **TERMS AND CONDITIONS**

#### EQUIPMENT, FIXTURES AND EXPENDABLES

The Partner shall not remove any items owned by the County from the premises without first seeking written approval from County Officials.

The County shall not be legally responsible for loss or damage to equipment owned by the Partner or a Partner's representative and located on County premises.

The Partner shall surrender to the County upon termination of the contract all equipment and furnishings owned by the County in good repair and condition considering normal wear and usage. Repairs and replacements caused by the Partner's negligence or misuse shall be charged to the Partner for payment.

#### PRICING AFTER THE INITIAL CONTRACT YEAR

The initial three (3) year term may offer a fixed percentage to the County, or other option presented by the responder. Prior to each optional extension, revenue to the County may be negotiated.

The County recognizes that prices of goods and services of the Partner may fluctuate from year to year. However, for each year of the contract, the Partner must propose and justify any price increases at least one-hundred twenty (120) days in advance of the succeeding contract period. The County reserves the right to approve or reject all price changes. In no event, except with County approval, will prices increase by more than the increase in the consumer price index (all items) for the previous twelve month period as published by the United States Department of Labor El Paso County area.

#### **PUBLICITY**

Partner shall not publish any comments or quotes by County employees, or include the County in either news releases or a published list of customers, without the prior written approval of the County.

#### SUBMISSION OF BID

# General Provisions County of El Paso, Texas

These General Provisions are considered standard language for all County of El Paso BIDS and Request for Proposal documents. If any "specific bid requirements" differ from the General Provisions listed here, the "specific bid requirements" shall prevail.

#### 1. BID/PROPOSAL PACKAGE

a. The request for bid/proposal, general and special provisions, drawings, specifications/line item details, contract documents and the bid/proposal sheet are all considered part of the bid/proposal package. Bids/Proposals must be submitted on the forms provided by the County, including the bid/proposal sheet completed in its entirety and signed by an authorized representative by original signature. Failure to complete and sign the bid/proposal sheet/contract page (s) may disgualify the bid/proposal from being considered by Commissioners' Court. Any individual signing on behalf of the proposer expressly affirms that he or she is duly authorized to tender this bid/proposal and to sign the bid/proposal sheet/contract under the terms and conditions in this bid/proposal. Proposer further understands that the signing of the contract shall be of no effect unless subsequently awarded and the contract properly executed by Commissioners' Court. All figures must be written in ink or typed. Figures written in pencil or with erasures are not acceptable. However, mistakes may be crossed out, corrections inserted, and initialed in ink by the individual signing the bid/proposal. Changes must also be made to any electronic copies submitted. If there are discrepancies between unit prices quoted and extensions, the unit price will prevail. Each bidder/proposer is required to thoroughly review this entire bid/proposal packet to familiarize themselves with the bid/proposal procedures, the plans and specifications for the requested work as well as the terms, and conditions of the contract the successful proposer will execute with the County.

# b. Bid/Proposal must be in the Purchasing Department BEFORE the hour and date specified. Faxed or e-mailed bids/proposals will not be accepted. Late bids/proposals will not be considered under any circumstances.

**c.** Any bid/proposal sent via express mail or overnight delivery must have the BID/RFP number and title clearly marked on the outside of the envelope or package. Failure to clearly identify your bid/proposal may be cause for disqualification.

# 2. COMPETITIVENESS AND INTEGRITY

To prevent biased evaluations and to preserve the competitiveness and integrity of such acquisition efforts, proposers are to direct all communications regarding this bid/proposal to the El Paso County Purchasing Agent or assigned designee, unless otherwise specifically noted.

An authorized person from the submitting firm must sign all bids/proposals. The signature acknowledges that the proposer has read the bid/proposal documents thoroughly before submitting a bid/proposal and will fulfill the obligations in accordance to the terms, conditions, and specifications.

Please carefully review this Request for Bid/Proposal. It provides specific information necessary to aid participating firms in formulating a thorough response.

#### 3. BIDDERS'S/PROPOSER'S RESPONSIBILITY

The Bidder/Proposer must affirmatively demonstrate its responsibility. The Bidder/Proposer must also meet the following minimum requirements:

- Have been in business of providing services for a minimum of one (1) years;
- Have adequate financial resources or the ability to obtain such resources as required;
- Be able to comply with all federal, state, and local laws, rules, regulations, ordinances and orders regarding this Request for Bid/Proposal;
- Have satisfactory record of performance;
- Have a satisfactory record of integrity and ethics; and
- Be otherwise qualified and eligible to receive an award.

#### 4. **REJECTION OF BIDS/PROPOSALS**

The County, acting through its Commissioners' Court reserves the right to: (1) reject any and all bids/proposals and waive any informality in the bids/proposals received; (2) disregard the bid/proposal of any proposer determined to be not responsible. The County further reserves the right to reject any bid/proposal due to failure of performance on deliveries as determined in writing by the County Purchasing Agent.

#### 5. RESTRICTIVE OR AMBIGUOUS SPECIFICATIONS

It is the responsibility of the prospective proposer to review the entire invitation to bid/proposal packet and to notify the Purchasing Department if the specifications are formulated in a manner that would restrict competition or appear ambiguous. Any such protest or question(s) regarding the specifications or bid/proposal procedures must be received in the Purchasing Department no less than seventy-two hours prior to the time set for bid/proposal opening. Vendors are to propose as specified herein or propose an approved equal. The mention of any brand name in the specifications is not intended to be restrictive, but is intended to describe the general features and requirements (or equivalent) that the County of El Paso is seeking.

Under Local Gov't Code Section 262.005 and Health & Safety Code Section 361.426, the County is required to give preference to products made of recycled materials if they meet specs. The County is also required to encourage the use of recycled products in developing new procedures and specs. They are also required to eliminate procedures and specifications that explicitly discriminate against products made of recycled materials.

#### 6. SUBSTITUTES

It is not the County's intent to discriminate against any material of equal merit to those specified however, should the proposer desire to use any substitutions, prior written approval shall be obtained from the County Purchasing Agent sufficiently in advance in order that an addendum might be issued.

# 7. EXCEPTIONS TO BID/PROPOSAL

The proposer will list on a separate sheet of paper any exceptions to the conditions of the bid/proposal. This sheet will be labeled, "Exceptions to Bid/Proposal Conditions", and will be attached to the bid/proposal. If no exceptions are stated, it will be understood that all general and specific conditions will be complied with, without exception.

The Bidder/Proposer must specify in its bid/proposal any alternatives it wishes to propose for consideration by the County. Each alternative should be sufficiently described and labeled within the bid/proposal and should indicate its possible or actual advantage to the program being offered.

The County reserved the right to offer these alternatives to other proposers.

#### 8. PRICING

Bid/Proposals for equipment shall offer new (unused) equipment or merchandise unless otherwise specified. Quotes F.O.B. destination. If otherwise, show exact cost to deliver (merchandise only). Bid/Proposal will be either lump sum or unit prices as shown on the bid/proposal sheet. The net price will be delivered to the El Paso County, including all freight or shipping charges. In case of error in extension, unit prices shall govern. BID/RFP subject to unlimited price increases will not be accepted. The County is tax exempt and no taxes should be included in your bid/proposal.

Unless prices and all information requested are complete, bid/proposal may be disregarded and given no consideration.

In case of default by the contractor, the County may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the contractor, the difference between the price named in the contract of purchase order and the actual cost thereof to the County. Prices paid by the County shall be considered the prevailing market price at the time such purchase is made. Periods or performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the Purchasing Agent and the Commissioners' Court.

#### 9. TAX EXEMPTION

Pursuant to Section 151.309 of the Texas Tax Code, El Paso County qualifies for exemption from sales, excise and use taxes imposed under the Limited Sales, Excise, and Use Tax Act, which is codified at Chapter 151 of the Texas Tax Code. In accordance with Section 151.309, a taxable item sold, leased, or rented to, or stored, used, or consumed by the County is exempt from the taxes imposed under Chapter 151.

#### 10. MODIFICATION OF BIDS/PROPOSALS

A bidder/proposer may modify a bid/proposal by letter at any time prior to the submission deadline for receipt of bids/proposals. Modification requests must be received prior to the submission deadline. Modifications made before opening time must be initialed by bidder/proposer guaranteeing authenticity. Bids/Proposals may not be amended or altered after the official opening with the single exception that any product literature and/or supporting data required by the actual specifications, if any, will be accepted at any time prior to the Commissioners' Court consideration of same. No substitutions or cancellations for merchandise will be permitted without written approval of the County Purchasing Agent.

#### 11. SIGNATURE OF BIDS/PROPOSALS

Each bid/proposal shall give the complete mailing address of the Bidder/Proposer and be signed by an authorized representative by original signature with the authorized representative's name and legal title typed below the signature line. Each bid/proposal shall include the Bidder's/Proposer's Federal Employer Identification Number (FEIN),

failure to sign the Contract page(s) and bid/proposal response sheet will disqualify the bid/proposal from being considered by the County. The person signing on behalf of the Bidder/Proposer expressly affirms that the person is duly authorized to render the bid/proposal and to sign the bid/proposal sheets and contract under the terms and conditions of this BID/RFP and to bind the Bidder/Proposer thereto and further understands that the signing of the contract shall be of no effect until it is properly placed on the Commissioner's Court agenda, approved in open Court, authorized to be executed by the County Judge, and fully executed by both parties.

#### 12. AWARD OF BID/PROPOSALS-EVALUTATION CRITERIA AND FACTORS

#### Pursuant to the Texas Local Government Code

Bids shall be awarded to the responsible bidder that submits the lowest and best bid.

**Bid/Proposals** will be made to the responsible proposer whose bid/proposal is determined to be the best evaluated offer demonstrating the best ability to fulfill the requirements set forth in this Request for Bid/Proposal. The prices proposed will be considered firm and cannot be altered after the submission deadline. The proposed cost to the County will be considered firm, unless the County invokes its right to request a best and final offer and cannot be altered after the submission deadline.

The County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this BID/RFP and may discontinue its efforts under this BID/RFP for any reason or no reason or solely for the County's convenience at any time prior to actual execution of the contract by the County. County reserves the right to accept or reject all or any part of the bid/proposal, waive minor technicalities, or to award by item or by total bid/proposal. Price should be itemized.

# A Bidder/Proposer whose bid/proposal does not meet the mandatory requirements set forth in this BID/RFP will be considered noncompliant.

Each Bidder/Proposer, by submitting a bid/proposal, agrees that if its bid/proposal is accepted by the Commissioners' Court, such Bidder/Proposer will furnish all items and services upon the terms and conditions in this BID/RFP and contract.

Contractor shall submit to the County, for approval, within ten (10) days from notice of contract award, all Certificates of Insurance evidencing the required coverage as described under Insurance in the schedule of the Requests for Bids/Proposals.

#### 13. PUBLIC INFORMATION ACT

The parties agree that the County is a governmental body for purposes of the Public Information Act, codified as Chapter 552 of the Texas Government Code and as such is required to release information in accordance with the Public Information Act. Bidder/Proposer agrees that it has marked any information that it considers to be confidential, proprietary, and/or trade secret in its bid/proposal. County agrees to provide notice to Bidder/Proposer in accordance with the Public Information Act in the event the County receives a request for information under the Public Information Act for information that the Proposer has marked as confidential, proprietary, and/or trade secret.

#### 14. **RESULTANT CONTRACT**

The resultant contract shall become effective upon the Commissioners' Court execution of the same. The contract documents shall consist of the contract, the general and

special provisions, the drawings, bid/proposal package, any addenda issued, and any change orders issued during the work.

The criteria utilized for determining responsibility of bidder/proposer(s) includes, but is not limited to, the proposer's experience, skill, ability, business judgment, financial capacity, integrity, honesty, possession of the necessary facilities or equipment, previous performance, reputation, promptness, and any other factor deemed relevant by the County to determine whether a bidder/proposer is responsible. The term of the resultant contract will begin as stated in the contract executed by the Commissioners' Court and will terminate on the date specified in the contract unless terminated earlier as herein set forth.

#### 15. ESTIMATED QUANTITIES

Any reference to quantities shown in the Request for Bids/Proposals are an estimate only. Since the exact quantities cannot be predetermined, the County reserves the right to adjust quantities as deemed necessary to meet its requirements.

#### 16. CONTRACTOR INVESTIGATION

Before submitting a bid/proposal, each contractor shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and to verify any representations made by the County upon which the contractor will rely. If the contractor receives an award as a result of its bid/proposal submission, failure to have made such investigations and examinations will in no way relieve the contractor from its obligation to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the contractor for additional compensation.

#### 17. NO COMMITMENT BY COUNTY

This Request for Bid/Proposal does not commit the County to award any costs or pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a bid/proposal to this request, or to procure or contract for services or supplies.

#### 18. BEST AND FINAL OFFERS

In acceptance proposals, the County reserves the right to negotiate further with one or more of the contractors as to any features of their proposals and to accept modifications of the work and price when such action will be in the best interest of the County. This includes solicitations of a Best and Final Offer from one or more of the proposers. If invoked, it allows acceptable proposers the opportunity to amend, change or supplement their original proposal. Proposers may be contacted in writing requesting that they submit their best and final offer. Any such best and final offer must include discussed and negotiated changes.

#### 19. SINGLE BID/PROPOSAL RESPONSE

If only one (1) bid/proposal is received in response to the Request for Bids/Proposals, a detailed cost bid/proposal may be requested of the single contractor. A cost/price analysis and evaluation and/or audit may be performed of the cost bid/proposal in order to determine if the price is fair and reasonable.

#### 20. REJECTION/DISQUALIFICATION OF BIDS/PROPOSALS

El Paso County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this bid/proposal package and may discontinue its efforts for any reason under this bid/proposal package at any time prior to actual execution of the Contract by the County. Bidders/Proposers may be disqualified and rejection of bid/proposals may be recommended to the Commissioners' Court for any of (but not limited to) the following causes:

- A. Failure to use the bid/proposal form(s) furnished by the County, if applicable.
- B. Lack of signature by an authorized representative that can legally bind the company on the bid/proposal form.
- C. Failure to properly complete the bid/proposal.
- D. Bids/proposals that do not meet the mandatory requirements.
- E. Evidence of collusion among bidders/proposers.

#### 21. CHANGES IN SPECIFICATIONS

If it becomes necessary to revise any part of this bid/proposal, a written notice of such revision will be posted on the County Purchasing website. The County is not bound by any oral representations, clarifications, or changes made in the written specifications by the County's employees, unless such clarification or change is posted on the County Purchasing website. It shall be Bidder's/Proposer's responsibility to check the website prior to the bid/proposal opening date to verify whether any addendums have been posted.

#### 22. BID/PROPOSAL IDEAS AND CONCEPTS

The County reserves the right to adopt or use for its benefits, any concept, plan, or idea contained in any bid/proposal.

#### 23. BID/PROPOSAL DISCLOSURES

Results of bids/proposals for the purchase of goods, materials, general services and construction are considered public information at the time of the bid/proposal opening. All information contained in the bid/proposal response is available for public review.

The Proposal for Services: Only the names of those who submitted proposals will be made public information until an award is made by Commissioners' Court and contract executed by the parties. No price, staffing or other proposal information will be released. Proposers are requested to withhold all inquiries regarding their proposal or other submissions until after an award is made. No communication is to be had with any County employee, other than the Purchasing Agent, regarding whether a proposal was received. Violations of this provision may result in the rejection of a proposal.

#### 24. WITHDRAWAL OF BID/PROPOSAL

Bidders/Proposers may request withdrawal of a sealed bid/proposal prior to the scheduled bid/proposal opening time provided the request for withdrawal is submitted to the Purchasing Agent in writing. No bids/proposals may be withdrawn for a period of sixty (60) calendar days after opening of the bids/proposals.

#### 25. INDEMNIFICATION

A. The contractor shall agree to assume all risks and responsibility for, and agrees to indemnify, defend, and save harmless, the County, its elected and appointed officials and department heads, and its agents and employees from and against all claims, demands, suits, actions, recoveries, judgments, and costs and expenses including reasonable attorney's fees for the defense thereof in connection therewith on account of the loss of life property or injury or damage to the person which shall arise from contractor's operations under this contract, its use of County facilities and/or equipment or from any other breach on the part of the contractor, its employees, agents or any person(s) in or about the County's facilities with the expressed or implied consent of the County. Contractor shall pay any judgment with cost which may be obtained against El Paso County resulting from contractor's operations under this contract.

Contractor agrees to indemnify and hold the County harmless from all claims of subcontractors, laborers incurred in the performance of this contract. Contractor shall furnish satisfactory evidence that all obligations of this nature herein above designated have been paid, discharged or waived. If Contractor fails to do so, then the County reserves the right to pay unpaid bills of which County has written notice direct and withhold from Contractor's unpaid compensations a sum of money reasonably sufficient to liquidate any and all such lawful claims.

**B.** Pursuant to Texas Local Government Code Section 262.032(b), any successful bidder who is awarded any contract in excess of \$50,000 may be required to execute a performance bond to the County. Said bond shall be in the full amount of the contract and must be furnished within 30 days after the date a purchase order is issued or the contract is signed and prior to commencement of the actual work. A performance bond required pursuant to this section shall be noted in the attached detailed bid specifications or scope of work. This section does not apply to a performance bond required by Chapter 2253, Texas Government Code.

The Bidder/Proposer shall be required to notify the County of any potential for merger or acquisition of which there is knowledge at the time that a bid/proposal is submitted.

If subsequent to the award of any contact resulting from this BID/RFP the Bidder/Proposer shall merge or be acquired by another firm, the following documents must be submitted to the County.

- 1. Corporate resolutions prepared by the awarded Proposer and the new entity ratifying acceptance of the original contract, terms, conditions and prices;

Information and data provided through this BID/RFP are believed to be reasonably accurate.

#### 33. SUBCONTRACTING/ASSIGNMENT

Bidder/Proposer shall not assign, sell, or otherwise transfer its contact in whole or in part without prior written permission of Commissioners' Court. Such consent, if granted, shall not relieve the Bidder/Proposer of any of its responsibilities under this contract.

#### 34. INDEPENDENT CONTRACTOR

Bidder/Proposer expressly acknowledges that it is an independent contractor. Nothing in this agreement is intended nor shall be construed to create an agency relationship, an employer/employee relationship, a joint venture relationship, or any other relationship allowing County to exercise control or direction over the manner or method by which Bidder/Proposer or its subcontractors perform in providing the requirements stated in the Request for Bid/Proposal.

#### 35. MONITORING PERFORMANCE

The County shall have the unfettered right to monitor and audit the Vendor's work in every respect. In this regard, the Vendor shall provide its full cooperation and insure the cooperation of its employees, agents, assigns, and subcontractors. Further, the Vendor shall make available for inspection and/or copying when requested, original data, records, and accounts relating to the Bidder's/Proposer's work and performance under this contract. In the event any such material is not held by the vendor in its original form, a true copy shall be provided.

(B) a transaction conducted at a price and subject to terms available to the public; or

(C) a purchase or lease of goods or services from a person that is chartered by a state or federal agency and that is subject to regular examination by, and reporting to, that agency.

#### Local Government Code § 176.003(a)(2)(A) and (B):

(a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:

(2) the vendor:

(A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, other than investment income, that exceeds \$2,500 during the 12-month period preceding the date that the officer becomes aware that

- a contract between the local governmental entity and vendor has been executed;
   or
- (ii) the local governmental entity is considering entering into a contract with the vendor;

(B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:

- (i) a contract between the local governmental entity and vendor has been executed; or
- (ii) the local governmental entity is considering entering into a contract with the vendor.

#### Local Government Code § 176.006(a) and (a-1)

(a) A vendor shall file a completed conflict of interest questionnaire if the vendor has a business relationship with a local governmental entity and;

 has an employment or other business relationship with a local government officer of that local governmental entity, or a family member of the officer, described by Section 176.003(a)(2)(A);

(2) has given a local government officer of that local governmental entity, or a family member of the officer, one or more gifts with the aggregate value specified by Section 176.003(a)(2)(B), excluding any gift described by Section 176.003(a-1); or

(3) has a family relationship with a local government officer of that local governmental entity.

(a-1) The completed conflict of interest questionnaire must be filed with the appropriate records administrator not later than the seventh business day after the later of:

(1) the date that the vendor:

 (A) begins discussions or negotiations to enter into a contract with the local governmental entity; or

(B) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential contract with the local governmental entity; or

(2) the date the vendor becomes aware:

(A) of an employment or other business relationship with a local government officer, or a family member of the officer, described by Subsection (a);

(B) that the vendor has given one or more gifts described by Subsection (a); or

(C) of a family relationship with a local government officer.
