#### SECTION 1: No-New-Revenue Tax Rate

The no-new-revenue (NNR) tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that would produce the prior of the prthe same amount of revenue if applied to the same properties that are taxed in both years (no new taxes). When appraisal values increase, the NNR tax rates hould decrease.

#### SECTION 2: Voter-Approval Tax Rate

The voter-approval tax rate is the highest tax rate that a taxing unit may adopt without holding an election to seek voter approval of the rate. Most school districts calculate a district of the rate of the rvoter-approval tax rate that is split into three separate rates. \*!

- 1. Maximum Compressed Tax Rate (MCR): A district's maximum compressed tax rate is defined as the tax rate for the current tax year per \$100 of valuation of taxable  $property\ at\ which\ the\ district\ must\ levy\ a\ maintenance\ and\ operations\ tax\ to\ receive\ the\ full\ amount\ of\ the\ tier\ one\ all\ ot\ ment,\ 15$
- 2. Enrichment Tax Rate (DTR): 20 Adistrict's enrichment tax rate is defined as any tax effort In excess of the district's MCR and less than \$0.17. The enrichment tax rate is divided into golden pennies and copper pennies. School districts can claim up to 8 golden pennies, not subject to compression, and 9 copper pennies which are subject to compression.compression with any increases in the guaranteed yield. 23
- 3. Debt Rate: The debt rate includes the debt service necessary to pay the school district's debt payments in the coming year. This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The MCR and DTR added together make up the school district's maintenance and operations (M&O) tax rate. Districts cannot increase the district's M&O tax rate to create a surplus  $in M\&O tax revenue for the purpose of paying the district's debts ervice. {\it ''}$ 

As chool district may adopt a M&O tax rate that exceeds the MCR in order to maintain the 2020-2021 school year basic all other historic exceptain requirements and receives the matter of the property of thapproval from TEA. Refer to Education Code, Section 48.2553 for more information.

A district must complete an efficiency audit before seeking voter approval to adopt a M&O tax rate higher than the calculated M&O tax rate, hold an open meeting to discuss the calculated before seeking voter approval to adopt a M&O tax rate higher than the calculated by the calcuresults of the audit, and post the results of the audit on the district's website 30 days prior to the election. 23 Additionally, a school district located in an area declared a disaster by the governor may adopt a M&O tax rate higher than the calculated M&O tax rate during the two-year period following the date of the declaration without conducting an efficiency

The school district must provide the tax assessor with a copy of the TCEQ letter of determination that states the portion of the cost of the installation for pollution control.
