



Dear Honorable Judges and Commissioners Court Members:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2023, is submitted herewith. This report is required by the *Texas Local Government Code*, §114.025. We believe the information contained within this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2023. In addition, the following pages detail total collections by department and assessments by court.

Overall, the funds and fees collections comparative summary reflects an average increase of 0.92% compared to the previous year collections. Increases and decreases greater than \$100,000 are as follows:

The increase of 2.58% in the County Tax Assessor collections is attributable to a 3.06% increase in vehicle sales taxes (collected for the State), a 7.15% increase in vehicle

sales taxes (CRB Fund), and a 3.11% increase in ad valorem taxes resulting from housing growth and increased property values.

Other substantial increases are related to a 57.90% increase in Constables' criminal fines, a 194.80% increase in 210th District Court collections due to a increase in civil cases filed, and a 10.84% increase in civil case collections by the 383rd District Court.

The most significant collection decrease is attributed to a 27.31% decrease in the Sheriff's Department Federal Prisoner Maintenance collections.

Other significant collection decreases are associated with the County Clerk, 327th District Court, and EPC CSCD. County Clerk collections decreased 11.20% due to reduced filing fees, recording fees and other collected fees. 327th District Court collections decreased by 67.04% due to a decrease in civil case filings. EPC CSCD collections dropped 5.21% connected to a decrease in pre-trial intervention program fees.

These departments will be monitored and analyzed during the current fiscal year. If needed, assistance will be offered to review policies and procedures and make recommendations to help increase efficiency.

My sincere thanks go to the County officials and employees who contributed support and leadership in conducting the County's financial affairs responsibly and professionally.
