Dear Honorable Judges and Commissioners Court Members:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2024, is submitted herewith. This report is required by *Texas Local Government Code*, §114.025. We believe the information contained within this report represents all the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2024. In addition, the following pages detail total collections by department and assessments by court.

Overall, the funds and fees collections comparative summary reflects an average increase of 6.2% compared to the previous year collections. Conversely, a majority of the collecting departments showed decreases in collections. Increases and decreases greater than \$100,000 are as follows:

The largest of the changes is an increase of 8.2% in the County Tax Assessor collections, attributable to a 19.7% increase in ad valorem taxes resulting from housing growth and increased property values. District Clerk had an increase of 23.9% with the majority attributable to bond forfeitures, increasing by 189.1%. The Financial Recovery Division increased by 27.0%, mainly attributable to an increase in county court fines. Civil case collections increased by 78.6% in the 210th District Court, 1,188.7% in the 409th District Court, and 23.6% in the County Court at Law No. 6.

The most significant decrease is the 53.6% decrease in the Sheriff's collections, attributed to the fall in federal prisoners reimbursements. The other large decrease is seen in the El Paso County Community Supervision and Corrections (EPC CSCD) collections, dropping 4.4%, mainly attributed to a decrease in pre-trial intervention program fees.

These departments will be monitored and analyzed during the current fiscal year. If needed, assistance will be offered to review policies and procedures and make recommendations to help increase efficiency.

My sincere thanks go to the County officials and employees who contributed support and leadership in conducting the County's financial affairs responsibly and professionally.
