Dear Honorable Judges and Commissioners Court Members:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2003 is submitted herewith. This report is required by the *Texas Local Government Code*, § 114.025. We believe that the information contained within this report represents all of the financial activity on a cash basis of accounting for various county offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2003. The following pages detail total collections by department and assessments by court.

Assessments in the 409th District Court doubled over the previous year, mainly attributable to the shifting of caseloads from other district courts. The 168th District Court reflects a decrease of 63.20 %, due to the segregation of the Impact and Tax Courts portion of the assessments. The 383rd District Court indicates a 25.17% increase in assessments, which coincides with the District Clerk's increase in collections of 28.27%, due to aggressive efforts in billing the State Attorney General more timely. County and County Criminal courts experienced a shift in caseloads this year again, as reflected in the assessments.

Increased collections for Constables and Justices of the Peace are attributable to the Warrants/Collections Program approved by Commissioners Court, effective April 1, 2003.

We thank the county officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.
