

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2009 is submitted herewith. This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2009. The following pages detail total collections by department and assessments by court.

Various District and County Courts experienced a decrease in collections on assessments from the previous year which is consistent with other revenue declines most likely attributable to the local and national economic declines. Several departments also experienced a decrease in collections to include the County Attorney, County Clerk, County Clerk Collections, County Sheriff's Office, County Tax Assessor-Collector, and Justices of the Peace, Precinct Numbers 1, 2, 3, 6-1, and 7.
