

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2011 is submitted herewith. This report is required by the *Texas Local Government Code*, §114.025. We believe that the information contained within this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2011. The following pages detail total collections by department and collections on assessments by court.

Overall there is an increase in collections for the various courts and County departments in comparison to Fiscal Year 2010. However, the County, District and Probate courts suffered a minor 1% decrease from previous year's collections. The most significant increase in collections has come from the Justice of the Peace collections. This is due to the ongoing success of the Scofflaw program. Secondly, the County continues to strive in providing the public a more convenient way of paying court costs and fines. It appears that El Paso County is slowly overcoming the country's economic downturn.

My sincere thanks goes to County officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.
