

Dear Honorable Judges and Commissioners Court Members:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2012 is submitted herewith. This report is required by the *Texas Local Government Code*, §114.025. We believe that the information contained within this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2012. The following pages detail total collections by department and assessments by court.

Overall there was an average decrease of 10.4% in collections throughout the various County departments compared to previous year collections. A majority of the decrease in collections came from the Justice of the Peace and Constable departments. This was due, in the most part, to a judicial computer conversion in which warrant executions and collections were not performed. Furthermore, the Scoff law program was halted for a short time during the conversion, which further hindered the collection process. Several other departments also experienced a considerable decrease in collections, including District Clerk, Domestic Relations and County Attorney. The District Clerk experienced a 11.9 percent decrease, Domestic Relations a 19.3 percent decrease and County Attorney a 28.7 percent decrease.

My sincere thanks go to the County officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.
