

Dear Honorable Judges and Commissioners Court Members:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 2014 is submitted herewith. This report is required by the *Texas Local Government Code*, §114.025. We believe that the information contained within this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 2014. The following pages detail total collections by department and assessments by court.

Overall there was an average increase of 6.47% in collections throughout the various County departments compared to previous year collections. A majority of the increase in collections came from the Justice of the Peace and Constable departments. This was due, in the most part, to a better functionality of the new judicial computer system (Odyssey) in which warrant executions and collections are now operating at a smoother pace. However, several other departments experienced a slight decrease in collections, including the County Clerk, Domestic Relations Office and the County Sheriff department. The County Clerk experienced an overall decrease by 1.0 percent (\$9,333,985 to \$9,269,795), Domestic Relations a 2.95 percent decrease (\$950,429 to \$922,353) and the County Sheriff department a 7.77 percent decrease,(\$16,784,812 to \$15,480,614). These decreases may be attributed to the following factors:

- Implementation and conversion to the new Odyssey system
- Decrease in case filings
- Decrease in collection of outstanding court costs and fines

Further evaluation of the 7.77 percent decrease in Sheriff's collections depicts various factors mentioned previously and also is attributed to the following factors as well:

- Decrease in prisoner maintenance collections (\$14,889,917 to \$14,177,626)
- Decrease in misdemeanors collections (\$1,321 to \$0)
- Decrease in collections by other County offices (\$1,401,717 to \$822,691)
- Decrease in N.O.W. account interest income (\$11,672 to \$1,190)

This office will continue to monitored and analyze collections during the current fiscal year to evaluate and understand various factors impacting overall Sheriff's collections.

My sincere thanks go to the County officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.




Justice of the Peace, Precinct No. 2




Justice of the Peace, Precinct No. 4 Fines and Fees






