### **Increase/Decrease Explanations**

- Increase of \$33,218,016 or 8.15% in County Tax Assessor collections is a combination of an increase of vehicle sales tax, new construction, and an increase of property values.
- Increase of \$3,111,701 or 16.64% in County Sheriff collections is due to an increase of 31% of Federal Prisoners fee collected due to an increase in federal inmate population.
- Increase of \$284,436 or 8.11% in District Clerk collection, due to an increase in District clerk fees.
- Increase of \$267,633 or 26.70% in Constables-All Precincts, due to an increase of 57.25% in civil and small claims fees.
- Increase of \$114,072 or 41.93% in Justice of Peace No. 5, due to a Increase of 64.12% in civil cases: Constable fees increase \$53,831, Justice court state consolidated civil fee increase of \$26,292 and increase of civil Justice fees of \$19,823 and an increase of 19.37% in misdemeanor fees.

#### **Increase/Decrease Explanations**

- Justice of the Peace, Precinct no. 1 increase of \$102,654 or 44.08% is attributed to 65.04% increase in civil fees and a 23.38% increase in Misdemeanor fees; the collections increase is a combination of the following fees, Constables by \$60,470, State fees by \$26,297 and Justice fees by \$14,591.
- County clerk decrease by (\$502,956) or 3.68% attributed to a decrease in filings and recording fees by (\$241,931) and decrease of County clerk's fee by (\$247,341).
- County Court at Law No. 5 decrease of (\$417,846) or 19.36% in due to a decrease of 15.31% in civil cases filed.
- El Paso County Community Supervision and Corrections (EPD CSCD) decrease of (\$116,280) or 3.79% attributed to a 12.88% decrease in a restitution funds.
- Financial Recovery Division decrease by (\$101,042) or 7.37% attributed to an overall decrease in County court costs and fees, and State court cost collected by Financial recovery division.
