The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 1993 is submitted herewith. This Funds and Fees of Offices Report is required by the *Texas Local Government Code*, § 114.025. We believe that all information presented in this report is accurate and reliable in all material aspects. We also believe that all information contained in this report is presented in a manner to set forth fairly the financial position of the various County offices as measured by the financial activity of the offices.

The modified accrual basis of accounting is used for all governmental fund and fiduciary fund types. Under the modified accrual basis of accounting, revenues are recognized when they become measurable and available. In the case of the County, "measurable" means that the amount of the transaction can be determined and "available" means collectible within the current period or soon enough thereafter to pay liabilities of the current period. Revenues susceptible to accrual include property taxes, special assessments, licenses, interest income and charges of services. Sales and use taxes collected and held by the State at fiscal year end on behalf of the County also are recognized as revenue. Fines, forfeitures and permits are not susceptible to accrual because generally they are not measurable.

We thank the many people who have contributed support and leadership in conducting the financial affairs of the County in a responsible manner.



Computation of Food Cost Per Prisoner Day


The cost of food, \$1,396,772.14, divided by the total prisoner days, 573,219, is approximately \$2.44, the cost of food per prisoner day.
