Dear Honorable Judges and Members of Commissioners Court:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 1997 is submitted herewith. This report is required by the *Texas Local Government Code*, § 114.025. We believe that the information contained in this report presents all of the financial activities on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 1997. As a means of comparison, the 1997 fiscal year funds and fees exceeded the 1996 fiscal year funds and fees by 7.8 percent. The most significant increase was posted by the Criminal Law Magistrate II at 258.6 percent. This significant change is partially attributable to the specialization by the County Courts. County Court at Law Number 1 and County Court at Law Number 3 which also handle criminal cases, also posted increases of 24.2 percent and 10.8 percent respectively. The 65th, 41st and 243rd District Courts also reflect impressive increases over the prior year.

We thank the county officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.


Computation of Food Cost Per Prisoner Day


The cost of food was \$1,505,015.35 and the total prisoner days were 548,682. The cost per prisoner day was \$2.74.
