Dear Honorable Judges and Members of Commissioners Court:

The Funds and Fees of Offices Report for the County of El Paso for the fiscal year ended September 30, 1998, is submitted herewith. This report is required by the *Texas Local Government Code*, § 114.025. We believe that the information contained in this report represents all of the financial activity on a cash basis of accounting for various County offices and is reliable in all material aspects.

This report is intended to provide a thorough overview of the various funds and fees collected by the County during the fiscal year ended September 30, 1998. As a means of comparison, the 1998 fiscal year funds and fees exceeded the 1997 fiscal year funds and fees by 11.66 percent. This increase is partly attributable to the inclusion of the fees collected by the County Clerk Collections Department, which began operations in April 1998, and the inclusion of the new County Court at Law Number 6, which began operations in February 1998. The 41st and 243rd District Courts and the Criminal Law Magistrate II reflect the most impressive increases.

We thank the county officials and employees who contributed support and leadership in conducting the financial affairs of the County in a responsible and professional manner.






Computation of Food Cost Per Prisoner Day


The cost of food was \$1,238,081.40 and the total prisoner days were 646,182. The cost per prisoner day was \$1.92.
