- -Continue attending at least 3 AA (or other support group) meetings per week (maintain a sponsor) -Report to Probation Officer monthly for finalized case plan
- -Attend DWI Treatment Court review hearings monthly
- Report to CSO office/lab 2 times per week (Monday, Friday) to provide a BA/UA (unless monitored by an alcohol device)
- -Have your alcohol monitoring device uploaded on a weekly basis (if applicable)
- -Submit to unannounced Breathalyzer testing and random observed urine /saliva testing
- Do not drive a motor vehicle without express permission from the Court, you are to make arrangements by public transportation and/or supportive family members to comply with program requirements
- -Submit to 11:00pm-6:00am curfew (unless working/attending school/an AA meeting or other support group)
- -Zero out community service hours
- -Continue to present a stable, habitable, and drugfree residence
- -Must have obtained a GED certificate (for those without proof of a high school diploma)

DWI INTERVENTION AND TREATMENT PROGRAM **ALUMNI TIER**

RESILIENT INVESTED SUCCEEDING EMPOWERED PROGRAM (R.I.S.E.)

Once participants have completed the DWI Intervention and Treatment Program, and yet their sentence has not been finalized, the participant will be required to participate in the DWI Intervention and Treatment Alumni Tier as part of their continuum of care.

This Tier consists of the Resilient Invested Succeeding Empowered Program (R.I.S.E.) and will continue to utilize the best practices, monitor their progress and hold them accountable to the Court. The same Judge will preside and conduct hearings, their compliance will be monitored, consequences will be certain and swift, and positive reinforcement will carry on.

The participants will report to the designated community supervision officer, who will continue to monitor all the terms and conditions and monitor the alcohol monitoring unit. There will be a multidisciplinary team who will be participating in this program.

This tier is expected to last up to three years after graduation date. However, this may be modified on case-by-case basis and as per recommendations of the Judge and treatment team.

(R.I.S.E.) PROGRAM REQUÍREMENTS

Duration: Up to 3 Years

- -Report to Judge monthly in person or video
- -Attend a minimum of 1 weekly peer support group or AA/NA meeting
- -Attend biweekly family sessions (support services)
- -Comply with random home visits
- -Comply with Probation Office visits as directed by Probation Officer
- -Comply with random and/or scheduled
- UA's/BA's as directed by Probation Officer
- -Comply with all Supervision Requirements
- -Must continue with alcohol monitoring device
- -Maintain sober lifestyle and network
- -In the event of a relapse, you will be provided with a treatment counseling assessment

DWI TREATMENT COURT **PROGRAM FACTS**

The DWI Intervention and Treatment Program ("the Program") is the first dedicated specialized court in the region to address adults convicted of a DWI offense(s). The Program instills offender accountability by requiring judicial monitoring, mandatory treatment, and intensive supervision. The Program can be completed in 18 months

and is divided into 5 distinct phases.

PHASE I REQUIREMENTS

Duration: 3 months

- -Register and attend the Victim Impact Panel (general class)-MADD
- Schedule a medical appointment (Physical exam)
- Attend recovery support groups as instructed by your treatment provider
- -Commence treatment counseling (sessions will be based on clinical outcome assessment) and obtain a mental health and medical assessmentminimum 3 groups per week and 1 individual session per week
- -Have your alcohol monitoring device uploaded on a weekly basis (if applicable)
- -Report to Community Supervision (Probation) Officer once a week
- -Attend weekly DWI Treatment Court review hearings in person or video (unless otherwise directed)
- Report to CSO office/lab 2-3 times per week to provide a BA/UA (random calling)
- -Have your alcohol monitoring device
- -Submit to unannounced Breathalyzer testing and random observed urine /saliva testing
- -Do not drive a motor vehicle without express permission from the Court, you are to make arrangements by public transportation and/or supportive family members to comply with program requirements
- -Submit to 8:00pm-6:00am curfew (unless working/attending school/an AA meeting or other support group)
- -Be present when home visits are conducted by Surveillance Officers/Probation Officers during curfew hours; they shall be allowed to enter premises and have the right to conduct a search of the premises and allow Officers to photograph living conditions
- -Do not spend weekends or overnights away from home unless otherwise permitted by the Court
- -Address and comply with statutory-mandated jail confinement (if applicable)

- -Attend DWI Treatment Court review hearings biweekly in person or video

- -Complete 1/4 of community service hours

PHASE III REQUIREMENTS

- --Be reassessed for treatment before Phase IV advancement

- -Attend DWI Treatment Court review hearings every three weeks in person or video
- -Complete 1/4 of assessed community service hours
- -Have your alcohol monitoring device uploaded on a weekly basis (if applicable)
- -Submit to unannounced Breathalyzer testing and random observed urine /saliva testing
- Do not drive a motor vehicle without express permission from the Court, you are to make arrangements by public transportation and/or supportive family members to comply with program requirements

- -Report to CSO office/lab 3 times per week (Monday, Wednesday and Friday) to provide a BA/UA (unless monitored by an alcohol device)
