I HAVE, AND STILL DO CONDUCT PERSONAL INVESTIGATIONS OF NEGLIGENCE/CRUELTY CASES IN THE LOWER VALLEY AND POLITELY ADVISE THE PEOPLE OF VIOLATIONS OF PENAL CODE SECTIONS 42.09 AND 42.092. I DO CARRY COPIES OF THESE LAWS WHICH I HAND OUT TOGETHER WITH APPLICABLE PENALTIES.
