Background Information

The County of El Paso has served in the lead agency capacity since the TxDOT mandated Regional Service Planning process began in 2006. Approval of this item will authorize the El Paso County Rural Transit Program to submit all required documents to TxDOT for continuation funding through March 31, 2011. This action will allow the development, implementation, and on-going modification of the current regional coordination workplan in the Far West Texas / El Paso region that includes El Paso, Brewster, Culberson, Hudspeth, Jeff Davis and Presidio Counties. AMENDMENT #3

THIS AMENDMENT to a project grant agreement is made by and between the State of Texas acting through the Texas Department of Transportation (the "State") and County of El Paso (the "Subrecipient"), and becomes effective when fully executed by both parties.

BACKGROUND

The State and the Subrecipient executed a Regionally Coordinated Transportation Planning Project Grant Agreement for State Project # 1009(51) on October 2, 2009, and subsequently amended on December 31, 2009 and May 10, 2010, concerning the establishing and maintaining a public and mass transportation project.

AGREEMENT

The State and the Subrecipient agree that the Agreement is further amended as follows:

I. Article 1, Grant Time Period, is amended to extend the termination date of this agreement from August 31, 2010 to March 31, 2011.

All other provisions of the above numbered Project Grant Agreement not hereby amended remain in full force and effect.
