Action Item

Approve and authorize payment of expenditures submitted to the Child Welfare Board for its August 23, 2010 meeting. The expenditures fall within established Board policies and funds are available.

Fiscal Impact

The expenditures are \$14,771. Funds are available to cover these expenditures.

Background Information

On August 23, 2010, Commissioners Court rescinded its approval authorizing a new Title IV-E services contract with the Texas Department of Family and Protective Services (DFPS). Staff is working to wind down existing activities in preparation for a new process to manage this function. The Court allocated \$100,000 to meet children's needs in the new fiscal year with specific priorities to meet existing children's needs.

The Child Welfare Board meets monthly. Its next regular meeting is August 24, 2010. In the event of a failure to establish quorum, this item provides the Court the opportunity to authorize these expenditure. This authorization ensures that existing requests are met.
