## **Fiscal Impact**

## **Background Information**

The El Paso County Self Help Center Program is subject to CDBG and HUD regulations. As such, all funds dispersed under this program are subject to compliance with the National Environmental Policy Act 1969. The program's target area was given a broad environmental clearance on September 28, 2010. However, each individual program residence requires a site specific environmental clearance ensuring the construction activity proposed will not pose a threat to the environment.

The property on 740 Agua del Rio is an applicant for a residential water connection paid for by program funds. Staff has assessed the property and has determined that construction and installation of this water line poses no threat to the natural environment.

The attached form requires signature from the County Judge and submittal to the Texas Department of Housing and Community Affairs.
