### **SUBJECT:**

Request to submit the 2013 Indigent Defense Discretionary Grant Program to request funding for Tablet PC Upgrade.

### **BACKGROUND/DISCUSSION OF TOPIC:** To include statutory requirement, operational impact, or performance goal.

The El Paso County Public Defender's Office is submitting the 2013 Indigent Defense Discretionary Grant Program to the Texas Indigent Defense Commission to purchase 40 WI-FI enabled tablet computers, either I Pads, Android based, or similar systems, at an approximate cost of \$600.00 each. We considered tablet computers with cellular data access, and chose to go with WI-FI due to the unpredictability of monthly data access costs and in light of on-going budgetary pressures.
