SUBJECT: Rio Grande Council of Governments Grant Funding for Solid Waste Reduction and Illegal Dumping Cleanup Events.

BACKGROUND/DISCUSSION OF TOPIC: As detailed in the attached backup material, the RGCOG, through a grant from the TCEQ, has made funding available to 21 different entities, including El Paso County, in order to provide solid waste reduction cleanup events. The dollar amount currently available has increased from \$3,684.21 to \$3,802.00. To date, none of the grant funding available to El Paso County has been utilized. "Keep Vinton Beautiful" has approached Commissioner Haggerty's office and has volunteered to sponsor a cleanup event on behalf of El Paso County, solely for the Westway Community.

FISCAL IMPACT:

No fiscal impact if reimburse guidelines are followed along with providing invoices and proof of prior payment. Grant funding will be utilized to reimburse entities for costs associated with a cleanup event such as roll-off container fees, landfill fees, protective gear and cleanup supplies.

If the monies allotted to El Paso County are not utilized by December 31, 2012 any remaining amount will be redistributed to other entities that have chosen to participate.

Subject: Grant Funding Announcement for Illegal Dumping Cleanups

Greetings,

The Rio Grande Council of Governments, through a grant from the Texas Commission on Environmental Quality will make funding available to reimburse cities, counties, and special districts in conducting cleanup events including scrap tire disposal events. Under this grant, funding can be used to reimburse disposal costs to include, but not limited to, roll-off container fees, landfill fees, protective gear and cleanup supplies, tire collection, transportation and disposal.

The RGCOG under the direction of the Solid Waste Advisory Committee has prepared a proposal to attempt to address the illegal dumping concern in the region. Under this proposal the RGCOG will make \$77,368.50 available to eligible entities that conduct cleanup/disposal events including scrap tire disposal events. Reimbursements will be made available to 6 counties (Brewster, Culberson, El Paso, Hudspeth, Jeff Davis, and Presidio), 12 cities (Alpine, Anthony, Clint, Dell City, El Paso, Horizon City, Marfa, Presidio, Socorro, Valentine, Van Horn and Vinton) and 3 special districts (El Paso Water Improvement District #1, Lower Valley Water District, and Horizon Municipal Utility District). The monies are allotted equally between the 21 entities which makes \$3,684.21 available to each entity. The deadline for this grant is December 31, 2012.

Illegal dumping is a growing problem that presents a host of environmental concerns. This project will help alleviate some of the financial burden of sponsoring cleanup/disposal events. By providing grant funding in the form of reimbursements, participating entities can establish contacts for tire disposal options and gather baseline statistics on the illegal dumping problem in their respective community.

FY 2012/2013 Regional Solid Waste Grant COG-Managed Project

Describe the Purpose and Benefits of the Project. Identify the goals, objectives, and recommendations from the regional solid waste management plan, for which the project is intended to implement.

The Rio Grande Council of Governments under the direction of the Solid Waste Advisory Committee has prepared a proposal to address the illegal dumping and scrap tire concern in the region. Under this proposal the RGCOG will make \$6,823.50 from FY12 funds plus an additional \$70,545 available from the FY10/11 carryover funding for a total of \$77,368.50 to entities that conduct cleanup events. Reimbursements will be made available to 6 counties (Brewster, Culberson, El Paso, Hudspeth, Jeff Davis, and Presidio), 12 cities (Alpine, Anthony, Clint, Dell City, El Paso, Horizon City, Marfa, Presidio, Socorro, Valentine, Van Horn and Vinton) and 3 special districts (El Paso Water Improvement District #1, Lower Valley Water District, and Horizon Municipal Utility District). The monies are allotted equally between the 21 entities which makes \$3,684.21 available to each entity.

This project will help alleviate some of the financial burden of sponsoring cleanup/disposal events to include scrap tires. By supplying grant funding in the form of reimbursements, participating entities can conduct litter and illegal dumping cleanup events and most importantly establish contacts for disposal options and gather baseline statistics on the illegal dumping problem in their respective community. The Regional Plan calls for the RGCOG to support regional and local efforts to identify areas with litter and illegal dumping problems and implement programs to address those problems (Goal 1, Objective). The Regional Plan also states the RGCOG will encourage local governments to clean up illegal dumpsites and provide residents with legal, affordable, and convenient disposal opportunities (Goal 2, Implementation Strategies). Finally, the RGCOG encourages tire amnesty days in cooperation with local governments and tire dealers to discourage illegal dumping of tires. The project will enable municipalities to begin establishing tire collection and disposal contracts, and eventually develop options for regional recycling and reuse of scrap tires (Goal 3, Implementation Strategies).

The project will allow funds to be used for disposal costs to include, but not limited to roll-off containers, landfill fees, protective gear and cleanup supplies.

The grant term will run from December 1, 2011 through December 31, 2012. After that, the RGCOG will evaluate all encumbered expenses and identify non-participating entities and redistribute allotment to participating entities by Feb. 28, 2013.
