COMMISSIONERS COURT ORDER

BANNING THE SALE/USE OF AERIAL FIREWORKS

WHEREAS, the El Paso County Commissioners Court finds that the Texas

Forest Service has determined that drought conditions exist in El Paso County, Texas,

for the 2012 Fourth of July fireworks season pursuant to Texas Local Government

Section 352.051(a)(2).

IT IS THEREFORE ORDERED that the sale and/or use of aerial fireworks, to wit:

skyrockets with sticks and missiles with fins, are hereby prohibited in all of the

unincorporated areas of the County of El Paso pursuant to Texas Local Government

Code Section 352.051(c). Further, any person selling any type of fireworks must, at

every location at which the person sells fireworks, provide reasonable notice of this

Order.

A violation of this Order is a Class C Misdemeanor punishable by a fine of up to

\$500 pursuant to Texas Local Government Code 352.051(i).

NOTICE

In accordance with Texas Local Government Code § 352.051 and by Order of the Commissioners Court of El Paso County adopted May 21, 2012:

The sale and/or use of all forms of skyrockets with sticks/rods and all forms of missiles with fins is prohibited*

All persons selling <u>any type</u> of fireworks must at every location at which the person sells fireworks, provide reasonable notice of this Order*

A violation of this order is a Class C criminal misdemeanor and is punishable by a fine of up to \$500.



* This order applies in all of El Paso County outside municipal limits. Some city's ordinances prohibit all fireworks within city limits.
