EPISD has requested the use of additional space at the JPD's "Crossroads Building" for the operation of the Delta Academy. Previously the EPISD leased 3,627 square feet. They are requesting to lease the entire building for a of 7,735 square feet.

**AMENDMENT NO. 1 TO MASTER INTERLOCAL AGREEMENT FOR THE
ESTABLISHMENT AND OPERATION OF EDUCATIONAL AND
INFORMATION SHARING PROGRAM**

On the 13th day of January, 2004, El Paso County, Texas (the "COUNTY"), on behalf of the El Paso County Juvenile Board (the "BOARD"), and the El Paso Independent School District (the "DISTRICT") entered into an agreement (KK-03-437) for (a) the provision of educational and administrative services by the DISTRICT to juveniles either court ordered detained or court ordered to the Boot Camp Program, as well as those juveniles on probation and court ordered to attend educational services at the El Paso County Juvenile Probation Department, (b) the joint convenience of information sharing between the Juvenile Probation Department and the El Paso Independent School District pursuant to Texas Family Code § 58.0051 and Texas Education Code § 37.084 respectively in order to facilitate liaison functions between the two agencies; and (c) to allow the District to remodel the Premises. The Parties now desire to amend the Agreement for good and valuable consideration specified herein. * All sections of the Agreement not specifically amended herein shall remain in full force and effect.

WHEREAS, Section 10.08 of the Master Interlocal Agreement provides that the Agreement may be amended or modified by a written document approved and executed by the parties to the Agreement; and

NOW THEREFORE it is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed Agreement.

I. ARTICLE I SECTION 1.01 OF THE AGREEMENT IS AMENDED TO READ AS FOLLOWS:

Section 1.01 In consideration of the mutual covenants and agreements of this Agreement, and other good and valuable consideration, the County leases to the District approximately seven thousand seven hundred thirty- five (7,735) square feet of space as shown on Exhibit A attached to this Agreement and made a part of this Agreement (the "Premises") located within the El Paso County Juvenile Probation Department's Crossroads Building (the "Building") located at 6400 Delta Drive, El Paso, Texas 79905.


