This Agreement, between El Paso County, Texas, ("Licensor"), and Licensee, is for the right to use the above-specified Premises and equipment but bestows no right in any other part of El Paso County property.

License to use these premises for selling food/non-alcohol beverages out of a mobile food vending vehicle is made subject to the following terms and conditions hereby agreed to by the Licensee:

1. A <u>non-refundable</u> payment of a Sponsorship fee for Movies by the Lake must be made in full by April 22, 2013. A cashier's check or money order must be submitted and made out to the County of El Paso, Texas for One-Hundred Fifty and No/100 Dollars (\$150.00). This fee covers both events.

- **2.** <u>CANCELLATIONS</u>. Cancellations must be made 48 hours prior to the event.
- 3. <u>CURFEW</u>. Licensee agrees to abide by the following curfew: Saturdays: 10 AM to Midnight
- **4.** <u>SECURITY</u>. Licensor shall provide necessary staffing and security personnel.
- **TRASH/CLEANUP**. All trash and rubbish in the immediate area of the Licensee will be cleaned by the Licensee and left in plastic trash bags.
- **6.** <u>FOOD and ALCOHOLIC BEVERAGES</u>. Licensee agrees that there will be NO alcohol or glass containers on the Premises during the event/use unless specifically authorized by the El Paso County Commissioner's Court.
- 7. <u>EXISTING EQUIPMENT</u>. Licensee may utilize all tables and chairs located within facilities. However, these cannot be moved outside.
- 8. <u>DAMAGE.</u> LICENSEE IS RESPONSIBLE FOR ALL DAMAGES TO THE PREMISES CAUSED BY INTENTIONAL OR NEGLIGENT ACTS OF THE LICENSEE, ITS AGENTS, EMPLOYEES, REPRESENTATIVES, SERVANTS OR GUESTS.
- 9. RELEASE AND INDEMNIFICATION. LICENSEE RELEASES LICENSOR FROM, AND AGREES TO INDEMNIFY AND HOLD LICENSOR HARMLESS AGAINST, ANY CLAIMS, DEMANDS, DAMAGES, COSTS, AND EXPENSES INCLUDING REASONABLE ATTORNEY'S FEES FOR DEFENDING THE CLAIMS AND DEMANDS, FOR INJURY OR DAMAGE TO THE PERSON OR PROPERTY OF LICENSEE OR ANY OTHER PARTY ARISING OUT OF ANY USE OR OCCUPANCY OF THE LICENSED PREMISES (OR ANY PART OF THEM), OR CAUSED BY ANY DEFECT IN ANY BUILDING, STRUCTURE, IMPROVEMENT, EQUIPMENT, OR FACILITY ON THE PREMISES, OR ARISING FROM ANY ACCIDENT, FIRE, OR OTHER CASUALTY ON THE PREMISES, OR BROUGHT ABOUT BY PARTIES' FAILURE TO MAINTAIN THE PREMISES IN SAFE CONDITION, INCLUDING CLAIMS OR DEMANDS BASED ON THE NEGLIGENCE OF THE LICENSOR, OR OF ANY OF ITS AGENTS, EMPLOYEES, LICENSEES, OR INVITEES, AS WELL AS CLAIMS BASED ON THE CONDUCT OR ACT OF THE LICENSEE, THE LICENSEE'S AGENTS, CONTRACTORS, EMPLOYEES, SUBTENANTS. CONCESSIONAIRES, INVITEES, OR LICENSEES. IF ANY ACTION OR PROCEEDING IS BROUGHT AGAINST LICENSOR BY REASON OF ANY SUCH CLAIM, LICENSEE, ON NOTICE FROM LICENSOR, WILL DEFEND THE ACTION OR PROCEEDING AT LICENSEE'S COST AND BY COUNSEL ACCEPTABLE TO LICENSOR.
- **10.** <u>MERCHANDISE SALES.</u> No vendors or solicitors allowed.
- 11. <u>CONCESSION.</u> Upon presentation by the Licensee to the El Paso County Parks and Recreation Director of the Licensee's current food vendor license issue by the City of El Paso, Texas, Licensee is permitted to: (a) serve/sell of any food or non-alcoholic drinks; (b) give away samples of food or non-alcoholic drink to Ascarate Park with the

- consent of the El Paso County Parks and Recreation Director, which is hereby expressly provided by execution of this Agreement.
- **12.** PARKING. Licensor has the exclusive right to control all parking areas located on its property, and parking is on a first-come, first-served basis. Parking spaces are limited.
- 13. <u>EJECTION OF PERSONS</u>. Licensor reserves the right to eject or cause to be ejected from the Premises any objectionable person or persons, and neither Licensor nor its agents shall be liable for damages that may be sustained through the exercise of such right.
- All equipment belonging to the Licensee must be removed the day/night of the event. Any equipment left after the event/use period will be stored, and the Licensee will be charged for storage. Licensor assumes no liability or responsibility for Licensee's property that may be left unsupervised, overnight, and/or abandoned on the Premises. Licensor shall have the sole right to collect and have the custody of articles left on the Premises by persons attending any program, performance, exhibition or entertainment given or held, and neither Licensee nor any other person in Licensee's employ shall collect or interfere with the collection or custody of such articles by Licensor.
- LIABILTY INSURANCE: As additional consideration, Licensee shall obtain and keep in force and effect during the term of this Agreement, at Licensee's expense, General Liability Insurance and the policy shall include coverage for bodily injury and property damage liability combined, as well as coverage for liabilities arising out of premises, operations, independent contractors, products, completed operations, personal & advertising injury, damage to rented premises, and medical payments with limits of Liability as set forth below. All policies of insurance shall be written by an insurance company or companies authorized to do business within the State of Texas, and acceptable to the Licensor. On all insurance, Licensee is to be named as the insured, and Licensor is to be named as an additional insured. The insurance policy shall also provide for thirty (30) days written notice to Licensor prior to any material change or cancellation. Licensee shall furnish a copy of all insurance policies to the Parks and Recreation Director prior to use of the Facility by Licensee. This provision is applicable if Licensee's use is as an event sponsor or promoter.
