Commissioner Perez,

I was contacted by a Mr. Ismael Castro in reference to a road closure in your district. Mr. Castro wishes to close the 13000 block of Emerald Pond (cul-de-sac). The roadway to be closed has a total of 7 residences located in that area and is within El Paso County, TX. Date of closure will be Saturday, June 29, 2013 from 5:00 p.m. to 2:00 a.m. the morning of June 30, 2013.

Reason for the requested road closure is for a block party celebration. Mr. Castro has informed me that he has made arrangements with Apache Barricade & Sign for stationary barricades and that the celebration would not leave the designated area of the Emerald Pond cul-de-sac.

Because the celebration will be a stationary event and will not be traveling through the neighborhood streets, the need for law enforcement presence is not necessary. The Sheriff's Office is in favor of approving Mr. Castro's request for the road closure.
